### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of US GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with US GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter**

##### *Supplemental Schedules Required by ERISA*

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. **Note 1. Description of Plan**

The following description of the Plastic Omnium Lighting Systems 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering all employees of OPmobility, formerly Plastic Omnium Lighting Systems, Inc. (the Company), except non-resident aliens and members of an excluded class, such as union and leased employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and the Internal Revenue Code (IRC).

The Plan was formerly the OSRAM Continental USA 401(k) Plan covering employees of OSRAM Continental USA, Inc. Effective January 1, 2022, the name of the Plan was changed to AMS OSRAM Automotive Lighting Systems USA, Inc. 401(k) Plan following the dissolution of OSRAM Continental USA, Inc. and the establishment in October 2021 of AMS OSRAM Automotive Lighting Systems USA, Inc. In July 2022, AMS OSRAM sold Automotive Lighting Systems to the Company. The Plan was amended effective November 1, 2022, to reflect the change in ownership to Plastic Omnium Lighting Systems, Inc. In March 2024, the Company was renamed to OPmobility under rebranding efforts.

**Eligibility**

Employees are eligible to participate in deferral and match contributions upon hire. The Plan has no age or service requirements.

**Contributions**

Participant can elect to defer up to 75% of their annual compensation, as defined in the Plan document. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. The Plan includes an auto-enrollment provision whereby all eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated fund unless changed by the participant. Automatic deferrals increase by 1% annually up to 10% of eligible compensations unless the participant has made an election.

The Company contributes a safe harbor match equal to 100% of the first 6% of the participant's contribution. The Company also may make an additional discretionary contribution. Employer contributions are allocated to the participant-directed investment options pro-rata to participant contributions. No additional discretionary Company contributions were made in 2024.

Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

The Plan was amended effective January 1, 2025, to remove the automatic deferral increase provision of the Plan.

**Note 1. Description of Plan**

**Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Company's contribution and Plan earnings and charged with an allocation of administrative expenses and Plan losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Company contributions not allocated to participant accounts at December 31, 2024 and 2023 were \$72 and \$1,670, respectively. Unallocated cash of \$1,030 was used during 2024 to reduce employer contributions.

**Vesting**

Participants are immediately fully vested in all contributions into the Plan.

**Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The Plan allows for a maximum of 2 loans to be outstanding at a time. Loan interest rates are set at 2% above the prime lending rate, as defined. Principal and interest is paid ratably through payroll deduction.

**Payment of Benefits**

Upon termination of services a participant may elect to receive 100% of the interest in their account in the form of a lump-sum or as partial payments. Distributions are also permitted when a participant reaches the normal retirement age of 65.

In-service distributions may be made in the event of hardship, as defined by the Plan document. In-service distributions may also be made from the Plan upon attaining 59 ½ years of age.

**Forfeited Accounts**

Forfeited participant account balances may be used to pay administrative expenses or offset future Company contributions. No forfeitures were used by the Plan in 2024. Forfeited, non-vested balances were \$0 at December 31, 2024 and 2023.

**Note 2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are prepared in conformity with accounting principles generally accepted in the United States of America (US GAAP).

**Use of Estimates**

The preparation of financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect the reported amount of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Note 2. Summary of Significant Accounting Policies**

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**Payment of Benefits**

Benefits are recorded when paid.

**Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of participant notes receivable are charged directly to the participant's account. Investment-related expenses are included in net change in fair value of investments.

**Note 3. Certification**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the following information included in the accompanying financial statements, notes, and ERISA-required supplemental schedules was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Life Insurance Company U.S.A., the custodian of the Plan:

- Investments at fair value
- Cash, noninterest-bearing
- Notes receivable from participants
- Net change in fair value of investments
- Interest income on notes receivable from participants

**Note 4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and that the Plan has the ability to access.

**Note 4. Fair Value Measurements**

Level 2 inputs are based on observable inputs corroborated by market data but not quoted on active markets.

Level 3 inputs are based on unobservable inputs and include situations where there is little, if any, market activity for the assets or liabilities and have the lowest priority.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

*Pooled Separate Accounts:* Funds that include units of an insurance company's pooled accounts valued at the net asset value (NAV) of units of the accounts. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Pursuant to Accounting Standards Update 2015-07, *Fair Value Measurement*, the pooled separate accounts measured at NAV have not been classified in the fair value hierarchy.

Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the accounts, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in methodologies used at December 31, 2024 and 2023.

The Plan holds various pooled separate accounts that are not direct filing entities. A majority of these pooled separate accounts seek to mirror the investment objectives and strategies of the underlying mutual fund for which the pooled account is named. Certain other pooled separate accounts are target date funds which seek capital appreciation and current income consistent with asset allocations that become more conservative over time to the specified target retirement date. The pooled stable value fund seeks to preserve principal and accumulate interest.

**Note 5. Related Party and Party-in-Interest Transactions**

Certain Plan investments are maintained by John Hancock Life Insurance Company U.S.A., the custodian of the Plan. The Plan pays administrator fees to the custodian. These transactions qualify as party-in-interest transactions and are exempt from the prohibited transaction rules of ERISA.

**Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to terminate the Plan under the provisions of ERISA.

**Note 7. Tax Status**

The Plan adopted a non-standardized defined contribution pre-approved plan document sponsored by Employee Benefit Services, Inc. The non-standardized sponsor has received an opinion letter from the IRS as to the non-standardized plan's qualified status. The non-standardized plan opinion letter has been relied upon by this Plan. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, no uncertain positions have been taken or are expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan is no longer subject to IRS examinations for the years prior to 2021.

**Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the Statements of Net Assets Available for Benefits.

**Note 9. Non-exempt Transactions**

During the years ended December 31, 2022 and 2021, participant contributions totaling \$84,119 and \$859,951, respectively, were not remitted to the Plan within the appropriate time period by the Company. These transactions constitute prohibited transactions as defined by ERISA. The Company corrected by depositing lost earnings to the Plan in February 2024. Procedures have been implemented to ensure that all future remittances are made within the prescribed time period.

**Note 10. Other Employer Contributions Receivable**

Other employer contributions receivable are for corrections by the Company for failure to increase deferrals under the automatic deferral increase provisions of the Plan. The Company corrected the missing deferrals along with lost earnings in October 2024.

**Note 11. Subsequent Events**

Management has evaluated subsequent events through August 13, 2025, the date on which the financial statements were available for issuance.
