**1. DESCRIPTION OF PLAN**

The following brief description of the Lenox Corporation 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**General** — The Plan is a defined contribution plan covering substantially all employees of Lenox Corporation (the “Company”). Employees are eligible to enter the Plan after reaching age 20 and 30 days of employment. The Benefits Committee of the Company controls and manages the operation and administration of the Plan. Vanguard Fiduciary Trust Company (“Vanguard” or the Trustee) serves as the Trustee and recordkeeper of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

**Plan Merger-** In connection with the Company’s merger with Cambridge Silversmith LLC, the assets of the Cambridge Silversmith Profit Sharing Plan transferred into this Plan in September 2022.

**Contributions** — Participants may elect to defer up to 90% of their pre-tax annual compensation, as defined in the Plan, subject to certain Internal Revenue Code (“IRC”) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan allows rollover contributions from other qualified plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan after 60 days, unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation and their contributions invested in a designated asset allocation fund until changed by the participant. The force out limit of terminated employees is \$5,000 vested balance with a minimal administrative fee.

The Plan has a discretionary Company match provision that allows the Company to determine annually what, if any, match the Company will contribute to the Plan. Employees are eligible for a matching or profit-sharing contribution after reaching age 20, with a minimum of 1,000 hours of service during the year. Additional profit-sharing amounts may be contributed at the option of the Company. For the year ended December 31, 2024, the Company did not elect to contribute to a matching contribution or a profit-sharing contribution.

**Participant Accounts** — Individual accounts are maintained for each Plan participant. Each participant’s account is credited with the participant’s contribution, the Company’s matching contribution, and allocations of Plan earnings and the Company’s discretionary contributions and charged with withdrawals and an allocation of Plan losses and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Investments** — Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various registered investment companies investment options for participants.

**Vesting** — Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company’s contribution portion of their accounts is based on years of continuous service, based upon the schedule below:

**Notes Receivable from Participants** — Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant’s account and bear interest at prime rate + 1%. Interest rates range from 4.25% to 9.50% per annum on outstanding notes. Principal and interest is paid ratably through payroll deductions.

**Payment of Benefits** — On termination of service due to retirement, death or disability, a participant may elect to receive either a lump-sum amount of the value of the participant’s vested account interest or annual installments over a specified period as defined in the Plan. For termination of service for other reasons, a participant may receive the value of the vested account interest as a lump-sum distribution. Participants may be eligible for a hardship or in-service distribution while employed by the Company; however, the Roth 401(k) deferral account is not eligible for such distributions.

**Forfeitures** — At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$2,125 and \$2,702, respectively. These accounts will be used to reduce future employer contributions and then the remaining amounts will be used to pay certain Plan administrative expenses. During the year ended December 31, 2024, the Plan utilized \$685 of forfeitures towards Plan administrative expenses.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting** — The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

**Use of Estimates** — The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

**Risks and Uncertainties** — The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants’ account balances, and the amounts reported in the statements of net assets available for benefits. As of December 31, 2024 two investments represented a concentration of greater than 10% of the Plan’s net assets available for benefits. As of December 31, 2023, four investments represented a concentration of greater than 10% of the Plan’s net assets available for benefits.

**Investment Valuation and Income Recognition** — The Plan’s investments are stated at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants** — Notes receivable from participants typically are required to be repaid over five years and are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions based on the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**Payment of Benefits** — Benefit payments are recorded upon distribution.

**Administrative Expenses** — Certain administrative expenses of the Plan are paid by the Plan as provided in the Plan document and certain transactional expenses are deducted from participant accounts. In addition, certain investment related expenses have been offset with net investment income reported by the Plan and are not readily determinable.

### **3. FAIR VALUE MEASUREMENTS**

The Financial Accounting Standards Board (“FASB”) issued guidance on fair value measurements which establishes a framework for measuring fair value and requires additional disclosures about fair value measurements. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value and requires that assets and liabilities carried at fair value be classified and disclosed in the following three levels of inputs, with Level 1 having the highest priority:

- Level 1 — Inputs based on quoted prices for identical assets or liabilities in active markets at the measurement date.
- Level 2 — Observable inputs other than quoted prices included in Level 1, such as quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar instruments in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.
- Level 3 — Valuations derived from valuation techniques in which one or more significant inputs or significant value drivers are unobservable.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies and money market funds are valued at the daily closing price, as reported by the fund.

The valuation methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan

believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurement at the reporting date.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The following tables set forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. The tables below include the major categorization for investments on the basis of the nature and risk of the investments at December 31, 2024 and 2023.

The Plan's policy regarding the timing of transfers between levels, including both transfers into and transfers out of Level 3, is to measure and record the transfers at the end of the reporting period. For the years ended December 31, 2024 and 2023, the Plan had no transfers between levels.

**5. EXEMPT PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of funds managed by Vanguard Fiduciary Trust Company. Vanguard Fiduciary Trust Company is the Trustee as defined by the Plan and such investments and related transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund and are not readily determinable. Notes receivable from participants also qualify as party-in-interest transactions.

**6. PLAN TERMINATION**

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

**7. TAX STATUS**

The Plan uses a prototype plan document sponsored by The Vanguard Group. The Vanguard Group received an opinion letter from the IRS, dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the IRC. The Plan has been subsequently amended. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023 there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements.

**8. DELINQUENT PARTICIPANT CONTRIBUTIONS**

For the year ended December 31, 2024, the Company did not remit certain participant contributions to the Plan on a timely basis as defined by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Untimely remittances identified on the Schedule of Delinquent Participant Contributions totaled \$203 for the year ended December 31, 2024. The untimely remittances were corrected in 2024 and lost earnings of approximately \$2 were deposited to the participant's account.

**9. SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events occurring after the statement of net assets available for benefits date through the date of July 31, 2025, the date for which the financial statements were available to be released. There were no subsequent events that require disclosure in or adjustment to the financial statements.
