Scope and Nature of the ERISA Section 103(a)(3)(C)

We have performed audits of the financial statements of Solidus Technical Solutions, LLC 401(k) Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Note 1. Description of Plan

The following description of the Solidus Technical Solutions Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established to provide employees of Solidus Technical Solutions, LLC (the Company) with retirement benefits in accordance with Sections 401(a) and 401(k) of the Internal Revenue Code ("IRC"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

All benefit-eligible Company employees, except interns and temporary employees who have worked fewer than 1,000 hours during the plan year or incumbent employees brought on to Solidus for the purpose of working on a newly government awarded contract, are eligible to participate in the Plan if they are at least 21 years of age and have attained 3 months of service.

The Plan includes an automatic enrollment provision. Therefore, 3 months following the participant's date of hire, the Company automatically, on behalf of those participants, defers 3% of the participants' eligible compensation (as defined). Participant deferrals will be automatically increased by 1%, annually, on July 1st, until the participant deferral reaches 10% of eligible compensation. This annual increase does not apply to participants within the first six months following their date of enrollment. These deferrals will be automatically invested in a Vanguard Target Fund based on the participant's age at the time of enrollment. Participants may cancel, modify, or otherwise change any of the automatic elections.

Participant Contributions

Eligible participants may make voluntary contributions through salary reductions from 1% to 90% of their annual pre-tax eligible compensation, as defined by the Plan, limited to the maximum amounts allowed under the provisions of the IRC (\$23,000 in 2024). Further, participants who are 50 years of age or older as of December 31, 2024 may contribute an additional "catch up" contribution (\$7,500 in 2024). Rollovers from other qualified plans are permitted. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a common collective trust as investment options for participants.

The Plan allows participants to defer funds into a "Roth 401(k) deferral". These deferrals are subject to federal income taxes and the maximum allowable combined contributions of the Roth 401(k) and pre-tax deferrals is \$23,000.

Employer Contributions

The Company contributes 3% of eligible compensation for the plan year as a safe harbor non-elective contribution on behalf of all eligible participants. During the plan years ended December 31, 2024 and 2023, the Company made safe harbor contributions of \$365,656 and \$382,076, respectively.

The Company may also make a discretionary non-elective contribution, as determined annually by the Company’s Board of Directors. For the plan year ended December 31, 2024, the Company did not make any additional discretionary non-elective contributions.

Participants’ Accounts

Each participant’s account is credited with its respective contribution and its allocation of (a) employer contributions and (b) Plan earnings or losses.

Vesting

Participants’ voluntary contributions, safe harbor employer contributions, and earnings thereon vest immediately. Vesting in the Company’s discretionary non-elective contributions is based on years of service per the schedule below:

In the event of death, disability, or attainment of age 65, participants’ accounts become fully vested.

Payment of Benefits

Upon termination of employment, retirement, death, or disability, the participant or the participant’s beneficiary is entitled to receive the vested portion of the participant’s account in a single lump-sum. Further, withdrawals from the Plan before leaving the Company are available for special “hardship” reasons or after attaining the age of 59½. Distributions to participants are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Participants may borrow up to 50% of their vested account balance with a maximum of \$50,000. The interest rate on notes receivable from participants is set at the Federal prime rate plus 1% at the time of the loan. Loan terms range from one to five years. However, if the loan is to acquire the principal residence of the participant, the term may be extended. Loans are secured by the balance in the participant’s account. Principal and interest are paid ratably through automatic payroll deductions.

Forfeitures

The Plan provides that forfeitures, the unvested portion of employer contributions for terminated participants, will serve to reduce future Company contributions. There was no balance in the forfeiture account as of December 31, 2024 and 2023.

Note 2. Summary of Significant Accounting Policies

The following is a summary of significant accounting policies followed by the Plan.

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Quoted market prices, if available, are used to value investments. Common stocks and U.S. government securities are valued at the closing price reported on the active market on which the individual securities are traded. Corporate bonds are valued on the basis of yields currently available on comparable securities of issuers with similar credit ratings. Investments in certain restricted common stocks are valued at the quoted market price of the issuer's unrestricted common stock less a discount. If a quoted market price for unrestricted common stock of the issuer is not available, restricted common stocks are valued at a multiple of current earnings consistent with multiples of similar companies based on current market prices. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end.

The Plan's interest in the collective trust is valued based on information reported by the investment advisor using the audited financial statements of the collective trust at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses

The Company may, at its discretion, pay the expenses incidental to administering the Plan. In the event that the Company does not pay Plan expenses, the expenses shall be paid by the Plan.

Other Income

Certain mutual fund and collective trust expenses that are charged by the mutual fund companies to the individual participants are credited to the Plan on a quarterly basis. These assets are held in a reserve account and may be allocated to eligible participant accounts based upon each participants' pro rata percentage of total plan investments.

As of December 31, 2024 and 2023, the balance in the reserve account amounted to \$2,029 and \$1,805, respectively. During the years ended December 31, 2024 and 2023, funds credited to the Plan amounted to \$6,733 and \$5,538, and are included in other income in the accompanying statement of changes in net assets available for benefits.

Subsequent Events

The Plan has evaluated subsequent events through September 15, 2025, which is the date the financial statements were available to be issued.

Effective January 1, 2025, the Plan entered into an amendment to add a discretionary employer match contribution with a 4-year graded vesting schedule.

Note 3. Certification of Plan Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Charles Schwab Trust Bank, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income from participants as shown in the statements of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Tax Status

The Plan operates under a non-standardized adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by Sentinel Benefits Group Inc. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified, and the related trust was tax exempt as of the financial statement date.

Note 4. Related Party Transactions

Sentinel Pension Advisors, Inc. (SPA) is the Plan's recordkeeper and Charles Schwab Co., Inc. ("Schwab") is the Plan's trustee, and therefore, transactions with SPA and Schwab qualify as party-in-interest transactions, which are exempt from the prohibited transactions rules, as defined by ERISA. Total fees paid to SPA and Schwab during the year ended December 31, 2024 amounted to \$64,672, which is included in administrative expenses on the statement of changes in net assets available for benefits.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Risks and Uncertainties

The Plan provides for various investment options in accounts which invest in investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that these changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Note 5. Disclosures About Fair Value of Plan Assets and Liabilities

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

Level 1 - Quoted prices in active markets for identical assets.

Level 2 - Observable inputs other than Level 1 prices, such as quoted prices for similar assets; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets.

Level 3 - Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets.

Following is a description of valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on nonrecurring basis.

Mutual fund: Valued at the daily closing price as reported by the fund. The mutual fund held by the Plan is an open-end mutual fund that is registered with the Securities and Exchange Commission. This fund is required to publish its daily net asset value (NAV) and to transact at that price. The mutual fund held by the Plan is deemed to be actively traded.

Common collective trusts: Value is based on the underlying unit value of the assets held. The assets of the underlying fund are invested primarily in equity investments of publicly traded small cap companies based in the United States of America. The fair value of the contracts is determined using the market approach based on market prices of similar contracts. The NAV is used as a practical expedient to estimate fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
