INDEPENDENT AUDITORS' REPORT

To the Trustees of James G Parker Insurance Associates Employees' 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of James G Parker Insurance Associates Employees' 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of James G Parker Insurance Associates Employees' 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of, and for the years ending December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. DESCRIPTION OF THE PLAN

The following description of the James G. Parker Insurance Associates Employees' 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

a. General

The Plan is a defined contribution plan covering all eligible employees of James G. Parker Insurance Associates (the Employer). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and Section 401(a) of the Internal Revenue Code. The Board of Trustees oversees governance of the Plan.

b. Eligibility

All employees who are not part of a collective bargaining unit are eligible to participate. Each eligible employee may become a participant in the Plan on the first day of the quarter immediately following the completion of one hour of service and attainment of age twenty-one. Each participant will become eligible for an employer contribution following the completion of 1,000 hours and are age 21 or older.

c. Contributions

Both Plan participants and the Employer make contributions to the Plan as follows:

Participants may make elective contributions to the Plan on a pre-tax or after-tax basis. Such participant contributions are subject to the requirements of Sections 401(k) and 401(m) of the Internal Revenue Code.

The Employer will make a matching contribution, in an amount equal to a matching percentage deemed advisable, of the participant's salary reduction contributions for a plan year. The Employer in its sole discretion may also contribute an amount designated as a qualified non-elective contribution or a discretionary contribution. For the plan years ending December 31, 2024 and 2023 the Employer made a discretionary contribution of the lesser of 3% for management and 1.25% for staff or 100% of employee contribution.

For the plan years ending December 31, 2024 and 2023 the employer elected to make matching contributions of \$143,155 and \$136,092, respectively. The matching contribution for the year ending December 31, 2024 and 2023 was reduced by forfeitures of \$1,398 and \$2,731 for a net contribution of \$141,575 and \$133,361, respectively. All contributions are invested at the participant's discretion.

d. Participant Accounts

Each participant's account is credited with the participant's contributions, the Employer contributions, and an allocation of Plan earnings. Forfeited balances of terminated participants' nonvested accounts are used to reduce Employer contributions.

e. Benefits and Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Employer's contributions plus earnings is based on years of service. A participant is fully vested after three years of credited service. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

f. Participant Loans

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their non-forfeitable account balance. Loan terms, unless for the purchase of a principal residence, are not to exceed five years. The loans are secured by the balance in the participant's account. Interest rates on participant loans are 4.25% - 9.5% at December 31, 2024 and 2023. Principal and interest are paid ratably through payroll deductions.

g. Forfeitures

As of December 31, 2024, and 2023, the forfeiture account balance is \$1,928 and \$1,429, respectively. Forfeitures may be applied to reinstate previously forfeited account balances of Participants, or to satisfy any employer contribution that may be required, or to pay Plan expenses. Forfeitures must be disposed of no later than the last day of the Plan Year following the Plan Year in which the Forfeiture occurs. For the years ending December 31, 2024 and 2023, the Plan Sponsor used \$1,398 and \$2,731, respectively, of forfeitures to reduce employer contributions.

2. SIGNIFICANT ACCOUNTING POLICIES

a. Accounting Basis

The financial statements of the Plan are prepared under the accrual method of accounting which is in conformity with accounting principles generally accepted in the United States of America.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally receive if they were to initiate permitted transactions under the terms of the plan.

b. Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value, and common collective trust funds. Common collective trust funds are valued based on the net asset value per share practical expedient. The practical expedient method is used as the asset do not have a readily determinable fair value and are reported at the value obtained from the fund's investment company. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Trustees determine the Plan's valuation policies. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

c. Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

d. Administrative Cost

Certain administrative costs are being paid on behalf of the Plan by the Employer.

e. Payment of Benefits

Benefits are recorded when paid. Each participant is eligible to receive his or her benefits as a lump sum distribution on the first distribution date after the participant's separation from service. Distribution may also commence upon the attainment of death or disability.

f. Subsequent Events

The Company has evaluated subsequent events through September 3, 2025, which is the date that the financial statements were available to be issued.

There were no material subsequent events that required recognition or additional disclosure in these financial statements.

3. FINANCIAL INFORMATION CERTIFIED BY CUSTODIAN

The Plan administrator has elected the alternative method of compliance permitted by Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, investment information and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023 and net appreciation (depreciation) in fair value of investments, interest, and dividends for the years then ended, were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the Custodian.

4. GUARANTEED PORTFOLIO FUND

Empower general investment account investment option for defined contribution plans is a Guaranteed Portfolio Fund (GPF) provided through a group annuity contract (the "Contract"). Under the terms of the Contract, a crediting rate is established for amounts invested in the GFP and participants may direct permitted withdrawal and/or transfer transactions of all or a portion of their account balance at contract value. Contract value represents contributions plus credited interest less participant withdrawals and fees. This investment option is considered to be fully benefit responsive notwithstanding the market value events under the Contract that limit the ability of the Plan to transact at contract value when a market value event occurs.

Certain events limit the Plan's ability to transact at contract value with Empower. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value.

Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

As of the last day of the current year reporting period, the Plan's contract has a multi-index market value formula. The current year fair value presented below represents the calculated market value determined in accordance with the contractual market value formula currently in effect.

5. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB), *Accounting Standards Codification ASC 820 Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common-collective trusts: Valued at the net asset value (NAV) of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

7. RELATED PARTY AND PARTIES-IN-INTEREST TRANSACTIONS

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such employer or employee association, or relatives of such person. Certain Plan investments are shares in funds managed by a party-in-interest, the Plan's Custodian. Notes receivable from Plan participants and the related interest income are also considered party-in-interest transactions.

8. TAX STATUS

The Plan adopted a prototype plan offered by Fox and Fox. The prototype plan received an IRS Determination Letter dated March 31, 2014, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the IRS Determination Letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their entire account balance.

10. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

11. ADMINISTRATIVE EXPENSES

The Plan is administrated by the Plan Sponsor and the Plan Sponsor utilizes the professional administrative services of Fox & Fox. Costs of administrating the Plan are paid by the Plan to the extent not paid by the Plan Sponsor.

12. RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500, SCHEDULE H, PART II
