Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### 1. DESCRIPTION OF PLAN

The following description of Savings Plan for Employees of Steinway Musical Instruments, Inc. (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### a. General

The Plan is a defined contribution plan covering eligible employees of Steinway Musical Instruments, Inc., Steinway, Inc. and The O.S. Kelly Company (collectively, the Company), as defined in the plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Administrator is responsible for the oversight of the Plan, determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

#### b. Eligibility

All employees of the Company, except union employees and leased employees, are eligible to participate in the Plan at age 18, and begin to make elective deferrals on the first day of the month coinciding with, or next following, the date the eligibility requirements are met. Effective May 6, 2024, interns and per diem event helpers are also excluded from participating in the Plan. Employees must be employed on the last day of the plan year in order to be eligible to receive the Company's discretionary nonelective contributions.

#### c. Contributions

Participants may contribute up to 100% of their pre-tax annual compensation, as defined in the plan document, up to the maximum amount allowed by the Internal Revenue Code (IRC). The Plan also allows for post-tax (Roth) contributions. Participants who have reached the age of 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover contributions).

The Plan includes an auto enrollment feature whereby eligible employees are automatically enrolled in the Plan with a 3% deferral contribution rate. These deferrals will be allocated to a default fund as defined in the plan document. Participants may opt-out or elect a different deferral amount at any time.

The Company may also make discretionary nonelective contributions. For the year ended December 31, 2024, discretionary nonelective contributions were calculated as 5.25% of a participant's eligible compensation. The Company made discretionary nonelective contributions to the Plan totaling \$1,186,686 for the plan year ended December 31, 2024.

#### d. Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's discretionary nonelective contributions, plus earnings or losses thereon, and is charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their contributions into various investment options offered by the Plan.

#### e. Vesting

Participants are fully vested in their own contributions, plus earnings or losses thereon. Participants become vested in the Company's discretionary nonelective contributions and related earnings or losses after three years of service. Participants become fully vested upon death or disability.

#### f. Payment of Benefits

The Plan provides for a normal retirement benefit to be paid to participants who have reached the normal retirement age of 55. Upon termination of service, a participant may elect to receive a lump-sum amount equal to the value of their account or installment payments. There are also retirement benefits available upon disability and death. The Plan requires balances up to \$5,000 be paid out to participants upon termination. Effective January 1, 2024, the involuntary force-out distribution limit was increased to \$7,000 under the provisions of SECURE Act 2.0.

The Plan allows in-service withdrawals upon attainment of age 59 ½. A participant may also request a withdrawal upon demonstration to the Plan Administrator that they are suffering a "hardship". Hardship is defined in applicable regulations promulgated or to be promulgated pursuant to the applicable section of the IRC or standards established by the Secretary of the Treasury or their delegate.

#### g. Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range up to five years, unless for the purchase of a primary residence, in which case the maturity is ten years. Loans are secured by the vested balance in the participant's account and bear interest at one percent above the prime rate. Participants may have one loan outstanding at any time. Principal and interest are paid ratably through payroll deductions.

#### h. Forfeitures

Forfeitures represent non-vested Company discretionary nonelective contributions forfeited by participants who terminate their employment or withdraw from the Plan. Forfeitures may be used to pay plan expenses or reduce Company contributions. The Plan had \$135,796 and \$76,678 of unallocated forfeitures available for use as of December 31, 2024 and 2023, respectively. The Plan used \$83,317 of forfeitures to reduce Company discretionary nonelective contributions during the year ended December 31, 2024.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Basis of Presentation

The Plan prepares its financial statements in accordance with generally accepted accounting principles (U.S. GAAP) established by the Financial Accounting Standards Board (FASB). References to U.S. GAAP in these notes are to the FASB Accounting Standards Codification (ASC).

#### Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the investment advisor and qualified institution. See Note 4 for disclosure of fair value measurement.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation of investments includes gains and losses on investments bought and sold, as well as held during the year.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued unpaid interest. Interest income on notes receivable from participants is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded. For the year ended December 31, 2024, there were \$4,341 of defaulted loans that were deemed distributed and included in benefit payments to participants in the accompanying statement of changes in net assets available for benefits.

#### Contributions

Contributions from plan participants are recorded in the year which the participant contributions are withheld from compensation. Company discretionary nonelective contributions are recorded when such contributions are authorized by the Company's Board of Directors.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to recordkeeping, advisory services, the administration of notes receivable from participants, and processing of distributions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of investments.

#### Subsequent Events

Subsequent events have been evaluated through September 11, 2025, which is the date the financial statements were available to be issued. There were no events that met the criteria for recognition or disclosure in the financial statements.

### 3. INFORMATION PREPARED AND CERTIFIED BY THE PLAN'S QUALIFIED INSTITUTION

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company (Reliance), the qualified institution, has certified to the completeness and accuracy of all investments reported in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the supplemental schedule, Form 5500, Schedule H, Part IV, Line 4i - Schedule of Assets Held at End of Year as of December 31, 2024, and the related investment transactions and investment income reported in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to certified investment information, except for comparing such certified investment information included in the accompanying financial statements and supplemental schedule, Form 5500, Schedule H, Part IV, Line 4i - Schedule of Assets Held at End of Year.

### 4. FAIR VALUE MEASUREMENT

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. *Fair Value Measurement* establishes a hierarchy of the valuation techniques based upon whether the inputs to those valuation techniques reflect assumptions other market participants would use based upon market data obtained from independent sources (also referred to as observable inputs). The fair value hierarchy is as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual funds:* Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Money market funds:* Valued at the closing price reported by the fund sponsor from an actively traded exchange.

### 4. FAIR VALUE MEASUREMENT (Continued)

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There have been no changes in the methodologies used as of December 31, 2024 and 2023.

### 5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested and all accrued benefits shall be paid to participants in accordance with the provisions of the Plan.

### 6. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Accordingly, transactions with investment funds managed and held by the qualified institution are considered party-in-interest transactions.

The Plan also allows for a revenue sharing credit, which is used to offset certain amounts owed to the qualified institution for its administrative services to the Plan. During 2024, the Plan paid the qualified institution, third-party administrator, investment advisory, and auditor administrative expenses totaling \$106,591, which is presented net of \$49,964 of the revenue sharing credit in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024. As of December 31, 2024 and 2023, the balance in the revenue sharing account was \$813 and \$1,865, respectively.

### 7. TAX STATUS

The Company has obtained an opinion letter dated November 30, 2020, in which the Internal Revenue Service (IRS) stated that the restated prototype plan document was in compliance with applicable requirements of the IRC. The Plan Administrator timely adopted the restated prototype plan. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is currently being operated in accordance with the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

### 8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant balances and the amounts reported in the accompanying statements of net assets available for benefits.

### 9. DELINQUENT PARTICIPANT CONTRIBUTIONS

During 2023, the Company failed to segregate and remit in a timely manner certain participant contributions (salary reduction amounts) from its assets within the required time period as specified by the United States DOL Reg. 2520.3012. Failure to segregate and remit contributions and loan repayments within the specified time period is a prohibited transaction. The Company calculated and funded lost earnings on the participant contributions and loan repayments in 2024.
