Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance, but is not absolute assurance, and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO THE FINANCIAL STATEMENTS

1. PLAN DESCRIPTION

The following description of American Chemet Corporation 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions. The Plan is a multiple employer plan covering employees of American Chemet Corporation (the Employer) and employees of Royal Metal Powders, Inc. (a Participating Employer), collectively the Company. On February 26, 2024, Royal Metal Powders, Inc. was sold to an unaffiliated entity, which obtained the name and changed it to Royal Metal Powders, LLC. The employees of Royal Metal Powders, Inc. were re-employed by the unaffiliated company, and as such, are no longer participating in the Plan.

General The Plan is a defined contribution plan covering substantially all full-time employees of the Company. Employees are eligible immediately upon hire to make employee deferrals. Newly eligible employees must be enrolled within 35 days from date of hire. Employees are eligible to receive company contributions if they are age 18 or older. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA), as amended. The Plan was originally established as of June 30, 1962, and has been subsequently amended and restated. The Plan administrator is responsible for oversight of the Plan, including the appropriateness of the Plan's investment offerings and investment performance.

Contributions Participants may elect to contribute to the Plan, in the form of discretionary contributions, up to the lesser of 100% of their eligible compensation or the maximum amount allowable by law. For the years ended December 31, 2024 and 2023, the maximum amount was \$23,000 and \$22,500, respectively. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. For 2024 and 2023, the maximum catch-up contribution was \$7,500. Participants may also contribute amounts representing distributions from other qualified retirement plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company makes discretionary profit sharing contributions and match contributions. Each year, the Company may provide a discretionary contribution to the Plan as determined by the Board of Directors. The Company made profit sharing contributions of \$148,312 and \$163,107 for the years ended December 31, 2024 and 2023, respectively. The Company provides a matching contribution of 25% of the participant's contributions, up to \$500 annually, for participants who are also participating in the Company's Defined Benefit plan. For those participants who are not also participants in the Company's Defined Benefit plan, the Company provides a 100% matching contribution, up to 6% of the participant's eligible compensation. The Company made matching contributions of \$399,000 and \$468,061 for the years ended December 31, 2024 and 2023, respectively.

Automatic Enrollment Employees eligible to participate in the Plan are automatically enrolled upon meeting the eligibility requirements noted above. Unless otherwise directed, the rate of deferral upon enrollment is 4% of eligible compensation on a pre-tax basis, to be invested in specific pre-selected investment offerings based on a participant's estimated time to retirement. Unless the participant elects otherwise, their deferral contribution rate is increased automatically by 1% each year, until it reaches a maximum of 6%.

NOTES TO THE FINANCIAL STATEMENTS

(Continued)

Participant Accounts Each participant's account is credited with the participant's contributions, Company contributions, and account earnings, and may be charged with an allocation of administrative expenses that are paid by the Plan. The Company's allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting Participants are immediately vested in their contributions, rollover contributions, and earnings thereon. Vesting in company matching and discretionary contributions is based on year of continuous service. A participant is 100% vested after three years of credited service. Participants are credited with one year of service for each plan year in which they worked at least 1,000 hours.

Notes Receivable From Participants Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note receivable repayment terms generally may not exceed five years, except in the case of the purchase of a primary residence. The notes receivable are secured by the balances in the participants' accounts. The notes receivable interest rate, determined at the date the loan is originated by the Company, is based on the prevailing interest rate charged by lending institutions under similar circumstances.

Payment of Benefits Withdrawals are allowed in the event of termination, disability, death, retirement, or attainment of age 73. Depending on the event, the withdrawal may be subject to early withdrawal penalties imposed by the *Internal Revenue Code* (IRC). Payments are made in the form of a lump-sum distribution or annual installments over a period of time of not more than the participant's life expectancy. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Participants with vested account balances less than \$1,000 will receive a single lump-sum cash payment. Distributions for participants with vested balances greater than \$1,000 require participant consent.

At December 31, 2024 and 2023, there were no amounts allocated to participants who elected to withdraw from the Plan but have not yet been paid.

Hardship distributions are allowed for certain expenses and may be withdrawn from elective deferrals and vested amounts of company contributions. Hardship withdrawals are subject to a \$500 minimum.

Forfeitures Forfeitures attributable to discretionary profit sharing contributions and matching contributions may be used to reduce Plan expenses or to reduce future company contributions. Forfeited nonvested account balances totaling \$55,846 and \$87,286 were used to reduce Company contributions for the years ended December 31, 2024 and 2023, respectively. At December 31, 2024 and 2023, the remaining forfeited nonvested accounts totaled \$2,871 and \$24,129, respectively.

Plan Termination Although it has not expressed any intent to do so, the Company has the right to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a plan termination, participants would become 100% vested in their Company contributions.

2. SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting The Plan uses the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition Investments are reported at fair value. Fair value is the price that would be received to sell an asset, or paid to transfer a liability, in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the investment advisors and the trustee. Fair value measurements are discussed below.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when received. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments purchased and sold, as well as held during the year.

Fair Value Measurements The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

NOTES TO THE FINANCIAL STATEMENTS

(Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Assets are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trust: The common collective trust maintained by Fidelity, a party in interest, is a pool of investments of which the Plan buys and sells units of participation that generally imitate established mutual funds. The underlying investments consist of a common collective trust which holds investment contracts issued by insurance companies and financial institutions, fixed income securities, money market funds, and collective investment vehicles. The Plan's valuation estimates are based on the contract and market values of the underlying investments using the practical expedient. Participant transactions issuances and redemptions may occur daily. If the Plan were to initiate a full redemption of the common collective trust, Fidelity reserves the right to temporarily delay withdrawal from the trust, in order to ensure that securities liquidations will be carried out in an orderly business manner. There were no unfunded commitments at December 31, 2024 and 2023.

See note 4 for the classification of these assets within the fair value hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Notes Receivable From Participants Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Delinquent participant notes receivable are recorded as distributions in accordance with the terms of the Plan agreement.

Excess Contributions Payable Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions.

Payment of Benefits Benefits are recorded when paid.

Expenses Investment management fees and certain other administrative expenses are paid by the Plan. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, and through direct payments that are included in administrative expenses. All other fees associated with the Plan are paid by the Company, and are not reimbursed by the Plan. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

Evaluation of Subsequent Events The Plan has evaluated subsequent events through September 4, 2025, the date the financial statements were available to be issued.

3. INFORMATION CERTIFIED BY FIDELITY MANAGEMENT TRUST COMPANY (UNAUDITED)

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such an election, the investments and notes receivable from participants included on the statements of net assets available for benefits, and the investment income and interest income in notes receivable from participants included on the statements of changes in net assets available for benefits as of and for the years ended December 31, 2024 and 2023, were not subject to auditing procedures and have been certified as complete and accurate by Fidelity Management Trust Company. Fidelity Management Trust Company is a qualified institution that prepared and certified the information in accordance with 29 CFR 2520.103-5.

5. RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Company is the administrator of the Plan. The Plan's administrator may designate other persons to carry out the day-to-day operations of the Plan. The Plan has an investment contract with Fidelity Management Trust Company. Fidelity Management Trust Company, as the Plan's broker, qualifies as a party in interest with respect to the investments managed by them; however, they are exempt from the prohibited transaction rules under ERISA. Fees paid by the Plan for investment management services amounted to \$46,474 and \$40,574 for the years ended December 31, 2024 and 2023, respectively. The Plan also has an investment contract with Morgan Stanley. Morgan Stanley, as the Plan's investment advisor, qualifies as a party in interest; however, they are exempt from the prohibited transaction rules under ERISA. Fees paid by the Plan for investment advisory services amounted to \$25,000 for each of the years ended December 31, 2024 and 2023.

6. TAX STATUS

The Plan has adopted a pre-approved, nonstandardized profit sharing plan established by Fidelity Management Trust Company. The pre-approved plan obtained an opinion letter on June 30, 2020, in which the IRS stated that the form of the pre-approved plan, as then designed, was acceptable under Section 401 of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan is qualified and the related trust is tax exempt.

7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The Plan had delinquent participant contributions for the year ended December 31, 2023. Delinquent contributions for the year ended December 31, 2023, amounted to \$14,643. There were no delinquent participant contributions for the year ended December 31, 2024. Management has corrected the late remittances and is confident the prohibited transactions will not adversely affect the qualified status of the Plan.

8. PLAN AMENDMENTS

Effective February 1, 2022, the Plan was restated as required by the IRS under the Cycle 3 DC restatement. Additional amendments have been made to this Plan document to include those required and optional provisional elements and will be included in the Plan document during the next restatement cycle.

Effective January 1, 2023, the Plan was amended to fund match contributions per pay period.

On February 26, 2024, Royal Metal Powders, Inc., a participating employer, was sold to an unaffiliated entity. Effective April 22, 2024, the Plan was amended to remove Royal Metal Powders, Inc. as a participating employer under the Plan. Participant account balances were distributed or rolled over into the purchaser's plan.
