## INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees of  
Local 531 Pension Fund

### Qualified Opinion

We have audited the accompanying financial statements of Local 531 Pension Fund (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits in liquidation as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits in liquidation for the years then ended, and the related notes to the financial statements.

In our opinion, except for the possible effects of the matter discussed in the Basis for Qualified Opinion section of the report, the financial statements referred to in the first paragraph present fairly, in all material respects, the net assets available for benefits in liquidation of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits in liquidation for the years then ended in accordance with accounting principles generally accepted in the United States of America.

### Basis for Qualified Opinion

As more fully described in Note 4 to the financial statements, the Pension Benefit Guaranty Corporation amended its multiemployer reporting, disclosure, and valuation regulations to reduce the number of actuarial valuations required for smaller plans terminated by mass withdrawal. As a result, the Plan did not prepare its accumulated plan benefits and changes therein and present the results in the financial statements in accordance with accounting principles generally accepted in the United States of America.

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our qualified audit opinion.





## Emphasis of Matters

As further discussed in Note 1 to the financial statements, the Plan is in termination phase which commenced effective November 30, 1997. At that time, in accordance with accounting principles generally accepted in the United States of America, the Plan changed its basis of accounting from going concern basis to liquidation basis. Given the nature of the Plan's assets and liabilities, such liquidation basis did not result in any material differences from that which would be reported on a going concern basis.

As discussed in Note 5 to the financial statements, since 2014, the Plan has been receiving financial assistance from the Pension Benefit Guaranty Corporation (PBGC), a U.S. governmental agency. In general, the PBGC guarantees certain Plan benefits at amounts which may be reduced from normal Plan benefit levels. Our opinion is not modified with respect to this matter.

## Responsibilities of Management for the Financial Statements

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

### NOTES TO FINANCIAL STATEMENTS

YEARS ENDED DECEMBER 31, 2024 AND 2023

#### NOTE 1. DESCRIPTION OF PLAN

The following brief description of the Local 531 Pension Fund (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

**General** - The Plan is a multiemployer defined benefit pension plan established under an Agreement and Declaration of Trust dated May 16, 1962, between Local 320 Production Sales and Service Employees (the Union), and various employers operating in the Greater New York area who were parties to collective bargaining agreements with the Union requiring contributions to the Plan. The Union and the employers agreed to participate in the operation of a trust fund for the purpose of providing pension benefits for employees represented by the Union. Effective November 4, 1971, Local 320 changed its name and affiliation to Local 531 International Brotherhood of Teamsters. The Plan is administered by a Board of Trustees (Trustees) consisting of union and employer representatives and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan was terminated by mass withdrawal of employers effective November 30, 1997. Contributing employers amended their respective collective bargaining agreements with the Union to provide for the cessation of contributions to the Plan effective November 30, 1997. Non-collectively bargained contributing employers also agreed to cease contributing to the Plan effective November 30, 1997. The Plan filed a Notice of Plan Termination by Mass Withdrawal with the Pension Benefit Guaranty Corporation (PBGC) on May 21, 1998 and assessed a withdrawal liability against each employer. Under ERISA, the Trustees continue to administer the Plan as a wasting trust, including collecting withdrawal liability payments from former contributing employers and pay benefits earned through April 1, 1996, the date benefit accruals were suspended for all active employees.

On September 30, 2014, the Plan began receiving financial assistance from the PBGC and has continued to receive financial assistance which resulted in a reduction of promised pension benefits.

**Benefits** - Pension benefits for retirees are payable up to the maximum amounts guaranteed by the PBGC. Benefits are calculated by determining the benefit earned per year of credit service (CS). The participant's PBGC maximum guaranteed benefit equals his years of CS multiplied by (1) plus (2).



## NOTE 1. DESCRIPTION OF PLAN (CONTINUED)

1. 100% of the first \$11 per year of CS; and
2. 75% of the next \$33 per year of CS.

**Funding Policy** - The Plan is currently being funded by the continued financial support received from the PBGC and from withdrawal liability payments received from former contributing employers.

## NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** - The accompanying financial statements have been prepared on the liquidation basis of accounting. Given the nature of the Plan's assets and liabilities, such liquidation basis does not result in any material differences from that which would be reported on a going concern basis.

**Use of Estimates** - The preparation of financial statements in conformity with the liquidation basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, disclosure of contingent assets and liabilities, if any. Actual results could differ from those estimates.

**Withdrawal Liability Receivable** - Withdrawal liability amounts due from former contributing employers are accrued at year end based on subsequent period cash collections. Based on a review of historical losses, current economic conditions and supportable and reasonable forecast assumptions, the Plan has concluded that any expected credit losses on balances outstanding at year end will be immaterial.

**Administrative Expenses** - Expenses incurred in connection with the general administration of the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits in liquidation.

**Payment of Benefits** - Benefit payments to participants are recorded upon distribution.

## NOTE 3. TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Plan by a letter dated July 13, 1995, that the Plan meets the requirements of Internal Revenue Code (IRC) Section 401(a) and is exempt from federal income taxes under IRC Section 501(a). The Plan has been amended since receiving the determination letter. However, the Trustees believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.



### **NOTE 3. TAX STATUS (CONTINUED)**

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **NOTE 4. ACTUARIAL VALUATION**

On May 2, 2019, the PBGC issued a final rule amending its multiemployer reporting, disclosure, and valuation regulations to reduce the number of actuarial valuations required by smaller plans terminated by mass withdrawal. The rule is intended to reduce costs by allowing smaller plans terminated by mass withdrawal to perform actuarial valuations less frequently. This reduces plan administrative expenses resulting in a reduction in financial assistance provided by the PBGC. Effective for plan years ending after July 1, 2019, actuarial valuations can only be prepared once every 5 years if the present value of the plan's nonforfeitable benefits is \$50 million or less. Since the Plan's nonforfeitable benefits is less than \$50 million, the Plan's actuary has not prepared an actuarial valuation and therefore the Plan's accumulated plan benefits and changes therein are not presented in these financial statements. The last actuarial valuation prepared for the Plan was for the year ended December 31, 2021. It is anticipated the Plan's next actuarial valuation will be prepared for the year ended December 31, 2026.

### **NOTE 5. INSOLVENCY AND PBGC FUNDING**

During the year ended December 31, 2013, the Plan prepared a notice of insolvency to the PBGC. In connection with this notice, the Plan submitted an application for financial assistance on August 24, 2014, requesting that the PBGC provide supplemental funding of benefit payments and reasonable administrative expenses incurred by the Plan after depletion of existing plan assets. On September 30, 2014, the PBGC began providing financial assistance to the Plan, and during the years ended December 31, 2024 and 2023, the Plan received \$383,300 and \$392,600, respectively. Total PBGC financial assistance received by the Plan at December 31, 2024 and 2023 is \$4,688,723 and \$4,301,501, respectively.

The Trustees of the Plan have signed a promissory note as a condition to receiving financial assistance from the PBGC. Amounts received from the PBGC are recognized as a liability in the statements of net assets available for benefits in liquidation. In addition, PBGC premiums are no longer required to be remitted to the PBGC, although the Plan must still file with the PBGC. However, the waived premiums are added to the Plan's promissory note. The ability of the Plan to continue operations and pay benefits is solely dependent on the PBGC continuing to provide financial assistance.



## **NOTE 6. PARTY-IN-INTEREST TRANSACTIONS**

The Plan pays certain administrative and professional fees to various service providers. These transactions are considered exempt party-in-interest transactions under ERISA.

## **NOTE 7. SUBSEQUENT EVENTS**

Subsequent events have been evaluated through September 5, 2025, which is the date the financial statements were available to be issued. This review and evaluation revealed no material event or transaction which would require an adjustment to or disclosure in the accompanying financial statements.
