To the Participants and Plan Administrator of
Invitation Homes 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Invitation Homes 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control-related matters that we identified during the audit.

Other Matter — Supplemental Schedule Required by ERISA

The supplemental schedule, Schedule H, Line 4i, Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

1. DESCRIPTION OF THE PLAN

The following description of the Invitation Homes 401(k) Plan (the "Plan") is provided for informational purposes only. Participants should refer to the Plan document for a complete description of the Plan.

General — The Plan is a defined contribution plan, effective January 1, 2013, and restated December 1, 2022, in which all employees of THR Property Management, LP/DBA Invitation Homes and its subsidiaries (the "Company" or "Plan Sponsor") may participate subject to their satisfaction of the Plan's eligibility requirements. The Plan Sponsor is a subsidiary of Invitation Homes Inc. (the "Parent").

On July 11, 2022, the Company's Benefits Committee approved the appointment of Fidelity Investments ("Fidelity") as the Plan recordkeeper and Fidelity Management Trust Company as the new Plan trustee (the "Trustee") and asset custodian effective December 1, 2022. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Eligibility — Employees of the Company may participate in the Plan if they are at least age 21 and have completed three months of service, except that seasonal employees are not eligible for Plan participation. Long-term part-time employees who meet eligibility requirements under the Setting Every Community Up for Retirement Enhancement Act ("SECURE") of 2019 are also eligible to participate in the Plan. Employees may become a participant on the first day of the month following the completion of the eligibility requirements.

Contributions — Contributions to the Plan may include (i) salary reduction contributions authorized by participants, (ii) matching contributions made by the Company, (iii) discretionary contributions made by the Company, and (iv) participant rollovers from another plan. Both participant contributions and Company contributions are reported on the Statement of Changes in Net Assets in the year in which the participant contributions are withheld from compensation.

Participants may elect to contribute a percentage of their compensation, as defined in the Plan document, to the Plan each year, subject to certain limitations described in the Plan document. Such contributions are excluded from the participant's taxable income for federal income tax purposes until received as a withdrawal or distribution from the Plan or are included in the participant's taxable income for federal income tax purposes, based on the participant's election. The Plan allows participants to make designated Roth contributions, as defined in Plan document, on an after-tax basis and allows rollovers of designated Roth contributions into the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Catch-up contributions are not eligible for a Company matching contribution.

The Company makes a safe harbor matching contribution to each participant's account equal to 100% of the first 3% of compensation deferred by participants, and 50% of the next 2% of compensation deferred by participants. This contribution is intended to satisfy a safe harbor contribution formula permitted by Internal Revenue Service ("IRS") regulations. By making the safe harbor matching contribution, the Plan will automatically satisfy the nondiscrimination requirements that otherwise would apply to 401(k) contributions made by the Plan. Additional amounts may be contributed at the discretion of the Board of Directors of the Company's Parent. During the year ended December 31, 2024, there were no discretionary contributions made by the Company.

The Plan allows participants to make rollover contributions representing distributions from other qualified defined benefit or defined contribution plans. Rollover contributions are subject to certain Internal Revenue Code ("IRC") limitations.

Participant contribution receivables and Company contribution receivables, if any, consist of contributions that were in transit to the Plan as of year end. All contributions for the years ended December 31, 2024 and December 31, 2023 had been received by the Plan prior to year end.

Participant Accounts — Individual accounts are maintained for each participant in the Plan. Each participant's account is credited with the participant's contributions, related matching and non-elective contributions, discretionary contributions, and Plan earnings. Participant accounts are also charged with withdrawals and an allocation of Plan losses and administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Investments — Participants direct the investment of their contributions, Company contributions, and/or account balances into various investment options offered by the Plan. The Plan currently offers registered investment companies and common collective trust investment options. Participants may change investments and transfer amounts between funds daily unless otherwise restricted by the issuer of the investment option.

Vesting — Participants are vested immediately in their contributions, Company safe harbor matching contributions, and earnings thereon. Company discretionary contributions vest based on years of service, and a participant is 100% vested therein after six years of credited service.

Forfeited Accounts — As of December 31, 2024 and 2023, there were \$59,824 and \$69,538 of forfeited nonvested accounts, respectively. During the year ended December 31, 2024, Company contributions were reduced by \$15,182 from forfeited nonvested accounts.

Notes Receivable from Participants — Participants may borrow from their accounts a minimum of \$500 up to a maximum of the lesser of one-half of the vested account balance or \$50,000. The loans are secured by an assignment of a participant's vested interest in the Plan and bear interest at a rate commensurate with local prevailing rates at the time funds are borrowed as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions or as a lump sum for the outstanding loan balance. Loan terms range from 1 to 5 years; however, terms may exceed five years for the purchase of a primary residence. As of both December 31, 2024 and 2023, participant loans had maturities through 2048 at an interest rate between 4.25% and 10.50%.

Payment of Benefits — Upon termination of service with the Company (including termination of service due to death, disability, or retirement), a participant may generally elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or the payment paid as a direct rollover to an individual retirement account or another employer's tax qualified plan. If a terminated participant's vested balance is less than or equal to \$7,000, the amount may be automatically distributed in the form of lump sum payment or individual retirement account, depending on the balance.

Participants are also eligible to make certain hardship withdrawals from their account balance.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting — The accompanying financial statements have been prepared in accordance with U.S. generally accepted accounting principles ("GAAP").

Use of Estimates — The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties — The Plan provides various investment options to its participants. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, market risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect the value of the participants' account balances and the amounts reported in the financial statements.

Investment Valuation and Income Recognition — The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Stable Asset Trust — The Invesco Stable Value Trust (the "SVT") is a collective trust fund sponsored by Invesco. The beneficial interest of each participant is represented by units. Units are issued and redeemed daily at the SVT's constant net asset value ("NAV") of \$1 per unit. Distributions to the SVT's unit holders are declared daily from the net investment income and automatically reinvested in the SVT on a monthly basis, when paid. It is the policy of the SVT to use its best efforts to maintain a stable NAV of \$1 per unit; although there is no guarantee that the SVT will be able to maintain this value.

Participants ordinarily may direct either the withdrawal or transfer of all or a portion of their investment at contract value. Contract value represents contributions made to the SVT, plus earnings, less participant withdrawals and administrative expenses. Certain events may limit the ability of the Plan to transact at contract value with the stable value fund (for example, partial or complete termination of the Plan or its merger with another plan, layoffs, bankruptcy, mergers, early retirement incentives, certain transfers of assets from the stable value fund) and may also limit the ability of the stable value fund to transact at contract value with the participants. The Company believes that the occurrence of events that would cause the fund to transact at less than \$1 per unit is not probable.

Notes Receivable from Participants — Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions based on the terms of the Plan document.

Administrative and Investment Management Expenses — Administrative expenses of the Plan can be paid by the Plan Sponsor or from the trust assets as provided in the Plan document. All investment management and transaction fees directly related to the Plan investments are paid by the Plan. Management fees and operating expenses charged to the Plan for investments are either deducted from income earned on a daily basis or are separately reflected in the financial statements of the Plan Sponsor. Consequently, management fees and operating expenses can be reflected as a reduction of investment return on such investments in the financial statements of the Plan or as an expense in the financial statements of the Plan Sponsor.

Revenue Sharing Account — The revenue sharing account is used to pay administrative expenses or is allocated to participant accounts. At December 31, 2024 and 2023, there were \$17,198 and \$7,130, respectively, of revenue sharing account balances available. During the year ended December 31, 2024, there were \$9,409 of revenue sharing fund contributions, and no amounts were reallocated to participants

accounts in accordance with the revenue credits program. Administrative expenses as reported on the Statement of Changes in Net Assets Available for Benefits are net of revenue sharing contributions.

Payment of Benefits — Benefit payments to participants are recorded upon distribution. There were no participants who elected to withdraw from the Plan but had not yet been paid at December 31, 2024 and 2023.

Excess Participant Contributions Payable — The Plan is required to return employee contributions received during the Plan year in excess of the amounts allowed by the IRS. There were no contributions in excess of amounts allowed by the IRS at December 31, 2024 and 2023.

Plan Termination — Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants' accounts will become fully vested and non-forfeitable.

Recent Regulatory Updates — The SECURE 2.0 Act of 2022 (the "SECURE 2.0 Act") was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the year ended December 31, 2024, which did not have a material effect on the Plan's financial statements. Plan management continues to evaluate the optional provisions of the SECURE 2.0 Act and any potential impact to the Plan.

3. INFORMATION CERTIFIED BY THE TRUSTEE

Certain information disclosed in the accompanying financial statements and ERISA-required supplementary information was obtained by management and agreed to or derived from information certified as complete and accurate by the Trustee. The certified information related to investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, and dividends, as well as interest income on notes receivable from participants for the year ended December 31, 2024.

4. FAIR VALUE MEASUREMENTS

Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value, as follows: Level 1, which refers to securities valued using unadjusted quoted prices from active markets for identical assets; Level 2, which refers to securities not traded on an active market but for which observable market inputs are readily available; and Level 3, which refers to securities valued based on significant unobservable inputs. Assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

Asset Valuation Techniques — Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value.

Money Market and Mutual Funds — Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trust Funds — Valued at the NAV of the units of the collective trust. The NAV as provided by the Trustee is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities.

The SVT is composed primarily of fully benefit-responsive investment contracts and is valued at the NAV of units of the collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

5. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds and common collective trust accounts provided through the Trustee. Effective December 1, 2022, Fidelity Investments is the Plan recordkeeper, and Fidelity Management Trust Company is the Trustee. Therefore, these transactions qualify as party-in-interest transactions. All investment fund earnings or losses posted to each Plan participant's account are net of investment management fees charged by each investment fund under the Plan.

The Plan also holds notes receivable from participants which qualify as exempt party-in-interest transactions. Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee received compensation from the Plan.

6. FEDERAL INCOME TAX STATUS

The Plan is maintained as a tax-exempt plan. Effective December 1, 2022, the Plan uses a pre-approved plan document sponsored by Fidelity. Fidelity received an opinion letter from the IRS, dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the IRC. The Plan Sponsor did not apply for an IRS determination letter because it relies on the IRS's opinion letter. Plan management believes that the plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
