Board of Trustees

Glacier Fish Company, LLC 401(k) Savings Plan and Trust:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists.

The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedules Required by ERISA

The supplemental schedules, Schedule H, line 4i – Schedule of Assets (Held at End of Year) and Schedule H, line 4a – Schedule of Delinquent Participant Contributions, as of December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

1. DESCRIPTION OF PLAN

The following description of the Glacier Fish Company, LLC 401(k) Savings Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

a. General

The Plan is a defined contribution plan, established on January 1, 2000, covering all employees of Glacier Fish Company, LLC (the Company). The Company is also the plan sponsor and plan administrator.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

b. Eligibility

Employees are eligible to contribute to the Plan once they attain the age of 21. Eligible entry begins on the first day of the month following date of hire. Employees are eligible to receive employer contributions after they attain the age of 21 and complete one year of service. For all vessel crew employees, the Plan defined a year of service as a twelve-month eligibility service period in which the employee completed 100 days of service. For non-vessel employees, the Plan defined a year of service as a twelve-month eligibility service period in which the employee completed 1,000 hours of service. Eligibility for employer contributions begins on February 1 or August 1 following, or commensurate with, the attainment of the age and service requirements.

For former vessel employees of North Star Fishing Company LLC who become employees of the Company, the one year of service eligibility requirement is waived.

c. Contributions

Plan participants may elect to contribute a portion of their compensation, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Plan has a safe-harbor matching contribution feature. Under the terms of the safe harbor provisions, the Company matches employee contributions up to a maximum of 3% of the employee's earnings. In addition, the Company will match half of the employee's contributions that are above 3% of the employee earnings to a maximum of 5% of the employee's earnings.

The Company may also contribute a discretionary qualified non-elective contribution. This contribution is allocated to participants based on the employees' proportionate share of the total compensation paid during the Plan year to all participants in the Plan. There were no such contributions made for the years ended December 31, 2024 and 2023

The Plan also permits the Company to make a discretionary profit-sharing contribution. This contribution is allocated to participants based on the employees' annual compensation. There were no such contributions made for the years ended December 31, 2024 and 2023.

c. Contributions, (Continued)

Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers several mutual funds and a collective investment fund.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

d. Participant accounts

Each participant's account is credited with the participant's contributions and an allocation of the employer's contributions, plan earnings (losses) and plan expenses. The allocation of the Plan's earnings or losses is based on each participant's share/unit values. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested accounts.

e. Vesting

Participant interests in their 401(k) contributions and the Company's safe-harbor matching contributions allocated to participant accounts will be 100% vested at all times.

Participant interests in any discretionary qualified non-elective contributions and profit-sharing contributions the Company may make to the Plan will become 100% vested upon attaining the Plan's normal retirement age or if employment is terminated because of death or disability. The Plan defines a participant's normal retirement age as the later of reaching age 59½ or the 5th anniversary of the date on which participation commenced in the Plan.

If employment is terminated prior to normal retirement age for any reason other than death or disability, then the participant's interest in any discretionary qualified non-elective contributions and profit-sharing contributions the Company may make to the Plan will become vested in accordance with the following schedule:

Less than 3	None
3 or more	100%

f. Payment of benefits

Upon retirement, disability, termination or death, if the vested account balance exceeds \$1,000, then a participant or the stated beneficiary shall elect distribution under one, or any combination, of the following methods: (a) by payment in a lump sum; (b) by a partial payment in a lump sum and partial payment in installments; or (c) by payments over a specified period of time, not exceeding the life expectancy of the participant, or the joint life and last survivor expectancy of the participant and his/her beneficiary.

Following termination, a participant must wait 270 days before receiving a distribution, unless having already attained normal retirement age. Terminations due to death or disability result in a shortened waiting period of 180 days. Non-highly compensated, non-vessel participants are not subject to any waiting period.

f. Payment of benefits, (Continued)

If a participant's vested account balance does not exceed \$1,000, then the participant may only receive a distribution in a lump sum.

If the present value of a participant's non-forfeitable accrued benefit does not exceed the "cash-out limit" of \$1,000 at the time of distribution, then the Plan may make a distribution to the participant without participant consent. If the value of the non-forfeitable accrued benefit exceeds \$1,000, then any distribution requires participant consent.

Participants may also withdraw funds from their account in the event of financial hardship as defined by the Plan.

g. Forfeitures

Forfeited account balances are allocated to the remaining participants as part of the Company's matching contribution for the Plan year. At December 31, 2024 and 2023, there were no forfeited, non-vested amounts.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

a. Basis of accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

b. Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

c. Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's administrative committee determines the Plan's valuation policies utilizing information provided by the investment adviser and trustee. See note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

d. Payment of benefits

Benefits are recorded when paid.

(Continued)

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES, (Continued)

e. Administrative expenses

Transaction based fees are charged directly to the participants' accounts. Substantially all administrative expenses are paid by the Plan. Administrative expenses paid by the Plan are charged to participants' accounts and apportioned based upon their relative account values. Investment related expenses are included in net appreciation of fair value of investments.

f. Date of the Plan's review

The Plan has evaluated subsequent events through September 12, 2025, the date the financial statements were available to be issued.

3. TRUSTEE CERTIFICATIONS UNDER ERISA SECTION 103(a)(3)(C)

The plan sponsor has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under such election, the auditors' examination did not extend to the following investment information certified by Charles Schwab Trust Bank, the trustee, as complete and accurate:

- Investments
- Net appreciation in fair value of investments
- Interest and dividends
- Schedule of assets (held at end of year)

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

4. FAIR VALUE MEASUREMENTS, (Continued)

Level 2 Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs that are unobservable inputs for the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective investment fund: Valued at the NAV of units of the collective investment fund. The NAV, as provided by the fund's trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell an investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective investment fund, the investment adviser reserves the right to temporarily delay withdrawal from the trust for twelve months.

There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

5. PARTY-IN-INTEREST TRANSACTIONS

During 2024 and 2023, the Plan investment funds were held by Charles Schwab Trust Bank. Charles Schwab Trust Bank is the trustee as defined by the Plan and, therefore, these transactions are recognized as exempt party-in-interest transactions under ERISA.

The Plan paid \$85,281 and \$76,555 for expenses related to plan operations and investment activity to various service providers for the years ended December 31, 2024 and 2023, respectively. These expenses are recognized as exempt party-in-interest transactions under ERISA.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in any employer discretionary contributions.

7. TAX STATUS

The Plan utilizes a prototype non-standardized pre-approved profit sharing plan document administered by Eisenhower Carlson PLLC that obtained a determination letter dated June 30, 2020 from the IRS, which states that the Plan, as designed, complied with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

9. PROHIBITED TRANSACTIONS

During 2024, participant contributions totaling \$21,981 were not remitted to the Plan's trustee within the period prescribed by DOL regulations constituting delinquent contributions. The delinquent contributions were considered a nonexempt party-in-interest transaction, however, it does not affect the tax status of the Plan.

The Company will compensate the participants for any lost interest and earnings resulting from the delay in remittance during 2025.
