***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of The Ambassador Holding Company 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). NOTES TO FINANCIAL STATEMENTS

**NOTE A - DESCRIPTION OF PLAN**

The following description of The Ambassador Holding Company 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General.** The Plan, which became effective July 1, 1994 and was most recently amended January 1, 2024, is a defined contribution plan covering employees of Ambassador Wellness Center LLC, The Ambassador Group Inc., and the wholly owned subsidiaries of The Ambassador Holding Company (collectively referred to as the Company) who are at least 20 years of age with three months of service including at least 416 hours. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Elective Contributions.** Participants may contribute up to 100% of their annual compensation in the form of employee elective contributions, including designated Roth contributions, subject to Internal Revenue Service limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers 7 mutual funds and 22 funds held in a collective trust as investment options for participants.

**Employer Contributions.** The Company's matching and profit sharing contributions are discretionary. For 2024, the Company matched 40% of the first 5% of employee elective contributions. There were no profit sharing contributions for 2024. During the year ended December 31, 2024, the total discretionary nonelective contribution was \$194,907.

**Participant Accounts.** Each participant's account is credited with the participant's elective contributions and Company matching contributions, as well as allocations of Company profit sharing contributions and Plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participant accounts are maintained by Matrix Trust Company, the Plan's custodian. All amounts in participant accounts are participant-directed.

**Vesting.** Participants are at all times 100% vested in the value of their elective contributions. Vesting for employer contributions is at 20% after two years of service, 40% after three years, 60% after four years, 80% after five years, and 100% after six years of service. Upon death, disability, or attainment of normal retirement age, participants become 100% vested.

**Notes Receivable from Participants.** Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested interest in the Plan. The loans are secured by the balance in the participant's account. The loan interest rate is set at 1% above the prime rate as defined. Principal and interest is paid ratably through bi-weekly payroll deductions.

**Payment of Benefits.** On termination of service due to death, disability, or retirement, a participant may elect to receive a single lump sum payment or a partial withdrawal. Installment payments are available only with respect to minimum required distributions. In-service distributions may be made to a participant who has not separated from service upon reaching age 62.

Termination of employment prior to normal retirement age requires distribution if the account balance does not exceed \$7,000. The participant can elect to receive: (a) a direct rollover to an IRA or another qualified retirement plan or (b) a payment in cash, subject to federal tax withholding and generally a penalty tax if under age 59½. If the account balance is less than \$7,000, the distribution will be paid in cash. If the vested account balance is greater than \$7,000, the participant may defer distribution until normal retirement age or further defer to age 73.

NOTES TO FINANCIAL STATEMENTS

**NOTE A - DESCRIPTION OF PLAN – CONTINUED**

**Payment of Benefits. Continued**

Hardship withdrawals are permitted for purposes specified by the Internal Revenue Code. Withdrawals cannot exceed the amount of financial need plus any amount necessary to pay taxes or penalties as a result of the withdrawal.

**Forfeitures.** Certain terminations of participation in the Plan cause the non-vested portion of the participant's account to be forfeited. Such forfeitures may be used to off-set employer contributions or Plan administrative expenses. Forfeited non-vested account balances were \$34,125 and \$15,612 at December 31, 2024 and 2023, respectively. Employer contributions for 2024 were reduced by \$15,612 of forfeited non-vested accounts.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting.** The financial statements of the Plan are prepared on the accrual basis of accounting.

**Investment Valuation and Income Recognition.** The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The Plan utilizes a framework to prioritize the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full-term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Transfers between levels shall occur at the actual date of the event or change in circumstances that caused the transfer. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs. See Note C for discussion of fair value measurements.

NOTES TO FINANCIAL STATEMENTS

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - CONTINUED**

Investments measured at net asset value (NAV) per share (or its equivalent using the practical expedient in FASB's fair value measurement guidance) are not required to be categorized in the fair value hierarchy.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants.** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

**Payment of Benefits.** Benefits are recorded when paid.

**Expenses.** Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Expenses incurred for investment advisory services and the administration of the Plan are the responsibility of the Plan. A portion of the fees related to recordkeeping of the Plan are shown on the statement of changes in net assets available for benefits. Other investment related expenses are included in net appreciation in fair value of investments.

**Use of Estimates.** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

**NOTE C - FAIR VALUE**

Following is a description of the valuation method used for assets measured at fair value. There have been no changes in the methodology used during the years ended December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled separate account:* Calculated as a unit value for each separate account investment based on the underlying assets, which include a mix of mutual funds, collective trusts, and managed accounts. All underlying investment options are valued daily. This daily price is considered the selling price for transfers and withdrawals and is calculated each day the principal market is open. The investment options are available for trading each day the principal market is open.

*Collective trust:* Collective trust accounts are valued based on each underlying contract's pro-rata share of the fair value of the securities in the underlying separate accounts in which the contracts participate. Units of the Fund are valued each day on which the New York Stock Exchange (NYSE) is open for trading in accordance with the valuation procedures established by the Trustee. The NAV per unit is computed by dividing the total assets of the Fund, less its liabilities, by the total number of units outstanding at the time of such computation. Investment income earned is reinvested in the Fund and included in the determination of unit values.

**NOTE C - FAIR VALUE - CONTINUED**

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE D - INVESTMENT AT CONTRACT VALUE**

The Plan held a traditional investment contract. This contract met the fully benefit-responsive investment contract criteria; therefore, was reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses. The following represents the contract value of the investment contract held by the Plan:

With traditional investment contracts, the Plan owned only the contract itself and not the underlying assets of the contract. Traditional investment contracts are designed to accrue interest based on crediting rates established by the contract issuers.

The traditional investment contract held by the Plan was a guaranteed investment contract. The contract issuer was contractually obligated to repay the principal and interest at a specified interest rate that was guaranteed to the Plan. The crediting rate was based on a formula established by the contract issuer but may not be less than zero percent. The crediting rate was reviewed on a monthly basis for resetting. The contract could not be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts was dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

**NOTE E - PARTY IN INTEREST TRANSACTIONS**

The Plan made direct payments of \$1,550 to United of Omaha Life Insurance Company for recordkeeping services during 2024. The Plan also made direct payments of \$10,053 to TBS Agency, Inc and \$8,723 to Ascensus LLC. Certain Plan investments are managed by Matrix Trust Company, the custodian. Other indirect investment management fees are included in net appreciation in fair value of the investments As described in note B, The Plan Sponsor pays directly any other fees related to the Plan's operations.

**NOTE F - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTES TO FINANCIAL STATEMENTS

**NOTE G - TAX STATUS**

The Plan has adopted the Non-Standardized Pre-Approved Profit Sharing Plan with CODA of Mutual of Omaha Insurance Company, which received a determination letter dated September 21, 2020 stating that the Plan was designed in accordance with the provisions of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified, and the related trust is tax-exempt.

For the years ended December 31, 2024 and 2023, the Plan had no tax liability on unrelated business activity. The Plan believes that it has appropriate support for any tax positions taken, and as such, does not have any uncertain tax positions that are material to the financial statements. The Plan's Federal returns for December 31, 2024, 2023, and 2022 are subject to examination by the IRS, generally for three years after they were filed.

**NOTE H - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
