I am writing on behalf of Healthcare Acc Services 401 (k) Plan, formerly sponsored by Healthcare Accounting Services, to formally request relief from the annual audit requirement under ERISA Section 103(a)(3)(A) for the plan year ending December 31, 2024.

During 2024, the Plan Sponsor experienced severe financial distress that led to the cessation of all business operations. As part of the wind-down process, the Sponsor sold or disposed of its assets and permanently closed its home office. In connection with this dissolution, the Plan distributed nearly all of its assets to participants in accordance with the Plan Document and applicable Department of Labor (DOL) rules and regulations.

As of December 31, 2024, the Plan retained approximately \$30,000 in net assets. The Plan Sponsor no longer has substantial assets or resources to fund an independent audit. Given the limited remaining assets and the near-complete distribution of Plan funds, we believe that an audit would not provide meaningful benefit to participants or stakeholders.

We respectfully request that the Department of Labor consider this letter as part of our effort to comply with applicable reporting requirements and to acknowledge the unique circumstances surrounding the Plan's termination.
