Note 1 - Plan Description

The following description of the Alonti 401(k) Plan (the Plan) is provided for general information only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan which was established on April 1, 2017 for eligible employees of Pepi Corporation (the plan administrator) and related employers (collectively, the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). An appointed employee of the Company serves as the trustee of the Plan. Empower Annuity Insurance Company of America (EAICA) serves as the asset custodian of the Plan's assets.

Eligibility

The Plan is provided for all eligible employees of the Company. Except for nonresident aliens and employees covered by a collective bargaining agreement, all other employees become eligible to participate in the Plan on the first day of the quarter coincident with or next following the completion of one year of service.

Contributions

Employee pre-tax and Roth contributions are made to the Plan by electing to contribute a portion of the employee's eligible compensation, as defined, subject to the maximum limits allowed by law. Eligible employees who have attained age 50 before the close of the plan year are eligible to make catch-up contributions subject to the limitations of the Internal Revenue Code (IRC).

The Company makes safe harbor matching contributions equal to 100% of each participant's contributions up to 3% of eligible compensation, as defined, plus 50% of each participant's contribution that exceeds 3% but does not exceed 5% of the participant's eligible compensation.

Vesting and Forfeitures

Participants are always fully vested in their contributions, the Company's safe harbor matching contributions and actual earnings thereon.

Forfeitures can be used to offset Company contributions or to pay plan expenses. As of December 31, 2024 and 2023, there were \$177 and \$146 available forfeitures, respectively. For the year ended December 31, 2024, no forfeitures were utilized to offset the Company's safe harbor contributions or to pay for plan expenses.

Participant Accounts

Separate accounts are maintained for each participant. Upon enrollment in the Plan, participants may direct the investment of their accounts into various investment options offered by the Plan. Participants may change their investment options daily. Under the Plan, earnings and losses are allocated to the participants' accounts daily based on their respective balances in the investments.

Benefit Payments

Distributions may be made to participants or their beneficiaries upon termination of employment, disability or death. The distribution may be made as a lump-sum payment, partial withdrawal, or transferred directly to an individual retirement account (IRA) or another qualified employer-sponsored plan. Under certain circumstances, plan participants may withdraw the value of their account while still employed for reasons of financial hardship, upon the attainment of age 59½ and for other such reasons. Upon termination, participants with an account balance of \$5,000 or less shall receive an automatic lump sum distribution from the Plan. Upon withdrawal from the Plan, participants may be subject to federal income taxes on contributions and income earned.

Notes Receivable from Participants

Loans to participants are not permitted by the Plan.

Note 2 - Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Investment Valuation and Income Recognition

Investments held by a defined contribution plan are required to be reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts, because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan invests in a fully benefit-responsive investment contract. See Note 5.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Net appreciation or depreciation in the fair value of investments includes realized gains or losses on investments sold during the year as well as the unrealized gains or losses on the investments held at the end of the year.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses incurred in connection with the operation of the Plan are paid by the Plan, unless paid by the Company, at its discretion.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and the disclosure of contingent assets and liabilities at the date of the financial statements. Accordingly, actual results could differ from those estimates.

Risks and Uncertainties

The Plan provides for investment in various investment securities. Investment securities, in general, are exposed to certain risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect participants' account balances and amounts reported in the financial statements.

Subsequent Events

Management of the Plan evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through July 16, 2025, which is the date the financial statements were available to be issued. See Note 11.

Note 3 - Certified Information

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator has obtained certifications from Empower Annuity Insurance Company of America (EAICA) as of December 31, 2024 and 2023, and for the year ended December 31, 2024, that all of the information provided is complete and accurate. Information included in the financial statements and accompanying notes to the financial statements as to investments, investment income, and all the related information in the supplemental schedule of assets (held at end of year), is presented in reliance solely upon these certifications.

The Plan's independent auditor did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements, the accompanying notes to the financial statements and the supplemental schedule (held at end of year).

Note 4 - Fair Value Measurements

GAAP provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in methodology used at December 31, 2024 and 2023.

Pooled Separate Accounts: These investments are valued at their net asset value (NAV) as reported by the issuer based on quoted market prices of the underlying investments, when available, net of certain expenses. The NAV is used as a practical expedient to estimate fair value. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The pooled separate accounts are measured using NAV as the practical expedient and have been excluded from the fair value hierarchy in accordance with GAAP. The following provides additional information for the pooled separate accounts as of December 31, 2024 and 2023.

- (g) The strategy of the specialty funds is to seek long-term capital appreciation and current income while investing at least 80% of its net assets in equity securities of real estate investment trusts (REITs), real estate companies, and other types of securities.

Note 5 - Investment Contract with Insurance Company

The plan invests in the MassMutual Guaranteed Interest Account, a general account product of EAICA offered through a group annuity contract which qualifies as a fully benefit-responsive investment contract.

As described in Note 2, the contract is included in the statements of net assets available for benefits at contract value, as reported to the plan. The value represents deposits made under the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer and may not be less than 1.00% or more than 3%. Such interest rates are reviewed on an annual basis for resetting.

Certain events limit the ability of the Plan to transact at contract value. Such events include: certain plan sponsor initiated events, which require at least 60 calendar days advance notice and termination of the contract by the plan sponsor for any reason other than full plan termination, which requires at least 90 days advance notice. Plan management does not believe the occurrence of any events that would limit the Plan's ability to transact at contract value with participants are probable.

Note 6 - Federal Income Tax

The non-standardized pre-approved plan document adopted by the Plan received an opinion letter from the Internal Revenue Service (IRS) dated November 30, 2020, stating that it was in compliance with the applicable requirements of the IRC. The pre-approved plan document has since been amended; however, the plan administrator believes that the Plan, through its adoption of the non-standardized pre-approved plan document, is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 - Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the plan document to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 8 - Party-in-Interest Transactions

The Plan's pooled separate accounts and benefit-responsive investment contract are offered through a group annuity contract with EAICA. The transactions relating to these investments qualify as party-in-interest transactions and are covered by an exemption from the "prohibited transaction" provisions of ERISA and the IRC.

Note 9 - Nonexempt Prohibited Transactions

As reported on supplemental Schedule H, Line 4a - Schedule of Delinquent Participant Contributions for the year ended December 31, 2024, \$5,548 of participant contributions were not remitted to the Plan within the time frame specified by the DOL's Regulation 29 CFR 2510.3-102, thus constituting a nonexempt prohibited transaction between the Plan and the Company for the year ended December 31, 2024. The participant contributions were remitted to the Plan prior to December 31, 2024. Lost earnings of \$28 were remitted to the Plan subsequent to December 31, 2024.
