Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Description of Plan

The following description of the Sonendo, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General

The Plan was adopted on January 1, 2015 as a defined-contribution plan covering substantially all employees of Sonendo, Inc. (the “Plan Sponsor” or the “Company”), and has been amended and restated effective July 1, 2022. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Eligibility

Employees of the Company who are over 21 years of age are eligible to participate in the Plan. Entry date is on first day of the month coinciding with or next following the date employees satisfy the eligibility requirements.

Contributions

Participants may contribute up to 90 percent of eligible compensation up to the statutory limit (\$23,000 for 2024). In addition, if the individual’s age is 50 or over during the calendar year, then the employee may be permitted to make an additional catch-up contribution of 90 percent of the participant’s compensation up to the statutory limit (\$7,500 for 2024). The Plan includes an automatic enrollment provision whereby, eligible employees automatically have 6% of their compensation withheld as an employee contribution unless they complete an affirmative election to elect a different percentage or elect not to participate at all.

Effective August 1, 2023, the Company suspended the discretionary employer matching contributions indefinitely. For the year ended December 31, 2024, the Company made no matching contributions to the Plan.

Participant Investment Options

Participants must direct their contributions from salary deferrals and their allocated share of employer discretionary matching contributions into investment options as made available and determined by the Plan Sponsor, which are more fully described in the Plan’s literature.

1. Description of Plan (continued)

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Company's discretionary matching contribution, investment earnings and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Participants are 100% vested in the Company's discretionary matching contributions after completing one year of service.

Notes Receivable from Participants

Participants may borrow from their fund accounts in amounts ranging from \$1,000 to \$50,000, but not in excess of 50 percent of the vested account balance. Notes are repaid at a reasonable rate of interest through payroll deductions within five years or, in the event the note is used to acquire a principal residence, the Plan Administrator may permit a longer repayment term. Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the Plan document.

Payment of Benefits

Upon termination of service, a participant may elect to receive benefits in a lump-sum distribution, on an installment basis, receive a rollover of the vested interest into another qualified plan, or defer receipt to a date no later than that prescribed by government regulation. Account withdrawals are permitted by participants who suffer certain financial hardships and meet criteria established by the Internal Revenue Code ("IRC"). Terminated participants with vested account balances of \$5,000 or less can be paid in a lump-sum cash amount.

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in conformity with accounting principles generally accepted in the United States ("GAAP").

2. Summary of Significant Accounting Policies

Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lower priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Accounting Standards Codification (“ASC”) 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the methodologies used to value the Plan’s investments:

Mutual funds: Such investments are valued at the daily closing price as reported by the respective fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. Therefore, they are deemed to be Level 1 investments.

Fair Value Measurements (continued)

Common/collective trust: The Plan's indirect investment in the common/collective trust is valued at the net unit value ("NUV") of units held by the Plan at year-end based on information reported in the common/collective trust's audited financial statements at year-end. The NUV is determined by the total contract value of fund assets divided by the total number of units of the fund owned. The Plan uses a practical expedient permitting a reporting entity to measure the fair value of certain investments using the net asset value per share (or its equivalent) of the investment. Because the Plan has an indirect investment in the contracts held by the common/collective trust, they are not considered fully benefit responsive.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the valuation methodologies used at December 31, 2024.

Investment Income Recognition

Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued daily. Dividends are recorded on the ex-dividend date. Realized gains and losses from security transactions are reported on the average cost method. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

3. Assets and Information Certified or Provided by Reliance Trust Company

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and supplemental schedule, that was prepared by or derived from information provided by Reliance Trust Company ("Reliance") and furnished to the Plan Administrator. The Plan Administrator has obtained certification from Reliance that information provided to the Plan Administrator by Reliance related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to investment information that appears throughout the financial statements and supplemental schedule.

3. **Assets and Information Certified or Provided by Reliance Trust Company (continued)**

There were no transfers in or out of Level 1, 2 or 3 during the year ended December 31, 2024. The nature, risks and investment objectives of the investment categories described in the tables above can be found in the Plan's enrollment literature.

Reliance also certified the completeness and accuracy of \$1,272,748 of net appreciation in fair value of mutual funds, \$383,402 of interest and dividends related to the Plan assets, \$114,942 of notes receivable from participants, and \$12,649 of interest income on notes receivable from participants for the year ended December 31, 2024.

4. **Tax Status**

Effective July 1, 2022, the Plan adopted a non-standardized pre-approved profit sharing/money purchase plan with CODA sponsored by Automatic Data Processing. The prototype plan has received an opinion letter from the Internal Revenue Service, dated October 6, 2020, as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan Administrator believes that the Plan has taken no uncertain tax positions that require adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

5. **Party-In-Interest Activity**

Certain administrative functions are performed by employees of the Company. No such officer or employee receives compensation from the Plan. The majority of the administrative expenses are paid by the Plan Sponsor. Notes receivable from participants are also considered permitted party-in-interest activities.

6. **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA and discontinue its contributions at any time. In the event of Plan termination, participants would become 100 percent vested in their accounts.
