We have performed audits of the accompanying financial statements of Wilhoit Properties, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). Notes to Financial Statements

Years Ended December 31, 2024 and 2023

1. Description of Plan

The following description of the Wilhoit Properties, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all employees of Wilhoit Properties, Inc. (the Company) and its subsidiaries who have completed 90 days of service and are age twenty-one or older. Participants who have completed 1,000 hours of service during the plan year and are age twenty-one or older are eligible to receive an employer contribution. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Each year, Participants may contribute up to 90% of their annual wages, subject to certain IRS limitations, as defined in the Plan, through pre-tax contributions or as after-tax Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may make discretionary profit sharing contributions to the Plan which is an amount determined by management equal to a percentage of the participant's eligible wages. The Company did not make a profit sharing contribution for years ended December 31, 2024 and 2023.

The Company made matching contributions to the Plan equal to 25% of the participant's elective salary reductions limited to 90% of eligible compensation. The Company made matching contributions to the Plan in the amount of \$100,514 and \$120,021 for the years ended December 31, 2024 and 2023, respectively. A participant must be employed on the last day of the year to be eligible for all employer contributions.

Participant accounts: Each participant's account is credited with (a) the participant's contribution, (b) the Company's matching contributions and profit sharing (if any), and (c) plan earnings. Net income and asset revaluations are allocated to each participant based upon the earnings of the investments selected by the participant. These are allocated based upon the participant's account balance. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately 100% vested in their voluntary contributions plus actual earnings thereon. Participants are fully vested in employer matching and profit sharing contributions upon reaching six years of service.

Investment options: Upon enrollment in the Plan, a participant may direct contributions into a variety of investment options.

Payment of benefits: Participants who terminate service and have account balances of \$5,000 or less may receive an automatic distribution of their vested balance at the Plan Sponsor's discretion.

Participants with account vested balances that exceed \$5,000 may elect to receive a lump-sum amount equal to the value of the vested interest in their account.

Forfeitures: Forfeitures may be used to pay plan expenses or to reduce future employer contributions. During the year ended December 31, 2024, forfeitures in the amount of \$30,204 were used to reduce employer matching contributions. No forfeitures were used during the year ended December 31, 2023. No additional unallocated forfeitures were available at December 31, 2024. At December 31, 2023, unallocated forfeitures amounted to \$17,088.

2. Summary of Accounting Policies

Basis of accounting: The Plan's policy is to prepare its financial statements on the accrual basis of accounting; consequently certain revenue and the related assets are recognized when earned rather than when received, and certain expenses are recognized when the obligation is incurred rather than when paid.

Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) in the fair value of investments.

Investment valuation and income recognition: Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Subsequent events: Management has evaluated subsequent events between the end of the most recent fiscal year end and September 15, 2025, the date the financial statements were available to be issued.

3. Risks & Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

4. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In

the event of plan termination, participants would become 100 percent vested in their employer contributions.

5. Certified Information

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (the custodian of the Plan).

6. Tax Status

The prototype plan document adopted by the Plan obtained its latest determination letter on October 6, 2020, in which the Internal Revenue Service stated that the prototype plan document, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code and, therefore, not subject to tax. The Plan has been amended since receiving the determination letter. The plan administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 – inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or

other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
