INDEPENDENT AUDITOR'S REPORT

1. Description of the Plan

The following description of the Quintairos, Prieto, Wood & Boyer, P.A. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a 401(k) Profit Sharing Plan covering all employees of Quintairos, Prieto, Wood & Boyer, P.A. (the “Company”) who are age 21 or older as of the Plan entry date and have completed six months of service. Effective January 1, 2024, employees become eligible to participate in the Plan immediately following the completion of their first payroll cycle. However, the Company matching contribution, as described below, continues to apply only after the Plan participant has completed six months of service and will begin on the first day of the month following such completion. The Plan is subject to certain provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Plan is administered by a third-party administrator (TPA) who serves at the discretion of the Company. The third-party administrator, Automatic Data Processing Retirement Services (“ADPRS”) is responsible for all matters, including, but not limited to, determining eligibility, rights to benefits, interpreting Plan documents, directing the Plan’s trustee and maintaining participant accounts. The Plan’s trustee is Reliance Trust Company.

Contributions

Each year, participants may contribute between 1% and 90% of pre-tax annual compensation subject to limitations, as defined by the Plan. In addition, participants over 50 years of age are permitted to make additional catch-up contributions of \$7,500. Starting in 2025, there is an enhanced catch-up contribution of \$11,250 for individuals 60-63 years of age, which must be made as Roth contributions if their pay exceeds the inflation-adjusted threshold, this threshold begins in 2026. Participants may also contribute amounts representing rollover distributions from other qualified plans. Upon enrollment, participants may direct their contributions to any of the Plan’s investment options. Additionally, participants may change their investment options at any time. Effective February 1, 2021, the Plan allows for Roth elective contributions. The Roth contributions are after-tax contributions and maintained in a separate account from pre-tax deferrals. Earnings on a participant’s Roth account accumulate on a tax-free basis. Plan participants may elect all traditional, all Roth, or a combination of traditional or Roth contributions.

The Company shall contribute an amount equal to a percentage of each participant’s compensation for each plan year as specified by resolution of the Company’s Board of Directors. The percentage for the employer contribution was 100% on the first 4% of employees’ compensation contributed for the year ended December 31, 2024. The Company from time to time may contribute additional amounts to the plan on a discretionary basis. Company contributions shall be calculated and allocated each pay period and invested in accordance with the participant’s directed investment options. Effective March 1, 2024 and 2023, the matching contribution will not exceed \$13,800 and \$13,200, respectively, per participant.

Participants’ Accounts

Each participant’s account is credited with the participant’s contributions and allocations of (a) the Company’s matching contribution and (b) Plan earnings or loss and (c) charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings,

account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions, and amounts rolled over into the Plan plus actual earnings thereon. Effective January 1, 2009, the Company adopted a Safe Harbor 401(k) Plan and, as a result, all the 2024 Company Safe Harbor contributions are immediately vested, which are separate from the Company's non-elective contribution. Vesting in the Company's non-elective contribution portion of their accounts plus actual earnings thereon is based on years of credited service. A participant is 100% vested after six years of credited service. In an event of Plan termination, all participants will be considered fully vested.

Payment of Benefits

On termination of service due to normal retirement, attainment of age 59½, death, or disability, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or a monthly annuity (fixed or variable) distributed in accordance with the Plan.

Notes Receivables from Participants

Participants may borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with the prime rate at the time the loan is effective, as published in the Wall Street Journal on the 14th of each month, plus one percentage point. Principal and interest are paid ratably through payroll deductions. Loan terms range from one to five years or up to 30 years for the purchase of a primary residence. A participant may not have more than one loan outstanding at a time.

Forfeited Accounts

As of December 31, 2024 and 2023, forfeited non-vested balances totaled \$5,861 and \$5,694, respectively. These amounts will be used to reduce future employer contributions or to pay Plan administrative expenses. During the year ended December 31, 2024, employer contributions were reduced by \$2,131 by forfeited non-vested balances, and Plan administrative expenses were not paid from such.

2. Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies

utilizing information provided by the investment adviser and custodian. See Note 8 for additional disclosures of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document. No allowance for credit losses was considered necessary as of December 31, 2024 and 2023.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

The administrative fees of the Plan are absorbed by the Plan, unless otherwise paid by the Company. Expenses paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants or fees on distributions to participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

Date of Management's Review

The Plan has evaluated subsequent events through September 9, 2025, which is the date the financial statements were available to be issued.

3. Information Prepared and Certified by Trustee

The Plan administrator has elected to have the audit performed in accordance with ERISA Section 103 (a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivables from participants held at December 31, 2024 and 2023, and net appreciation and depreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, the trustee of the Plan.

The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified as complete and accurate by the trustee.

4. Related Party Transactions and Party in Interest Transactions

The Plan uses third-party service providers to perform administrative functions. Transactions with such providers are considered an exempt party in interest transactions under ERISA. In addition, there were outstanding notes receivable from participants as of December 31, 2024 and 2023. The notes receivable from participants also qualifies as party in interest transactions.

5. Tax Status

The Plan is an adoption of the standardized prototype plan written by Automatic Data Processing (“ADP”) Prototype 401(k) and Profit-Sharing Plan. The Internal Revenue Service (“IRS”) has determined and informed ADP by a letter dated October 6, 2020, that the Plan and the related trust are designed in accordance with applicable section of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. As of December 31, 2024 and 2023, there are no uncertain tax positions taken that would require recognition or disclosure in the financial statements. The Plan is subject to routine audits by the taxing jurisdictions; however, there are currently no audits for any tax periods in process.

6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances, and the amounts reported in the statements of net assets available for plan benefits.

7. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

8. Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 – Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission ("SEC"). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable value common/collective trust fund – The Plan invest in the Invesco Stable Asset Fund, which is a collective trust that consists primarily of synthetic guaranteed investment contracts, which are a combination of a portfolio of individual assets and wrap contracts typically issued by a financial institution or insurance company that provides that participant transactions are executed at contract value. Investments in common/collective trust funds are reported at NAV, which is used as a practical expedient to estimate fair value in the statement of net assets available for benefits.

Certain events limit the ability of the stable value fund to transact at contract value with the issuer. These events include plant closings, layoffs, plan termination, bankruptcy or reorganization, merger, early retirement incentive programs, and tax disqualification of a trust. In addition, there are certain events that would permit a wrapper contract issuer to terminate a contract upon short notice. Such events include the loss of qualified status, material breaches or responsibilities that are not cured, or material and adverse changes to the provisions. The Plan administrator does not believe that the occurrence of any such event is probable.

The Plan is required to give 12-month irrevocable written notice of its intention to redeem all or a portion of its participation in the Invesco Stable Asset Trust Fund. The Plan has no unfunded commitments with the Invesco Stable Asset Trust as of December 31, 2024 and 2023.

The plan will continue to treat the DDL as an outstanding loan, while the plan's Form 5500 will exclude the DDL from the assets reported.

10. Subsequent Events – Roth Conversion Feature

Effective August 1, 2025, the Plan was amended to allow in-plan Roth conversions. Under this provision, participants may elect to convert eligible pre-tax contributions, including employee deferrals and employer contributions, to designated Roth contributions within the Plan. Employer contributions are eligible for Roth conversion only if the participant is 100% vested in those contributions at the time of conversion.

Converted amounts are included in the participant's gross income in the year of conversion, to the extent such amounts were not previously taxed, and are subject to applicable IRS rules and restrictions. ADP RS will report the taxable portion of the conversion on Form 1099-R to the participants. Participants are advised to consult with their tax advisors prior to making a Roth conversion election.
