Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of **The Anderson Company, L.L.C. 401(k) Retirement Plan**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits (modified cash basis) for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of **The Anderson Company, L.L.C. 401(k) Retirement Plan's** financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of **The Anderson Company, L.L.C. 401(k) Retirement Plan** and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. Emphasis of Matter – Basis of Accounting

We draw attention to Note 2 to the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting as described in Note 2, and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Note 1 – Description of The Plan

The following description of the Anderson Company, LLC 401(k) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan formed on January 1, 1999 and subsequently amended and restated effective January 1, 2016. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Eligibility

Employees of The Anderson Company, LLC (the “Company”) are eligible to participate in the Plan upon completing one year of service and reaching the age of 21. Eligible employees begin participating on the first day after which the employee meets eligibility requirements set forth in the plan document.

Contributions

Participants may elect to contribute a percentage of their pre-tax annual compensation, as defined in the Plan. The Plan also includes a Roth Elective Deferral option, whereby participants may elect to contribute after-tax dollars of their compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Effective January 1, 2023, the Plan was amended for the Company to make safe harbor matching contributions in an amount equal to the sum of 100 % of the amount of the participant's elective deferrals that do not exceed 3% of the participant's compensation, plus 50% of the amount of the participant's elective deferrals that exceed 3% of the participant's compensation but do not exceed 5% of the participant's compensation. The Company may also make discretionary profit-sharing contributions. The Company made no discretionary profit-sharing contributions in 2024. Contributions are subject to certain Internal Revenue Service (“IRS”) limitations.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, employer matching and nonelective contributions, and an allocation of earnings (losses) based on the performance of the investment account(s) selected by the participant and charged with an allocation of administrative expenses. Participants choose the fund(s) in which their contributions are invested. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investment Options

Participants may select from various investment options which are maintained by Reliance Trust Company (the “Trustee”) as of December 31, 2024 and December 31, 2023. The Plan is intended to qualify as a participant-directed plan under Section 404(c) of ERISA. A participant may change investment allocations

at any time.

Vesting

Participants are vested immediately in their elective contributions, qualified non-elective contributions, earnings thereon, and safe harbor match contributions. Participants become vested in discretionary employer matching contributions based upon the following schedule:

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum of the lesser of 50 percent of their vested account balance or \$50,000. Loan terms range up to five years. The loans are secured by the balance in the borrower's account and shall bear an interest rate equal to the bank prime rate at the origination date plus 1 percent. At December 31, 2024 and 2023, the interest rates for outstanding loans range from 4.25 percent to 9.50 percent for both years. Participants may pre-pay the full balance of the loan without penalty and are permitted to have one loan outstanding at a time. Principal and interest are generally paid through payroll deductions, however, the administrator may allow for another method of repayment.

Payment of Benefits

The Plan provides benefit payments to participants upon termination of employment, disability, hardship, death, attainment of age 59½, retirement, or plan termination. Upon each event, a participant may elect to receive payment in the form of either a lump sum or installment payment. Terminated participants with account balances less than \$5,000 will automatically receive a lump sum distribution or have their account balance rolled over to an individual retirement plan selected by the plan administrator.

Forfeitures

At its discretion, the Company may use forfeited non-vested accounts to pay plan expenses, which would otherwise be payable by the Company, or to reduce future Company matching contributions. During the year ended December 31, 2024, the Plan applied \$6,578 in forfeitures to reduce employer contributions.

At December 31, 2024 and 2023, there were \$10 of unapplied forfeitures for both years.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in their accounts.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The Plan utilizes a modified cash basis of accounting for financial reporting purposes, whereby additions are recognized when received and deductions are recognized when paid, except that investments include adjustments to their fair value at the end of the plan year and participant loans are reflected as notes receivable from participants. This method of accounting differs from accounting principles generally accepted in the United States of America (“U.S. GAAP”), which requires that additions be recognized when earned and deductions other than benefit payments be recognized when incurred. The preparation of the financial statements in conformity with a modified cash basis of accounting requires the Plan’s management to use estimates and assumptions that affect the accompanying modified cash basis financial statements and disclosures. Actual results could differ from these estimates.

Investment Valuation and Income Recognition

The Plan’s investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Refer to Note 4 for details on inputs, valuation techniques, and fair value measurement levels within the fair value hierarchy for each investment.

Net appreciation in fair value of investments included in the accompanying modified cash basis statement of changes in net assets available for benefits includes realized gains or losses from the sale of investments and unrealized appreciation or depreciation in fair value of investments, and fees charged by the Trustee for certain recordkeeping and investment management expenses. Net unrealized appreciation or depreciation in fair value of investments represents the net change in the fair value of the investments held during the period. The net realized gains or losses on the sale of investments represent the difference between the sale proceeds and the fair value of the investment as of the beginning of the period or the cost of the investment if purchased during the year.

Purchases and sales of investments are recorded on a trade-date basis. Interest and dividend income are recorded when received.

Notes Receivable from Participants

Participant loans are classified as notes receivable from participants, which are segregated from plan investments and measured at their unpaid principal balance plus any accrued but unpaid interest.

Benefits Paid

Benefit payments are recorded when paid.

Expenses

The Company pays certain administrative expenses of the Plan except those expenses that are charged directly to participant accounts by the Trustee. Administrative expenses paid directly by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments on the accompanying statement of changes in net assets available for benefits.

Risks and Uncertainties

Investment securities are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying modified cash basis statements of net assets available for benefits.

Subsequent Events

The Plan has evaluated subsequent events through September 11, 2025, the date these modified cash basis financial statements were available to be issued.

Note 3 – Information Certified by the Trustee

The following is a summary of the asset information as of December 31, 2024 and 2023 and for the year ended December 31, 2024, included throughout the Plan's modified cash basis financial statements and supplemental schedule that were prepared or derived from information provided by Reliance Trust Company, the trustee of the Plan, and furnished to the Plan Administrator. The Trustee also certified to the completeness and accuracy of \$648,239 in net appreciation in fair value of investments and \$394,482 of interest and dividend income related to the aforementioned Plan assets for the year ended December 31, 2024.

Note 4 – Fair Value Measurements

The Plan follows U.S. GAAP for measuring, reporting, and disclosing fair value. These principles apply to all assets and liabilities that are measured, reported and/or disclosed on a fair value basis.

As defined in the accounting standards, fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value hierarchy ranks the quality and reliability of the information used to determine fair values. Assets and liabilities measured, reported, and/or disclosed at fair value will be classified and disclosed in one of the following three categories:

Level 1 - Inputs to the valuation methodology are unadjusted quoted market prices for identical assets in active markets that the Plan has the ability to access.

Level 2 - Observable market based inputs or inputs that are corroborated by market data. Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 - Inputs that are unobservable and not corroborated by market data.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The plan sponsor is responsible for the determination of fair value. Accordingly, the plan sponsor performs periodic analysis on the prices received from the pricing services used to determine whether the prices are reasonable estimates of fair value. As a result of these reviews, the plan sponsor has not historically adjusted the prices obtained from the pricing services.

The following are the major categories of investments measured at fair value on a recurring basis during the years ended December 31, 2024 and 2023, using quoted prices in active markets for identical assets (Level 1); significant other observable inputs (Level 2); and significant unobservable inputs (Level 3). There have been no changes in the methodologies used in December 31, 2024 and 2023.

Money Market and Mutual Funds

The fair values of the money market and mutual funds are based on quoted market prices of the shares held by the Plan at year end. Accordingly, these fair value measurements are classified as having used Level 1 inputs.

Common Collective Trust

The Plan's investment in the common collective trust determines fair value using the net asset value ("NAV") as a practical expedient, which is determined based on the underlying NAV of the common collective trust. This fund invests primarily in investment contracts issued by insurance companies ("GICS"). Accordingly, these investments are not included within the fair value hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 – Party-in-Interest Transactions

The common collective trust consists of separately managed investment portfolios directed by Reliance Trust Company. Reliance Trust Company is the trustee as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. The Plan pays the Trustee for certain administrative and transactional fees. The Plan made direct payments in the amount of \$4,675 for the year ended December 31, 2024. Other Trustee fees were paid directly by the Company. Additionally, the Plan issues loans to participants, which are secured by the participant's account balance. These transactions qualify as exempt party-in-interest transactions.

Note 6 – Income Tax Status

The Plan has received a favorable opinion letter from the Internal Revenue Service dated October 6, 2020, which states that the prototype plan is qualified under section 401(a) of the IRC and, therefore, the related trust is intended to be exempt from federal income taxes under the applicable sections of the IRC. The Plan has been amended since the date of this opinion letter; however, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's modified cash basis financial statements.
