We encountered no significant difficulties in dealing with management relating to the performance of the audit.

In the normal course of our professional association with Senseonics Incorporated 401(k) Plan, we generally discuss a variety of matters, including the application of accounting principles and auditing standards, significant events or transactions that occurred during the year, business conditions affecting the plan, and business plans and strategies that may affect the risks of material misstatement.

None of the matters discussed resulted in a condition to our retention as Senseonics Incorporated 401(k) Plan's auditors.


Other Matters
