Opinion

The following description of the American Systems Corporation Employee Stock Ownership Plan (the "Plan") provides only general information. Participants should refer to the Plan Documents and amendments for a more complete description of the Plan's provisions.

General

American Systems Corporation (the "Company") established the Plan effective as of January 1, 1990. The Plan was most recently amended and restated effective January 1, 2024. The Plan operates as an employee stock ownership plan (the "ESOP") and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code ("IRC") of 1986, as amended, and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. The Plan is administered by a committee appointed by the Company's Board of Directors. An independent third party is the Plan's Trustee.

Eligibility

Employees of the Company are eligible for participation based on their benefit classification. Eligible employees commence participation in the Plan as of the beginning of the first Plan Year, during which the employee completes 501 hours of service and attains age 18.

Participant's accounts

Each participant's account is credited with the participant's allocations of the Company's common stock ("Company Common Stock"), forfeiture amounts of terminated participants, recycled shares from cash contributions less plan expenses, and net earnings/losses of the Plan (if applicable). Allocation of Company Common Stock, forfeitures, recycled shares, and net earnings/losses are based on eligible compensation as defined by the Plan.

Vesting

A year of service is a Plan Year, during which an employee has completed at least 1,000 hours of service. For participants employed with the Company on or after December 31, 2016, the vesting schedule is as follows:

Company contributions

The Company contributes to the Plan in the form of either cash or Company Common Stock. Beginning in the 2012 Plan Year, the Board of Directors elected to increase the contribution of Company Common Stock or cash from 7% to 8% of eligible compensation for all active participants. The Board of Directors further approved a special additional 4% contribution for the 2024 Plan Year in celebration of the company's 50th anniversary year for active eligible employees as of 1/1/2025. During 2024, the contribution amounted to \$20,355,340 and \$2,060,737 in the form of Company Common Stock and cash, respectively, resulting in the contribution of 272,783 new shares and 23,902 recycled shares within the Plan.

Investment earnings from stock redemption

In applicable years, investment earnings from stock redemptions represents the difference between the number of shares purchased by the Plan from participants based upon the December 31ST stock valuation and the number of shares sold to the Company based upon the June 1st stock valuation to the final transaction date. The differential represents the Plan's need to sell a fewer number of shares to the Company than were repurchased from participants due to the increase in stock price during the period. This differential is recorded as investment earnings to the Plan and, after the earnings amount used to pay plan expenses is deducted, the remaining amount is reallocated to participants based on eligible compensation in the Plan Year. As the Company repurchased shares from the Plan, the purchase price is based upon the higher of the previous December 31st or June 1st stock valuations and therefore would not record a loss should the stock of the Company decline between valuations. In 2024 and 2023, the Company did not execute a mid-year purchase of shares from the ESOP trust.

Payment of benefits

Upon retirement, death, or disability (as defined under the Plan or the related Distribution Policy), distributions to a participant or beneficiary commence in the year following such event. Lump, sum distributions occur for vested balances up to \$7,000 provided the participant was terminated in the preceding year or earlier. Otherwise, distributions generally commence in the sixth year following termination of employment. Distributions from the Plan can be made in the form of either cash or stock.

Forfeited accounts

Net forfeitures of non-vested account balances are reallocated to participants based on the relation of the participant's eligible compensation to total compensation. During the current year, net stock forfeitures of 36,241 shares were reallocated to participants as of December 31, 2024.

Voting rights

In certain limited situations, participants are entitled to exercise voting rights attributable to the shares allocated to their account by directing the Trustee as to the manner in which to vote those shares (including fractional shares). The Trustee votes all shares that are not allocated to participant accounts. In other situations, the Trustee votes all shares in the Plan. The ESOP Administrative Committee directs the Trustee on votes pertaining to Board of Director appointments.

Put option

Under federal income tax regulations, the Company Common Stock that is held by the Plan and its participants includes a put option. Additionally, regulations require and have been met whereby the Company Common Stock is not readily tradable on an established market and is subject to trading limitations.

The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock at the previous year end. The put option shall permit the participant to sell shares to the Company at any time during one option period, described fully in the Plan document. The payment for any Company Common Stock shall be made in a lump sum or in substantially equal, annual installments over a period not to exceed five years, with proper consideration of interest payable made by the Company. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Notwithstanding the above, the Plan may distribute a participant's Company Common Stock account entirely in cash during any period that the charter or by-laws of the Company restrict the ownership of substantially all of the outstanding Company Common Stock to the Plan and current employees of the Company. The Amended and Restated Articles of Incorporation of American Systems Corporation dated July 1, 2020 restrict the ownership and transfer of Company Common Stock. Alternatively, Company Common Stock may be distributed subject to the requirement that it be immediately resold to the Company.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company Common Stock into investments which are more diversified. Participants who are at least 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of shares allocated to his/her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. Participants who elect to diversify receive a cash or stock distributions which is eligible for rollover to a qualified plan or an individual retirement account. Effective January 1, 2023, new diversification eligibility is limited to active participants.

Operating expenses

The ESOP allows for certain operating expenses to be covered by plan assets. Additional expenses incurred by the Plan are paid by the Company.

Note 2 - Summary of significant accounting policies

Basis of accounting

The Plan utilizes the accrual method of accounting for financial reporting purposes, whereby revenue or additions are recognized when earned or due, and expenses or deductions are recognized when incurred. Benefit payments are recorded when paid.

Cash

The Plan periodically maintains cash accounts with certain financial institutions in amounts which at times may exceed the Federal Deposit Insurance Corporation insurance limitation.

Investment and income valuations

The Company Common Stock is valued at fair value. Fair value is determined by the ESOP Trustee based on an independent appraisal, which is conducted no less frequently than annually. This appraisal was based upon a combination of the market and income valuation techniques consistent with prior years. The appraiser took into account historical and projected cash flow and net income, return on assets, return on equity, market comparables and fair value of Company assets and liabilities.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Company Common Stock was valued at \$80.51 and \$74.33 per share at December 31, 2024 and 2023, respectively. Shares held by the Plan amounted to 4,204,833 and 4,457,349 with an aggregate cost basis of \$253,187,664 and \$240,049,204 at December 31, 2024 and 2023, respectively.

Purchases and sales of securities are recorded on a trade-date basis. Realized gains and losses from security transactions are reported on the average cost method.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits, and changes therein. Actual results could differ from those estimates.

Risk and uncertainties

The Plan's principal asset is Company Common Stock. This investment is exposed to various risks such as interest rate, market and the success of the Company. Due to the level of risk associated with this investment including uncertainty related to changes in the value of the investment, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Subsequent events

Material subsequent events have been considered for disclosure and recognition in these financial statements through September 8, 2025, the date the financial statements were issued.

During the year ended December 31, 2024, the Plan's investment in Company Common Stock appreciated in value by \$25,906,489.

Note 4 - Fair value

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") issued Accounting Standards Codification 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

In accordance with FASB Accounting Standards Update ("ASU") No. 2013-09, *Fair Value Measurement (Topic 820): Deferral of the Effective Date of Certain Disclosures for Nonpublic Employee Benefit Plans in Update No. 2011-04*, the Plan has chosen to defer the disclosure of the quantitative unobservable input table for the years ended December 31, 2024 and 2023.

Note 5 - Administration of Plan assets

The Plan's assets, which consist of Company Common Stock and for limited periods of time-cash, are held by the Trustee of the Plan. Company contributions are held and managed by the Trustee, who invests cash received and makes distributions to participants.

The Company and the ESOP pay administrative expenses incidental to the operation of the Plan. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee received compensation from the Plan during the year ended December 31, 2024.

Note 6 - Tax status

The Plan obtained its latest determination letter on November 8, 2013, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 - Plan termination

Although it has not expressed any intent to do so, the Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon such termination of the Plan, each participant will become 100% vested in their account balances unless the ESOP is replaced by contributions to a comparable plan. Upon termination, the Company will decide whether benefits will be distributed immediately or deferred until a later date.

Note 8 - Related party transactions

The Company is the sponsor of the Plan. All Plan assets are shares of Company Common Stock; therefore, these qualify as party-in-interest transactions.

During the year ended December 31, 2024, the Company redeemed 525,298 shares from the Plan at a purchase price of \$74.33 per share. Additionally, the Company recycled 23,902 shares at \$74.33 directly from participants.
