INDEPENDENT AUDITOR’S REPORT

***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of the Federated Hermes, Inc. Employees Profit Sharing/401(k) Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor’s Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- the information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of these financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

(1) DESCRIPTION OF THE PLAN

(A) GENERAL

The Federated Hermes, Inc. Employees Profit Sharing/401(k) Plan (the Plan), is sponsored by Federated Hermes, Inc. (Federated Hermes), for the benefit of current and former employees of Federated Hermes and its domestic subsidiaries (Employee, Employees, Participant or Participants). The Plan trustee, Empower Trust Company, LLC (the Trustee) has been appointed by Federated Hermes' Board of Directors (the Board). The recordkeeping and custodial functions are performed by Empower Retirement, a division of Great-West Life & Annuity Insurance Company. A brief description of the provisions of the Plan is contained in the Summary Plan Description distributed to Employees. Participants should refer to this document and the Plan document for a more complete description of the Plan's provisions.

(B) PROFIT SHARING PLAN

The Profit Sharing Plan component is a defined contribution plan to which Federated Hermes may make contributions as authorized by the Board. Federated Hermes made no contributions to the Profit Sharing Plan in 2024. An Employee becomes eligible for participation in the Profit Sharing Plan if they are employed on the last day of the year and have worked at least 500 hours during that year. Federated Hermes' contributions are allocated to the accounts of Participants on the basis of a uniform percentage of each Participant's Plan-defined compensation for the Plan year. Earnings are allocated to the accounts of the Participants based upon the average daily balances for the specific periods and investments to which the respective earnings relate.

(C) 401(k) PLAN

The 401(k) Plan component is a voluntary employee salary deferral program pursuant to Section 401(k) of the Internal Revenue Code (IRC). Generally, an Employee becomes eligible for participation in the 401(k) Plan upon hire. All Employees may make contributions upon enrollment with the Plan's recordkeeper, Empower Retirement, beginning on the first day of the month following their date of hire with the exception of Employees who are expected to work less than 910 hours in a calendar year. Such Employees become eligible to participate in the Plan as of the first day of the month following the date on which the Employee first works 910 hours or more in a calendar year.

Employee salary deferral contributions are made at a rate of 1% to 50% of an Employee's annual compensation, as defined in the Plan document, not to exceed the contribution limits prescribed by the IRC. In 2024, there was a pre-tax limit of \$23,000 with an additional \$7,500 limit on catch-up contributions for Participants who attained age 50 by the end of the calendar year. An Employee may choose to contribute their annual salary deferral contribution as well as the annual catch-up contribution to the pre-tax 401(k) option, the after-tax Roth 401(k) option or a combination of both.

At its discretion, Federated Hermes may make employer matching contributions to the Plan. These matching contributions are made twice a month in an amount determined by Federated Hermes. In 2024, this amount was equal to 100% of the first 4% of compensation and 50% of the next 2% of compensation that each Participant contributed for a total possible match of 5%. In 2024, Federated Hermes made employer matching contributions of \$7.5 million to the Plan. Forfeitures of unvested matching contributions are used to offset future matching contributions and totaled \$250,561 for the year ended December 31, 2024.

In certain situations, a Participant may borrow against their 401(k) Plan account at a fixed interest rate equal to the prime rate plus one percent. A Participant may borrow a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance, per loan. The maximum repayment period is five years. Loan repayments and interest are reinvested using the same allocation methodology as the Participant's salary deferral contributions.

(D) DIRECTING INVESTMENTS

Under the Plan, Participants have the ability to direct the investments of their Profit Sharing/401(k) accounts into any of the mutual funds or collective investment funds offered by the Plan (collectively, Funds). All Federated Hermes Funds offered by the Plan (affiliated registered investment companies and an affiliated collective investment fund) are advised or managed by subsidiaries of Federated Hermes. Participants cannot invest directly into Federated Hermes, Inc. Class B Common Stock (the Stock); however, Participants with existing Plan investment balances in the Stock may direct account balances from the Stock to Funds offered by the Plan, subject to certain black-out periods. Participants also have the option of directing investments into other collective investment funds including State Street S&P 500 Index Securities Lending Series Fund Class II and BNYM Mellon SL Mid Cap Stock Index Fund managed by State Street Global Advisors Trust Company and The Bank of New York Mellon, respectively.

Additionally, participants have the option of directing investments into the Schwab Personal Choice Retirement Account (Schwab PCRA). This option is a self-directed brokerage account offered through Charles Schwab & Co., Inc. and investment options include primarily mutual funds. The Participants' contributions and Federated Hermes' matching contributions are invested based on Participant investment elections.

(E) VESTING

Federated Hermes' employer matching contributions vest based on the following schedule:

A Year of Service is generally each year during which an Employee is credited with 1,000 or more hours of service. Employees are immediately vested in their 401(k) Plan salary deferral contributions and any rollover contributions.

(F) PLAN TERMINATION

Federated Hermes anticipates that the Plan will continue without interruption but reserves the right to discontinue the Plan. In the event that such discontinuance results in the termination of the Plan, the rights of Participants to their accounts and benefits under the Plan shall become 100% vested and the Trustee shall liquidate the assets held in the trust and distribute the net assets to each Participant.

(2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

(A) BASIS OF PRESENTATION

The accompanying financial statements have been prepared on the accrual basis of accounting in conformity with U.S. generally accepted accounting principles (U.S. GAAP). In preparing the financial statements, management is required to make estimates that affect the amounts reported in the financial statements, accompanying notes and supplemental schedule. Actual results may differ from those estimates, and such differences may be material to the financial statements.

(B) VALUATION OF INVESTMENTS

Investments held by the Plan are stated at fair value. For the registered investment companies (affiliated registered investment companies and Schwab PCRA) held by the Plan, fair value is determined by the net asset value calculated on the last business day of the Plan year. For the Stock, fair value is determined by the closing price per share on the New York Stock Exchange on the last business day of the Plan year.

The affiliated collective investment fund, the Federated Hermes Capital Preservation Fund (CPF), invests in fully benefit-responsive investment contracts. Investment contracts held by a defined contribution plan are required to be reported at fair value. CPF is designed to deliver safety and stability by preserving principal and accumulating earnings. CPF typically invests in guaranteed investment contracts (GICs), separate account GICs and synthetic GICs. Participant-directed redemptions have no restrictions. The fair value of CPF is based on the net asset value as determined by Federated Hermes. Units held in the affiliated collective investment fund are valued at the unit value as reported by the investment manager as of the last business day of the Plan year.

The collective investment funds are valued based on the units of the collective investment funds held by the Plan at year-end multiplied by the respective unit value. The unit values of the collective investment funds are based on significant observable inputs, although they are not based on quoted market prices in an active market. The Plan's investment in the collective investment funds is not subject to any withdrawal or redemption restrictions.

Any unrealized appreciation or depreciation, as well as realized gains or losses for the year, are reflected as net appreciation or depreciation in fair value of investments as shown on the Statement of Changes in Net Assets Available for Benefits. Dividends are recorded on the ex-dividend date. Interest is accrued on a daily basis. Purchases and sales of securities are recorded on a trade-date basis.

(C) PAYMENT OF BENEFITS

Participants may elect to have their vested account balance paid to them following termination of employment, death, total disability, reaching age 59½ or retirement, at any time of the year, with the exception of the Stock, which is subject to certain black-out periods during the year. Benefits are recorded when paid.

(D) NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants represent Participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest rates as of December 31, 2024 range from 4.25% to 9.50% with maturity dates through 2029. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses have been recorded as of December 31, 2024 or 2023. If a Participant ceases to make loan repayments and the plan administrator deems the Participant loan to be a distribution, the Participant loan balance is eliminated and a benefit payment is recorded.

(3) FAIR VALUE MEASUREMENTS

Fair value is the price that would be received to sell an asset or the price that would be paid to transfer a liability as of the measurement date. A fair-value reporting hierarchy exists for disclosure of fair value measurements based on the observability of the inputs to the valuation of financial assets and liabilities. The levels are:

Level 1 – Quoted prices for identical instruments in active markets. Level 1 assets may include equity and debt securities that are traded in an active exchange market, including shares of mutual funds.

(4) TRUSTEE CERTIFICATION

Management has elected the method of annual reporting permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. (5) TAX STATUS OF THE PLAN

The Plan has received a determination letter from the Internal Revenue Service (IRS) dated May 20, 2014, stating that the Plan is qualified under Section 401(a) of the IRC and, therefore, the related trust is exempt from taxation. Subsequent to this determination by the IRS, the Plan was amended. Pursuant to the 2014 determination letter, the Plan is required at all times to operate in conformity with the IRC to maintain its qualified status. The Plan administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC, and therefore believes the Plan, as amended, is qualified and the related trust is tax-exempt.

(5) TAX STATUS OF THE PLAN (continued)

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain tax positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods. Management believes that the Plan is no longer subject to income tax examinations for years prior to 2021.

(6) TRANSACTIONS WITH PARTIES-IN-INTEREST

Investments of the Plan are made primarily in Funds managed by Federated Hermes or in the Stock. Federated Hermes receives revenue from the Funds it manages. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transaction rules under ERISA. During 2024, the Plan received \$528,936 in dividends from the Stock. The investments provided through the Schwab PCRA offers investment elections in various mutual funds, including certain Federated Hermes funds not directly available through the Plan.

The Plan's administrative functions are performed by officers or employees of Federated Hermes at no cost to the Plan. In 2024, audit and consulting expenses were paid by Federated Hermes and were subsequently reimbursed by the Plan. All trustee, recordkeeping and custodial services are billed to Participants on a quarterly basis. These fees are included in Administrative expenses on the Statement of Changes in Net Assets Available for Benefits.

(7) RISKS AND UNCERTAINTIES

At the direction of the Participant, the Plan invests in various investment securities, including stocks, mutual funds, and collective investment funds. Investment securities are exposed to various risks, such as interest rates, market volatility and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect Participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

(8) COMMITMENTS AND CONTINGENCIES

The Plan is subject to various claims and legal proceedings covering a wide range of matters that arise in the ordinary course of operating the Plan. Management believes that any liability that may result from the resolution of these matters will not have a material effect on the Plan.

(9) SUBSEQUENT EVENTS

Management has evaluated subsequent events through August 22, 2025, the date these financial statements were available to be issued, and identified Section 109 of the SECURE Act 2.0 was implemented, allowing for a higher catch-up limit to apply at ages 60-63.

Management did not identify any additional events requiring recording or additional disclosure.
