## Independent Auditor's Report

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the New York Independent System Operator, Inc. Health and Welfare Benefits Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## Note 1 - Description of the Plan

The New York Independent System Operator, Inc. Health and Welfare Benefits Plan (Plan) and the New York Independent System Operator Health and Welfare Benefits Trust (Trust) were established effective January 1, 2010. The Plan is sponsored by New York Independent System Operator, Inc. (NYISO) and was most recently restated effective January 1, 2014.

The following brief description of the Plan is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

### *a. General*

The Plan is an employee welfare benefits plan providing certain insured and self-insured medical benefits to former employees of NYISO, and to the extent available, their eligible dependents. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan assets are held by Comerica Bank, the Trustee of the Plan, who invests cash received and income from investments based on written instructions from NYISO. The Retirement Board is responsible for administration of the Plan, recommending investment policy to the Board of Directors and monitoring investment performance. The Retirement Board reports to NYISO's Board of Directors.

### *b. Benefits*

The Plan provides medical benefits to retired employees and their spouses and dependents. NYISO employees who have completed ten or more years of service (five or more years of service if hired prior to January 1, 2005) and who retired from NYISO on or after age 55, are eligible for Plan benefits. Medical coverage becomes secondary upon Medicare eligibility. The Plan's medical coverage also includes prescription drug coverage.

### *c. Contributions*

The Plan provides for participant contributions based upon years of service with NYISO. The percentage of premiums paid by participants ranges from 50.00% to 77.50% for retired employees and 75.00% to 87.50% for eligible dependents. Contributions of the participants and those funded by the Plan Sponsor, pursuant to the Plan document, are held in the Trust.

## Note 2 - Summary of Significant Accounting Policies

### *a. Basis of Accounting*

The accompanying financial statements have been prepared in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) for health and welfare benefit plans.

### *b. Estimates*

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein; and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### *c. Investment Valuation and Income Recognition*

Investments are reported at fair value which is defined as the price that would be received to sell an asset in an orderly transaction between market participants on the measurement date. The Plan Trustee determines the Plan's valuation policies utilizing information provided by the investment advisors.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### *d. Actuarial Present Value of Accumulated Plan Benefits*

The postretirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed to employee service rendered to the date of the financial statements (Note 5). Postretirement benefits include future benefits expected to be paid to or for: (1) currently retired employees and their dependents; and (2) active employees and their dependents after retirement from service with NYISO. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims cost per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements, such as those for death, disability, withdrawal, and retirement) between the valuation date and the expected date of payment. The significant actuarial assumptions used in the valuation as of January 1, 2024, are as follows:

Mortality	Pri-2012 Mortality Table for employees and healthy annuitants, headcount weighted, and projected on a generational basis using MP-2021 mortality improvement scale.
Retirement Age	Age 55 with 10 years of service (five years for hires before January 1, 2005). The retirement rates used in the valuation vary by age.
Discount Rate	5.00% (2024) and 5.25% (2023) per annum.
Health Care Cost Trend Rate	2024: Initial pre-Medicare health care cost trend rate is 7.50% decreasing to an ultimate of 4.00% in 2038; initial post-Medicare health care cost trend is 8.00% decreasing to an ultimate of 4.00% in 2040.

### *d. Actuarial Present Value of Accumulated Plan Benefits - Continued*

#### Health Care Cost Trend Rate - Continued

2023: Initial pre-Medicare health care cost trend rate is 6.25% decreasing to an ultimate of 4.75% in 2029; initial post-Medicare health care cost trend is 6.75% decreasing to an ultimate of 4.75% in 2031.

Expected Rate of Return 6.56% and 6.61% (2024 and 2023)

Amortization Gains and losses in excess of the 10% corridor are amortized over 13.06 years (2024) and 12.91 years (2023). Corridors for medical and life insurance determined separately.

The foregoing actuarial assumptions are based on the presumption that the Plan will continue. If the Plan were to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of accumulated Plan benefits.

The weighted-average health care cost-trend rate assumption has a significant effect on the amounts reported in the accompanying financial statements. If the assumed rates increased by one percentage point in each year, it would increase the obligation as of December 31, 2024 and 2023, by approximately \$1,213,000 and \$1,027,000, respectively. If the assumed rates decreased by one percentage point in each year, it would decrease the obligation as of December 31, 2024 and 2023, by approximately \$1,008,000 and \$845,200, respectively.

### *e. Payment of Benefits*

Benefits are recorded when paid.

### *f. Administrative Expenses*

Administrative expenses of the Plan, to the extent such expenses are not paid or withdrawn from the Plan, are paid directly by NYISO (Note 7).

### *g. Subsequent Events*

Management has evaluated subsequent events for potential recognition or disclosure through July 10, 2025, the date the financial statements were available to be issued.

## Note 4 - Investments and Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to the valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3).

The following three levels of inputs may be used to measure fair value:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets in active markets;
- Quoted prices for identical or similar assets in inactive markets;
- Inputs other than quoted prices that are observable for the asset; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money Market Funds: Valued at cost, which approximates fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's deficiency of net assets over benefit obligations at December 31, 2024 and 2023, relates primarily to the postretirement benefit obligation. It is expected that the deficiency will be funded through future contributions by NYISO.

## **Note 6 - Tax Status**

The Plan received an exemption letter from the Internal Revenue Service dated September 13, 2010, stating that the trust is tax-exempt under the provisions of Section 501(c)9 of the Internal Revenue Code (IRC). However, as a result of the Plan's funding policy, from time to time the trust may be subject to income taxes. No federal or state income taxes have been recorded in 2024 or 2023 for unrelated business taxable income.

In addition, the Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust is tax-exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **Note 7 - Related Party and Party-In-Interest Transactions**

Administrative expenses paid by NYISO on behalf of the Plan totaled approximately \$90,400 and \$78,800 for the years ended December 31, 2024 and 2023, respectively. Certain Plan administrative functions are performed by employees of NYISO who do not receive compensation for such functions from the Plan.

Investments in money market funds are held with the Trustee, which is a party-in-interest of the Plan.

## **Note 8 - Plan Termination**

NYISO has the right under the Plan to modify the benefits provided to, and contributions required of, participants, or to discontinue its contributions at any time and to terminate the Plan. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to NYISO or be used for purposes other than for the exclusive benefit of the Plan's participants.

## **Note 9 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities could occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Plan contributions are made, and the actuarial present value of accumulated Plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.
