Report of Independent Auditors

To the Administrator of Progress Residential, LLC 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

1. Description of the Plan

The following description of the Progress Residential, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan and Trust Agreement (the “Plan Document”) for a more complete description of the Plan's provisions.

General

The Plan covers all full-time employees of Progress Residential, LLC and Progress Residential PM Holdings, LLC (collectively, the “Company”). The Company is the sponsor (the “Plan Sponsor”). The Company's Plan Administrator is Fiduciary Wise, LLC (the “Plan Administrator”).

Employees become eligible to make salary deferrals following two months of service and attaining the age of 21. The Plan is set up with an automatic deferral feature; once an employee becomes eligible, the Plan will defer 3% of participants' Plan compensation from each paycheck, as defined in the Plan Document. Eligible employees can adjust the automatic deferral rate or elect not to participate in the Plan. Employees are eligible to receive employer contributions once the employee begins participating in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

Participants may contribute the lesser of 90% of their annual compensation or the maximum contribution limit provided by the Internal Revenue Code (the “Code”), \$23,000 for 2024 and \$22,500 for 2023. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Each year, the Company may make discretionary matching contributions based on a percentage of the participant contributions. The percentage of such matching contributions, if any, is to be determined annually. The Company contributed 50% of the first 6% of compensation that a participant contributed to the plan. Participant contributions in excess of 6% of eligible compensation are not considered for matching contributions. The Company may make discretionary nonelective contributions in an amount to be determined by the Plan Administrator for each Plan year. All eligible participants are eligible for nonelective employer contributions. For the years ended December 31, 2024 and 2023, the Company did not make discretionary nonelective employer contributions to the Plan.

Investments

Upon enrollment in the Plan, a participant may direct contributions into various investment fund options maintained by Fidelity Management Trust Company (“Fidelity”), the trustee of the Plan. Participants can individually direct both employee and employer contributions made on their behalf. The Company's Investment Consultant is IFAM Capital.

Investment earnings, including net appreciation or depreciation of the assets in the Plan, are allocated to participants daily, in proportion to the value of each participant's account as of that date, to the total of all participant accounts.

Participant Accounts

Each participant's account consists of the participant's contribution (salary deferral), the Company's matching contribution, the Company's discretionary nonelective contributions, if any, required top-heavy contributions, and earnings on the invested balances.

Vesting

Participants are 100% vested in their salary deferral contributions, rollovers, and earnings thereon. The vesting for the Company's matching contributions, discretionary nonelective contributions, required top heavy contributions, and earnings thereon is based on years of service and vest at a rate of 33% each year beginning at one year of service and reaching 100% of vesting at three years of service.

Payment of Benefits

The Plan is designed to provide benefits at the time of retirement. However, if employment is terminated because of death, disability, or for any other reason, participants may request a distribution of their vested account balance from the Plan Administrator. Furthermore, upon approval by the Plan Administrator, participants may be entitled to take distributions of salary deferral contributions and rollover contributions to satisfy certain immediate and heavy financial needs. Participants can elect to withdraw all, or a portion of their account while still employed, upon attainment of age 59 ½.

Forfeited Accounts

Forfeited balances of terminated participants' non-vested accounts are used to reduce the Company's contributions and fees payable under the Plan. The following table summarized the account balance as of December 31, 2024:

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 4.50% to 10.50%, which are commensurate with local prevailing rates as determined quarterly by the Plan Administrator. Principal and interest are paid ratably through monthly payroll deductions.

2. Summary of Significant Accounting Policies

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Basis of Accounting

The accounting records of the Plan are maintained on the accrual basis. Revenues are recognized when earned, and expenditures are recognized when incurred.

Administrative Costs

The Plan has entered into service contracts with outside consultants and agencies to perform certain administrative services for the Plan. The fees for these services are paid by the Plan Administrator. Fees related to administration of participant loans are deducted from the participants' applicable accounts.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (see note 4).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Loans to participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan Document. Delinquent loans are reclassified as benefit payments based on the terms of the Plan document. Interest income is recorded on the accrual basis. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded.

Payment of Benefits

Benefits are recorded when paid.

4. Fair Value Measurements

The Plan’s investments are reported at fair value in the statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. No Level 2 or 3 inputs were used since Level 1 inputs were available for all investments.

Fair Value Measurements

The fair values of mutual funds are based on quoted net asset values (“NAV”) of the shares held by the Plan at year end.

5. Risks and Uncertainties

The Plan invests in various investments which, in general, are exposed to various risks, such as interest rate, credit and overall market volatility risks. Furthermore, due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes, could materially affect the amounts reported in the statement of net assets available for benefits.

6. Tax Status

The Plan has received an opinion letter from the Internal Revenue Service dated June 30, 2020 stating that the written form of the underlying plan document is qualified under Section 401(a) of the Code, and that any employer adopting this form of the Plan will be considered to have a plan qualified under Section 401(a) of the Code. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification.

The Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified, and the related trust is tax exempt. Accordingly, no provision for income taxes has been made in the accompanying financial statements.

The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to audit by taxing jurisdictions, however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2018.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their accounts.

8. Party-In-Interest Transactions

Parties-in-interest are defined under the DOL regulations as any fiduciary of the Plan, any party rendering services to the Plan, the employer, and certain others. During the year ended December 31, 2024, administrative fees of \$307,053 was paid by the Plan to Fidelity.

Certain Plan investments are shares of mutual funds managed by Fidelity. Since Fidelity is the trustee as defined by the Plan, these investments qualify as party-in-interest transactions.
