Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Jervey Eye Group, P.A. Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits - modified cash basis as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits - modified cash basis for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Jervey Eye Group, P.A. Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTE A – DESCRIPTION OF PLAN

The following description of Jervey Eye Group, P.A. (the “Employer”) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

GENERAL

The Plan is a defined contribution plan administered by the Employer for the benefit of its employees. The Plan covers all employees who have reached the age of 21 and have completed one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

CONTRIBUTIONS

Each year participants may contribute up to the maximum amount allowed by law of pretax annual compensation, as defined in the Plan. The Employer matches 100% of the employee’s contributions that do not exceed 3% of compensation plus 50% of the employee’s contributions between 3% and 5% of compensation. Also, the Employer, at its discretion, may make additional matching contributions and profit-sharing contributions. During the years ended December 31, 2024 and 2023, the Employer made no additional discretionary matching or profit sharing contributions. Contributions are subject to certain Internal Revenue Service (“IRS”) limitations. Participants direct the investment of contributions to their account into various investment options offered by the Plan.

PARTICIPANT ACCOUNTS

Each participant’s account is credited with the participant’s contributions, Employer required matching contributions, any Employer matching and profit-sharing contributions, and investment earnings. Each participant’s account is debited for investment losses and an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.

NOTES TO FINANCIAL STATEMENTS

Years Ended December 31, 2024 and 2023

NOTE A – DESCRIPTION OF PLAN (Continued)

VESTING

Participants are immediately vested in their contributions and the required Employer safe harbor matching contributions plus actual earnings thereon. A participant's vesting in the Employer's discretionary contributions to his or her account plus earnings thereon is based on the participant's years of credited service with the Employer. A participant is 100% vested after six years of credited service.

NOTES RECEIVABLE FROM PARTICIPANTS

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates, as determined by the Plan Administrator. Principal and interest is paid ratably through payroll deductions and is credited to the borrowing participant's account.

PAYMENT OF BENEFITS

Upon termination of service due to death, disability, retirement, or for other reasons, a participant with a vested account balance in excess of \$5,000 may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a single lump-sum payment or in partial withdrawals or installments under the required minimum distribution provisions of Sec. 401(a)(9) of the Internal Revenue Code (the "IRC"). Vested account balances of \$5,000 or less are automatically distributed in a single lump-sum payment to the participant upon termination of service.

In-service distributions and hardship distributions are also permitted by the Plan subject to certain requirements and limitations as specified in the Plan agreement.

FORFEITURES

At December 31, 2024 and 2023, forfeited non-vested amounts totaled \$2,299 and \$2,076, respectively. These amounts are used to reduce administrative expenses and/or future Employer contributions to the Plan. In 2024 and 2023, administrative expenses and employer contributions were reduced by \$2,299 and \$0, respectively.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

BASIS OF ACCOUNTING

The financial statements of the Plan have been prepared on the modified cash basis of accounting. This basis differs from accounting principles generally accepted in the United States of America because the Plan has not recognized contributions receivable, other than notes receivable from participants, nor contributions payable. The modified cash basis differs from the cash basis because the investments are adjusted to fair value.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

ESTIMATES

The preparation of financial statements in conformity with the modified cash basis of accounting requires the Plan's management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

INVESTMENT VALUATION AND INCOME RECOGNITION

In May 2015, the Financial Accounting Standards Board ("FASB") issued Accounting Standards Update ("ASU") 2015-07 which exempts from categorization within the fair value hierarchy those investments for which fair value is measured using the net asset value practical expedient in Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*. ASU 2015-07 is effective for fiscal years beginning after December 15, 2016. For simplicity in reporting and disclosure, management adopted ASU 2015-07 in 2017 and, accordingly, the common collective trust fund is not included within the fair value hierarchy in Note C.

INVESTMENT VALUATION AND INCOME RECOGNITION (Continued)

The Plan's investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (see Note C for discussion of fair value measurements).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the modified cash basis or "when received". Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

PAYMENT OF BENEFITS

Benefits are recorded when paid by the Plan.

EXPENSES

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

The Plan’s management has evaluated subsequent events through September 1, 2025, the date the financial statements were available to be issued.

Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurement*, defines fair value and establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs have the highest priority and consist of unadjusted quoted prices in active markets for identical assets; Level 2 inputs consist of observable market data other than unadjusted quoted prices in active markets for identical assets; and Level 3 inputs have the lowest priority, are unobservable, are supported by little or no market activity, and are generally based on the entity's own assumptions. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments on a recurring basis. When available, the Plan measures fair value using Level 1 inputs because these generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

LEVEL 1 FAIR VALUE MEASUREMENTS

The fair values of common stocks and closed-end mutual funds are based on quoted market prices in active markets. The fair values of money market funds and open-end mutual funds are based on quoted net asset values in active markets of the shares held by the Plan in these investments at year-end.

NOTE D – TRUSTEE CERTIFICATIONS

The December 31, 2024 and 2023 Statements of Net Assets Available for Benefits - Modified Cash Basis, the Statements of Changes in Net Assets Available for Benefits - Modified Cash Basis for the years ended December 31, 2024 and 2023, the accompanying notes to the financial statements, and the supplemental information were prepared in part or entirely from information certified by the Trustee (Vanguard Fiduciary Trust Company) in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The information certified includes a) total investments at fair value of \$17,249,156 and \$18,695,229 at December 31, 2024 and 2023, respectively, b) total notes receivable from participants of \$83,549 and \$104,619 at December 31, 2024 and 2023, respectively, and c) related income (loss) of \$2,136,069 and \$2,919,684 for the years ended December 31, 2024 and 2023, respectively.

NOTE E – COMMON COLLECTIVE TRUST FUND

The common collective trust fund represents the Plan's investment in Vanguard Fiduciary Trust Company (the "Trust") which has an investment objective to provide a relatively predictable return from current income with no change to principal value by emphasizing high credit quality and diversification. The underlying investments of the Trust are primarily a pool of investment contracts issued by insurance companies and commercial banks and contracts that are backed by bond funds and trusts. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. However, certain withdrawals may be subject to market value adjustments calculated in accordance with the provisions of the investment contracts.

NOTE F – RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by the Trustee, and therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. The Plan made direct payments to the third-party administrator totaling \$21,761 and \$19,896 for the years ended December 31, 2024 and 2023, respectively. Such payments were not covered by revenue sharing.

NOTE G – PLAN TERMINATION

Although it has not expressed any intention to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

NOTE H – PLAN AMENDMENTS

In 2016, the Plan was also amended such that the Employer may annually elect to satisfy the “safe harbor” nondiscrimination provisions of the IRC by making certain non-elective matching contributions to participants’ accounts. Participants will be immediately 100% vested in such safe harbor matching contributions. This amendment became effective January 1, 2017. The Plan was amended effective January 1, 2021 to comply with IRS Notice 2017-37.

NOTE I – TAX STATUS

The Employer adopted the Qualified Plans, LLC Volume Submitter 401(k) Profit Sharing Plan. The IRS determined by letter dated June 30, 2020, that this prototype plan document satisfies the applicable sections of the IRC. The Plan was amended since the date of the determination letter. However, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC and therefore the Plan continues to be qualified and the related trust continues to be tax-exempt.

NOTE I – TAX STATUS (Continued)

Plan management evaluates tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by various taxing jurisdictions. However, there are currently no audits in progress for any tax periods.

NOTE J – RISKS, UNCERTAINTIES AND CONCENTRATIONS

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits - Modified Cash Basis.

NOTE K – SECURE Act 2.0

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023 which included SECURE Act 2.0. SECURE Act 2.0 contains of 90 new retirement provisions, with varying effective dates through 2027. Since SECURE Act 2.0 provisions include both required and optional elements, the plan administrator will determine the optional provisions to elect and amend the Plan document accordingly. Significant provisions that became effective in 2024 include an increase in the required minimum distribution age from 72 to 73 and an increase in the mandatory cash out limit from \$5,000 to \$7,000. These changes had no material impact on the Plan's 2024 financial statements.
