NOTES TO FINANCIAL STATEMENTS

YEAR ENDED DECEMBER 31, 2024

NOTE 1. DESCRIPTION OF THE PLAN

The following description of the BBC International LLC 401(k) Plan & Trust (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan was established effective January 1, 1994 for eligible employees of BBC International LLC (the “Company”) and any affiliate which has adopted the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The custodian of the Plan is Voya and the recordkeeper is The Aimpoint Group.

Eligibility

The Plan is a defined contribution plan covering employees of the Company who have completed three months of service and are at least twenty-one years old.

Contributions

Each year, employees participating in the Plan may contribute up to 100% of their compensation as defined by the Plan, subject to the limits set forth by the Internal Revenue Code (“IRC”). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. In no event may participant contributions exceed any statutory limitations. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may elect to contribute a matching contribution to the Plan. The 2024 matching contribution amount was equal to 50% of the participant’s elective deferral contribution, not to exceed 3.75% of the participant’s compensation, up to a maximum of \$2,000. Company contributions are credited to individual participants’ accounts at the time the contribution is made and are allocated to participants’ accounts based on participants’ elections.

Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant’s account is credited with the participant’s contributions, allocations of Company matching contributions and Plan earnings (losses), and may be charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. The Company’s matching contribution plus earnings thereon vest based on years of continuous service. Amounts contributed by the Company for the benefit of each participant plus earnings thereon become 100% vested after three years of continuous service of 1,000 hours each calendar year, upon death or upon attainment of normal retirement age, which is 65.

Forfeitures

Forfeitures of nonvested accounts may be used to pay Plan expenses or reduce the Company's contributions to the Plan. Forfeitures in the amount of \$6,660 and \$1,617 were used to offset the Company's matching contributions during the years ended December 31, 2024 and 2023, respectively. Forfeited nonvested accounts available as of December 31, 2024 and 2023 were \$0 and \$79, respectively.

Payment of Benefits

On termination of service due to death, a participant becomes fully vested, and the beneficiary will receive a lump-sum distribution. For termination of service due to other reasons, a participant will receive the value of the vested interest in his or her account as a lump-sum distribution. Participants may also request a withdrawal from their accounts in cases of financial hardship.

Investment Options

Upon enrollment in the Plan, a participant may direct contributions into any of the various investment options offered by the Plan. Participants may change their investment options and allocations daily. The Plan provides participant-directed investments in a variety of pooled separate accounts and a guaranteed investment contract with Voya.

Termination of the Plan

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined-contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts, because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles (“GAAP”) requires the Plan to make estimates and assumptions that affect the reported amounts of net assets available for benefit and disclosure of contingent net assets available for benefit at the date of the financial statements and the reported amounts of additions to and deductions from net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan recognizes participant contributions received as additions to net assets in the period received from participants through payroll deductions. Company contributions are recognized in the year in which the Company becomes obligated to make such contributions.

Payment of Benefits

Benefit payments are recorded when paid.

Plan Expenses

Expenses are recorded when incurred in accordance with the accrual basis of accounting. Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in the net appreciation of fair value of investments.

Concentration of Credit Risk

Financial instruments which potentially expose the Plan to concentrations of credit risks, as defined by GAAP, consist primarily of investments and notes receivable from participants. The Plan invests in pooled separate accounts which, inherent in the fair market value determination, include the risk factor of credit worthiness for each debt security.

NOTE 3. INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, Voya, the insurance company of the Plan, has certified to the completeness and accuracy of all investments and related investment activity and notes receivable from participants and related activity in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the accompanying supplemental schedule of assets (held at end of year) as of December 31, 2024.

Allocations among the underlying investments are participant directed. The accounts are credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses.

During the year ended December 31, 2024, the Plan's underlying investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by approximately \$2,997,000. This was reported as net appreciation in fair value of investments in the accompanying statement of changes in net assets available for benefits.

NOTE 4. NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Participants may borrow from their investment fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance for a term of five years, or ten years for the purchase of a primary residence. Loan transactions are treated as a transfer to (from) the investment fund and from (to) the participant notes receivable fund. The loans are secured by the balance in the participant's account and bear interest at fixed rates equal to 1% above the prime rate in effect at the loan application date. Principal and interest is paid monthly through employee payroll deductions. Interest income is recorded on the accrual basis. The interest rate on all outstanding participant loans ranged from 4.25% to 9.50% as of December 31, 2024 and 2023. Notes receivable from participants were approximately \$191,000 and \$240,000 as of December 31, 2024 and 2023, respectively, and mature during various dates through 2029. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document. Related fees are recorded as administrative expenses and are expensed when they are incurred.

NOTE 5. FAIR VALUE MEASUREMENTS

GAAP provides a framework for measuring fair value and provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of fair value hierarchy are described as follows:

Level 1: Inputs using the valuation methodology are unadjusted quoted prices for identical, unrestricted assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methods used for assets measured at fair value as of December 31, 2024 and 2023:

Pooled separate accounts: Price/unit values for variable annuity investment options are calculated daily by the annuity provider based on the quoted price on a national exchange for the underlying mutual fund, adjusted for the contract account charges disclosed in the contract. The pooled separate accounts are comprised of a wide variety of underlying investments such as equities, bonds, and mutual funds.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 6. GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan's contract with Voya included the option to allocate contributions to a guaranteed investment contract, referred to as the Voya Fixed Account, which is fully benefit-responsive. Participant contributions to the guaranteed investment contract were held in the Voya general account. The contract is reported at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Voya guarantees a minimum interest rate of 1.0% on the Voya Fixed Account, and although a higher interest rate may be credited, the credited rate will not fall below the lifetime guaranteed minimum of 1.0%. Voya's determination of the credited interest rate reflects a number of factors, including mortality and expense risks, interest rate guarantees, the investment income earned on invested assets, and the amortization of any capital gains and/or losses realized on the sale of invested assets.

As of December 31, 2024 and 2023, the contract value of the Voya Fixed Account was approximately \$647,000 and \$1,012,000, respectively.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

- The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code;
- Premature termination of the contracts;
- Plan termination or merger;
- Changes to the Plan's prohibition on competing investment options; or
- Bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

- An uncured violation of the Plan's investment guidelines;
- A breach of material obligation under the contract;
- A material misrepresentation; or
- A material amendment to the agreements without the consent of the issuer.

NOTE 7. PARTY-IN-INTEREST TRANSACTIONS

The Plan investments consist of units in investment funds and a general account managed by Voya. Voya is a party-in-interest, as defined by ERISA, therefore, transactions related to these investments are party-in-interest transactions; however, they are exempt from prohibited transaction rules under ERISA. The Plan did not pay any direct fees to Voya during 2024 for these services, however, the Plan Sponsor paid certain fees directly to Voya on behalf of the Plan. Additionally, direct fees paid by the Plan for legal and professional expenses to advisors and independent auditor considered parties-in-interest were approximately \$7,000 and \$16,000, respectively, for the year ended December 31, 2024.

The insurance company provides certain administrative services to the Plan and receives revenue from mutual fund providers for services the insurance company provides to the funds. This revenue is used to offset certain amounts owed to the insurance company for its administrative services to the Plan. If the revenue received by the insurance company from such mutual fund service providers exceeds the amounts owed, the insurance company remits the excess to the Plan pursuant to the service agreement. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants on a pro-rata basis, in accordance with the service agreement. During 2024, the Plan had excess earnings on their revenue credits of approximately \$30,000 which were recorded in the caption "dividends and interest" on the statement of changes in net assets available for benefits and were used to pay Plan expenses.

NOTE 8. TAX STATUS

The Plan has adopted a non-standardized pre-approved profit sharing with CODA plan that is sponsored by CCH Incorporated. On June 30, 2020, the Internal Revenue Service ("IRS") stated in an opinion letter that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code and, therefore, the related trust is exempt from taxation. The Plan has been amended since receiving the letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified and the related trust is tax-exempt.

Plan management is required to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not to be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken by the Plan. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The administrator believes it is no longer subject to income tax examinations for years prior to 2021.
