### ***Auditor's Responsibilities for the Audit of the Financial Statements***



### 1. DESCRIPTION OF PLAN

The following description of the Fringe Benefit Plan For Davis-Bacon and Related Acts (DBRA) Employees of ServiceSource, Inc. (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

**General** - The Plan is a contributory defined contribution health and welfare plan established by ServiceSource, Inc. on January 1, 2011. ServiceSource, Inc. is herein referred to as the Company or the Plan sponsor. The Plan sponsor established a voluntary employees' beneficiary association (VEBA) Trust to serve as a funding vehicle for the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Benefits** - The Plan provides medical, dental and prescription drug benefits to all employees of the Company for whom fringe benefits are required to be made under the federal Davis- Bacon and Related Acts (DBRA), or any other federal, state or local prevailing wage law. Benefits are generally reserved for employee coverage, but employees may purchase additional coverage for their spouse and dependents through pre-tax and after-tax deductions as allowable under Internal Revenue Service (IRS) and ERISA rules and regulations. DBRA employees do not include leased employees or employees employed in an executive, administrative or professional capacity. A DBRA employee shall be a participant in the Plan for work performed that is not covered under the fringe benefit provisions of the DBRA in an amount determined by the Plan sponsor and at the Plan sponsor's discretion. A participant who terminates employment, or while continuing in employment ceases to be a DBRA employee, will continue to be a participant until the balance of the individual's account under the Plan has been fully exhausted or the participant dies.

**Contributions** - The Plan is funded by employer and employee contributions. In addition to deductibles and copayments, participants contribute specified amounts, determined annually, for coverage of themselves and their dependents. This determination is based on a review of the Plan's payment trends and an estimation of expected costs for the following year, as recommended by an independent third-party specialist.

Employer contribution rates are established annually by the Plan in accordance with prevailing wage rates and health and welfare rates for employees covered under the DBRA. The Plan sponsor adjusts the health and welfare contribution rates annually upon renewal or modification of the contract by the federal government. The Plan sponsor provides qualified fringe benefits for each employee covered by DBRA up to the statutory limitations. For the year ended December 31, 2024, the health and welfare contribution rates ranged from \$4.41 to \$5.36 per hour based upon the date of the contract renewal.

The Plan sponsor may also elect to take premium rebate credits against the required health and welfare contributions for qualified fringe benefits provided by the Company outside of the Plan in meeting the health and welfare contribution rate requirement under the DBRA and as required for the Plan to meet its obligations to Plan participants and service providers. The Company also contributes excess funds in participant premium reserve accounts, as defined and maintained by the Plan, to a qualified retirement plan established for the benefit of the Plan participants.

**Insured benefits** - The Plan fully insures its medical, dental and prescription drug benefits. The Company purchases annual insurance contracts for these insured benefits. Premiums are paid to the insurance company from the assets of the VEBA Trust.

**Plan administration and expenses** - Under the DBRA, employers are required to ensure compliance with the prevailing wage and health and welfare requirements. Accordingly, many employers establish separate trusts or other funded arrangements that receive and administer the health and welfare contributions. If such contributions are paid to a trust, the trust must preclude the federal contractor from recapturing any of the contributions paid into the trust in meeting the minimum prevailing wage requirement and from diverting any of the funds of the trust for its own benefit or use. The Plan is managed by a trustee, who is a primary representative of the Company. The trustee retained the services of a third-party administrator, Government Service Administrations (GSA), that specializes in providing administrative and accounting services for employee benefit plans.

## 2. SUMMARY OF ACCOUNTING POLICIES

**Basis of accounting** - The accompanying financial statements have been prepared using the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America (U.S. GAAP). The principal differences between the modified cash basis of accounting and U.S. GAAP are that additions are included in the year in which they were collected instead of the year in which they were owed and deductions are included in the year in which they are disbursed (except for premium reserve liabilities and related rebates) instead of the year in which they are incurred.

**Use of estimates** - The preparation of financial statements in accordance with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, net assets and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Payment of benefits** - Premiums paid by either the Company or the VEBA Trust are recorded as insurance premium payments in the accompanying Statement of Changes in Net Assets Available for Benefits.

**Subsequent events** - The Plan has evaluated subsequent events through September 15, 2025, the date on which these modified cash basis financial statements were available to be issued, and has determined that there are no subsequent events that require recognition or disclosure.

### **3. TAX STATUS**

The VEBA Trust established under the Plan to hold the Plan's assets obtained its tax exemption letter dated May 5, 2014, in which the IRS determined that the VEBA Trust was in compliance with the applicable requirements of the Internal Revenue Code (IRC); therefore, the VEBA Trust is exempt from federal income taxes under Section 501(c)(9) of the IRC. Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan is qualified, and the related VEBA Trust is tax-exempt, and no provision for income taxes has been included in the Plan's financial statements.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan sponsor has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken that would require recognition of a liability (or asset) or disclosure in the modified cash basis financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **4. RISKS AND UNCERTAINTIES**

The Plan holds cash in a bank deposit account with a financial institution, which, at times may exceed federally insured limits. Plan management periodically evaluates the balance and believes this account does not pose a financial risk to the Plan.

All of the plan participants are employees of the Company working under contracts with the federal government, many of which are subject to the DBRA. As such, federal contracts are subject to termination clauses whereby the government may terminate contracts for cause or convenience. Any contract termination or funding delays caused by political, budgetary, or other administrative matters may affect employees participating in the Plan and the ability and necessity of the Plan sponsor to fund and maintain the Plan.

### **5. PRIORITIES UPON TERMINATION**

Although it has not expressed any intention to do so, the Plan sponsor has the right under the Plan to modify or discontinue any terms, conditions, or benefits of the Plan at any time and terminate the Plan subject to the provisions of ERISA, the insurer's contract, and the contract administration agreement. Expenses incurred prior to a termination, modification, or amendment of the Plan would be paid as provided under the terms of the Plan prior to its termination, modification, or amendment. In the event of termination, the Plan sponsor shall first satisfy or make provisions to satisfy the obligations of the Plan.

### **6. ACCRUED PREMIUM REBATES AND RESERVE**

The accrued premium reserve payable represents the unexpended balance in the participant accounts from contributions made at the prevailing health and welfare contribution rates established under the DBRA, less the benefit premiums, retirement plan allocations, and other benefit payments made on behalf of the participants. Amounts remaining in the participant premium reserve accounts at termination of employment are generally used to fund benefits or are contributed by the Company to a qualified retirement plan for the benefit of the participants. Any premium rebate credits unpaid as of the end of the reporting period are reflected as an accrued premium rebate liability. As of December 31, 2024 and 2023, the Plan reported accrued premium rebate liabilities of \$23,507 and \$21,779, respectively, which are included in "Accounts payable" in the accompanying Statements of Net Assets Available for Benefits - modified cash basis. The Plan also reported an accrued premium reserve payable of \$78,319 and \$92,074 as of December 31, 2024 and 2023, respectively.

### **7. RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS**

GSA is the Plan's third-party administrator. Therefore, transactions with this party qualify as party in interest transactions. The Plan paid fees to GSA for administrative services rendered for the year ended December 31, 2024, totaling \$154,412.

Certain administrative functions of the Plan are performed by officers or employees of the Plan sponsor. No such officer or employee receives compensation from the Plan.


