## Independent Auditors' Report

**1. Description of Plan**

The following description of Comtech Telecommunications Corp. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

***General***

The Plan is a defined contribution plan covering all eligible employees of Comtech Telecommunications Corp. (the “Employer”). Excluded employees include those covered by a collective bargaining agreement, lease employees and nonresident aliens. Employees are eligible to participate in the Plan upon their date of hire if they are 18 years of age or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

***Contributions***

Each year, participants may contribute to the Plan up to 75% of their compensation on a pre-tax, after-tax or Roth basis, subject to Internal Revenue Service limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Transfers from qualified plans (rollover contributions) are also permitted. Participants direct the investment of their contributions into various investment options offered by the Plan. In addition, a self-directed brokerage account is also available to allow participants to select investment options not specifically offered by the Plan. Contributions are subject to certain limitations. The Plan provides for automatic enrollment for eligible employee’s at 3% of eligible compensation. Each year, participants’ contribution rate will be automatically increased by 1% until a contribution rate of 6% is reached.

The Employer makes a safe harbor matching contributions in the amount of 100% of the first 3% and 50% of the next 2% of eligible compensation.

In addition, the Plan allows for a discretionary Employer contribution for eligible participants that are employed on the last day of the Plan year and work 1,000 hours of service during the Plan year. No discretionary Employer contributions were made for the year ended December 31, 2024.

***Vesting***

Participants are immediately 100% vested in their contributions plus allocated earnings thereon. Participants are fully vested in Employer safe harbor matching and discretionary Employer contributions after two years of service.

**1. Description of Plan (continued)**

***Participant Accounts***

Each participant's account is credited with the participant's contribution, allocations of: (a) Employer contributions and (b) Plan earnings (losses) thereon. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. All investments are participant directed.

***Notes Receivable from Participants***

Participants may borrow from their account balance a minimum amount of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates as determined by the plan administrator. Principal and interest is paid ratably through payroll deductions. The repayment period generally cannot exceed 5 years. If the loan is for the purchase of a home, the repayment period cannot exceed 10 years.

***Payment of Benefits***

Upon termination of service due to death, disability, retirement, in-service or other reason, a participant is entitled to receive a distribution in the amount equal to the value of the participant's vested interest in his or her account. This can be distributed in either a single lump-sum amount, installments or partial withdrawals. Benefits can also be distributed in the event of a participant's immediate and heavy financial need. Such distributions, which are considered hardship withdrawals, are subject to restrictions as to the use of the proceeds.

***Forfeitures***

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$137,243 and \$89,450. These accounts will be used to pay administrative expenses or reduce future Employer contributions. During 2024, forfeitures of \$14,276 were used to pay administrative expenses and forfeitures of \$294,900 were used to reduce Employer contributions.

***Recent Regulatory Event***

On December 29, 2022, the Setting Every Community Up for Retirement Enhancement ("SECURE") 2.0 Act of 2022 was signed into law as part of the Consolidated Appropriations Act of 2023. The SECURE 2.0 Act of 2022 builds on the SECURE Act of 2019 which revised existing rules around retirement saving. The SECURE 2.0 Act of 2022 contains dozens of new retirement-related provisions with effective dates beginning January 1, 2024 and beyond. SECURE 2.0 is intended to expand and increase retirement savings and to simplify and clarify many complex existing retirement plan rules. **2. Summary of Significant Accounting Policies**

***Basis of Accounting and Use of Estimates***

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”), which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. All of the Plan’s investments, that were valued at fair value, were valued using level 1 inputs.

***Investment Valuation and Income Recognition***

All of the Plan’s investments are stated at fair value. The mutual funds and money market fund are valued at the daily closing price as reported by the fund. The funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission and are deemed to be actively traded. These funds are required to publish their daily NAV and to transact at that price. The Plan also offers a self-directed brokerage account which consists of mutual funds, other (options and rights/warrants), common stocks, and money market funds.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded upon a distributable event.

***Payment of Benefits***

Benefits are recorded when paid.

**2. Summary of Significant Accounting Policies (continued)**

***Expenses***

Certain expenses of maintaining the Plan are paid by the Employer and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in the NAV of the respective investment vehicles and, consequently, those expenses are not separately reflected, but are a component of net appreciation in fair value of investments.

***Reclassifications***

Certain 2023 amounts have been reclassified to conform with the 2024 classification.

***Subsequent Events Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is September 16, 2025.

Effective on or about October 1, 2024, the Employer elected to adopt the following withdrawal and other provisions of the SECURE 2.0 Act (see Note 1): a) Domestic Abuse Withdrawals for participants who are victims of domestic abuse, as defined under Section 314; b) Emergency Expense Withdrawals for emergencies, as defined in Section 115; c) Qualified Federally Declared Disaster Withdrawals, as defined in Section 331, and d) Qualified Birth or Adoption Distributions as defined in Section 113.

Effective on or about January 1, 2024 and January 1, 2025, respectively, the Employer elected to not opt out of a unilateral amendment advanced by Fidelity Workplace Services LLC, and thus adopt the following provisions of the SECURE 2.0 Act: a) Increase in Dollar Threshold for Mandatory Cash-Out Distributions, as defined in Section 304 and b) Increased Catch-Up Limits for Ages 60, 61, 62 and 63, as defined in Section 109.

**3. Information Certified (Unaudited)**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, a qualified institution.

**4. Income Tax Status**

The Internal Revenue Service (“IRS”) issued an opinion letter to the pre-approved plan document sponsor, FMR LLC, dated June 30, 2020, which states that the form of the pre-approved plan qualifies under the applicable provisions of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examination by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

**5. Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

**6. Party-In-Interest Transactions**

Certain Plan investments are managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee as defined by the Plan document and, therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

Certain administrative functions are performed by officers or employees of the Employer at no cost to the Plan.

The Plan and Fidelity Management Trust Company entered into a revenue sharing arrangement whereby a portion of the revenue earned from certain funds is passed through to the Plan for payment of permitted Plan expenses or allocated to participants. In order for the Plan to receive credits as a result of this revenue sharing arrangement, and to use this credit to pay Plan expenses or allocate to participants, the Plan created the Revenue Credit Account under the Plan. The Revenue Credit Account is a cash account within the Plan, similar in design to forfeiture accounts, and is used to record the redistribution of plan-generated fund revenue that exceeds the costs associated with Plan administration. The Revenue Credit Account balance was \$406,941 and \$771,120 at December 31, 2024 and 2023. During 2024, \$28,576 was used to pay Plan expenses and \$400,000 was allocated to participants from the Revenue Credit Account.

**7. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
