Note 1 - Description of the Plan

The following description of Kirwan Surgical Products 401(k) Profit Sharing Plan, (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering certain employees who have three months of service and are age eighteen or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Plan management is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions

Each year, participants may contribute up to 90% of pretax annual compensation, in accordance with Internal Revenue Service ("IRS") regulations, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible for catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds with registered investment companies and a common collective trust fund as investment options for participants. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 8% of eligible compensation and their contributions invested in a designated age-based fund until changed by the participant. In addition, on an annual basis, the automatic enrollment rate will increase by 1% per year for each participant who is automatically enrolled.

The Plan allows for non-discretionary matching contributions in an amount equal to 60% of elective deferrals, not in excess of 10% of compensation. The Plan also allows discretionary non-elective contributions into the Plan as determined annually by management. During 2024, management approved discretionary non-elective contributions equal to 5% of eligible compensation. Discretionary non-elective contributions for year ended December 31, 2024 amounted to \$878,623. Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and Plan earnings, as well as employer matching contributions and allocations of the employer's discretionary contribution, when applicable. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Note 1 - Description of the Plan (continued)

#### Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the employer's matching contributions and discretionary contributions portion of their accounts plus actual earnings thereon is based on years of continuous service. Matching contributions and discretionary contributions plus actual earnings vest following the schedule detailed below:

<u>Years of Vesting Service</u>	
Less than 2 years	0%
2 years	20%
3 years	40%
4 years	60%
5 years	80%
6 or more years	100%

#### Payment of Benefits

Participants may receive benefits the first day of the month on or after the date they reach age 65. Participants age 59 ½ or older may withdraw all of part of their account resulting from 401(k) elective deferral contributions and extra contributions. Distributions may be deferred until the participant reaches age 70 ½ if the value of the distribution is not less than \$1,000. However, if no distribution election is made before the age of 70 1/2, the participant will begin to receive a mandatory minimum distribution as required by Federal Regulations. In certain hardship situations, as described in the Plan agreement, participants may withdraw part of their account balances while actively employed, but such withdrawals are limited to the amount dictated by the hardship.

#### Forfeited Accounts

Forfeited balances of terminated participants' nonvested accounts are used to reduce future Company contributions. During the year ended December 31, 2024, forfeitures of \$12,879 were used to reduce Company contributions. There were \$688 and \$585 of forfeiture balances as of December 31, 2024 and 2023 respectively.

### Note 2 - Summary of Accounting Policies

#### Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting and in compliance with the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA.

#### Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires that Plan management make estimates and assumptions that affect the reported amounts in the financial statements and accompanying notes. Actual results could differ from those estimates.

### Note 2 - Summary of Accounting Policies (continued)

#### Investment Valuation and Income Recognition

Investments are reported at fair value or net asset value ("NAV") for the common collective trust. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan's management determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for details on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

The Plan's expenses are paid either by the Plan or plan sponsor as provided by the Plan document. Expenses that are paid directly by the plan sponsor are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying Statement of Changes in Net Assets Available for Benefits. In addition, certain investment-related expenses are included in net appreciation of fair value of investments presented in the accompanying Statement of Changes in Net Assets Available for Benefits.

### Note 3 - Investments

All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024, net appreciation in fair value of mutual funds, and dividend and interest income for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by the trustees.

### Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritized the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the value hierarchy under FASB ASC 820 are described as follows:

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-ended mutual funds that are with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trusts:* Valued at the net asset value of units of the collective trust. The NAV, as provided by the fund manager, is used as a practical expedient to estimate the fair value. The NAV is based on the fair value of the underlying investments. It is the policy of the fund to use its best efforts to maintain a stable net asset value of \$1.00 per unit; although there is no guarantee that the fund will be able to maintain this value. The practical expedient would not be used if it is determined to be probable that the Plan would sell the investment for an amount different from reported NAV.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 – Common Collective Trust

The Managed Income Portfolio ("MIP") is a common collective trust fund that is considered to be a stable value fund with underlying investments and is valued at fair value. Fair value of the fund is the net asset value of its underlying investments. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The MIP is a stable value fund that is an open-end commingled pool dedicated exclusively to the management of assets of defined contribution plans.

The MIP invests in assets (typically fixed-income securities or bond funds and may include derivative instruments such as futures contracts and swap agreements) and enters into "wrap" contracts issued by third-parties and invests in cash equivalents represented by shares in money market funds. The third-party issuer generally agrees to make payments to the MIP in certain circumstances. Wrap contracts are also designed to allow the MIP to maintain a constant net asset value and protect the portfolio in extreme circumstances.

The wrap contracts limit the ability of the fund to transact at NAV upon the occurrence of certain Plan sponsor events. These events include:

- The Plan's failure to qualify under Section 401(a) or Section 401(k) of the Internal Revenue Code.
- The establishment of a defined-contribution plan that competes with the Plan for employee contributions.
- Any communication given to participants by the Plan sponsor that is designed to induce or influence participants not to invest in the fund or to transfer assets out of the fund.
- Any transfer of assets from the fund directly to a competing investment option.

### Note 5 – Common Collective Trust (continued)

The wrap contract will also limit the ability of the fund to transact at NAV upon the occurrence of certain other events. These events include:

- Any substantive modification of the Portfolio or the administration of the Portfolio that is not consented to by the wrap issuer.
- Any change in law, regulation, or administrative ruling applicable to the Plan that could have a material adverse effect on the Portfolio's cash flow.
- Any employer-initiated transaction described above.

Plan management believes the occurrence of these events is not probable.

The fund is unlikely to maintain a stable NAV if, for any reason, it cannot obtain or maintain wrap contracts covering its underlying assets that are not otherwise invested in stable NAV money market funds. This could result, for example, from the fund's inability to promptly find a replacement wrap contract following termination of a wrap contract. Fidelity Management Trust Company will attempt to assess the credit quality of wrap issuers, but there is no guarantee as to the financial condition of a wrap issuer. The issuer's ability to meet its contractual obligations under the wrap contracts may be affected by future economic and regulatory developments. Wrap contracts are non-transferable and have no trading market. There are a limited number of wrap issuers and, with respect to those wrap issuers, a limited amount of wrap capacity. The fund may lose the benefit of wrap contracts on any portion of its assets in default in excess of a certain percentage of fund assets. In the event that wrap contracts fail to perform as intended, the fund's NAV may decline if the market value of its assets declines.

The participation agreement also requires up to 12 months advance notice for withdrawals directed by the Plan sponsor. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Certain investment options offered by the Plan (e.g., money market funds, short term bond funds, certain asset allocation/lifecycle funds, and brokerage window) may be deemed by the contact issuers to "compete" with this fund. Transferred amounts must be held in a non-competing investment option for 90 days before subsequent transfers to a competing fund can occur.

### Note 6 – Rollover Contributions

An aggregate of \$8,979 was rolled into the Plan during the year ended December 31, 2024 and is included in rollovers on the Statement of Changes in Net Assets Available for Benefits.

### **Note 7 - Related-Party Transactions**

Under ERISA, parties-in-interest are defined to include the Plan sponsor, officers, directors and employees of the sponsor; direct and indirect owners of the sponsor and their relatives, if they have combined voting power of 50% or more; the Plan custodian or trustee and the Plan administrator; other parties with fiduciary responsibilities; and a person and their relatives or an organization that provides services to the Plan such as the Plan actuary, auditors, lawyers, investment advisors, etc. Certain Plan investments are managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee as defined by the Plan and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for administrative expenses amounted to \$6,241 for the year ended December 31, 2024.

### **Note 8 - Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan terminates, participants will become 100% vested in the company contribution of their account.

### **Note 9 - Income Tax Status**

The Plan has adopted the volume submitter plan document of Fidelity Management & Research Company. The volume submitter sponsor received a favorable opinion letter dated March 31, 2014, in which the Internal Revenue Service stated that the volume submitter plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). Although the Plan has been amended since the date of the last letter, the Plan administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC, and that the related trust is therefore tax-exempt. Accordingly, no provision for income taxes has been included in the financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 10 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
