## Independent Auditors' Report

To the Plan Administrator  
of **H.F. Cox, Inc. 401(k) Plan**:

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements***

We have performed the audit of the financial statements of H.F. Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the 2024 financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

***Other Matter - Supplemental Schedule Required by ERISA***

The supplemental schedule of Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.



In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

Their report dated July 1, 2024, indicated that (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2023 supplemental schedules, other than the information in the 2023 supplemental schedules that agreed to or is derived from the certified investment information, were presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA; and the information in the 2023 supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determines meets the requirements of ERISA Section 103(a)(3)(C).

### 1. Description of the Plan

The following description of the H.F. Cox, Inc. 401(K) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions, which is available from the Plan administrator.

#### *General*

The Plan is a defined contribution plan sponsored by H.F. Cox, Inc. (the “Company”) for the benefit of its full-time employees who have six months of consecutive service and are age 18 years or older. The Plan was effective January 1, 1991 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Plan is administered by the Company’s management (“Management”). Management has overall responsibility for the operation and administration of the Plan and determines the appropriateness of the Plan’s investment offerings, monitors investment performance and reports to the Company’s Board of Directors. The Plan has contracted Ascensus Trust Company (“Ascensus”) to process and maintain the Plan’s records and act as its trustee.

#### *Contributions*

Participants may contribute up to 90% of their annual compensation as pre-tax or Roth contributions, as defined in the Plan. Eligible participants are automatically enrolled into the Plan at a contribution rate of 4% and the Plan will automatically increase pre-tax elections by 1% annually, up to 10%. Participants may also rollover amounts representing distributions from other qualified defined benefit or contribution plans. Additionally, participants aged 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions, as defined in the Plan.

The Plan provides that the Company may elect to make discretionary matching contributions and discretionary nonelective contributions. During the year ended December 31, 2024, the Company made discretionary matching contributions of 75% of participant’s elective deferral up to a maximum of \$1,500. The Company did not make any discretionary nonelective contributions during the year ended December 31, 2024. Contributions are subject to certain Internal Revenue Code (“IRC”) limitations.

#### *Participant Investment Account Options*

The Plan currently offers one money market fund and several mutual funds as investment options for participants. Each investment option has its own investment strategy, which can be obtained through the prospectus of the respective fund. Participants direct their investments into the various investment options offered by the Plan and may change their investment options at any time.

#### *Participant Accounts*

Separate accounts are maintained for each participant. Each participant’s account is credited with the participant’s contribution, rollover contributions, an allocation of the Company’s contribution and plan earnings or losses and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

### *Vesting*

The portions of the participant's account attributable to elective deferral contributions, catch-up contributions, rollover contributions and qualified non-elective contributions plus earnings thereon are 100% vested immediately.

The portions of the participant's account attributable to the Company's matching and profit sharing contributions are subject to the following vesting schedule:

### *Payment of Benefits*

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or certain other optional forms of benefit payment. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. If the account balance does not exceed \$5,000, it will be automatically distributed as a lump sum.

### *Forfeited Accounts*

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$89,330 and \$61,081, respectively. This account will be used to reduce future Company contributions and reduce administrative expenses. For the year ended December 31, 2024, Company contributions were reduced by \$47,053.

## **2. Summary of Significant Accounting Policies**

### *Basis of Accounting*

The Plan's financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

### *Use of Estimates*

The preparation of financial statements in conformity with GAAP requires the plan management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein and contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

### *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Management determines the Plan's valuation policies utilizing information provided by the investment trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

### *Contributions*

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

### *Excess Contributions Payable*

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service ("IRS") are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025. There were no excess contributions for 2023.

### *Payment of Benefits*

Benefits are recorded when paid.

### *Administrative Expenses*

Administrative expenses are paid by the Plan and are included in the statement of changes in net assets available for benefits. Investment related expenses are included in net appreciation of investments. Certain expenses of the Plan are paid by the Company and are not included in the statement of changes in net assets available for benefits.

### **3. Information Prepared and Certified by the Plan's Trustee**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus, the trustee of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule are complete and accurate with respect to investments:

- Investments at fair value
- Net appreciation in fair value of investments
- Interest and dividends
- Schedule of assets (held at end of year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

### 4. Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, are described below:

**Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** Inputs to the valuation methodology are unobservable and significant to measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds and money market fund:* Valued at the daily closing price as reported by the fund. Mutual funds and the money market held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value ("NAV") and to transact at that price. The mutual funds and money market fund held by the Plan are deemed to be actively traded.

### 5. Related Party Transactions and Party-In-Interest Transactions

Plan investments include mutual funds and a money market fund managed by Ascensus, the trustee of the Plan and therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation of investments, and are paid through revenue sharing, rather than a direct payment. As described in Note 2, the Plan made direct payments to The Vanguard Group, Inc., the third-party administrator, totaling \$53,809 for the year ended December 31, 2024, which was not covered by revenue sharing. These transactions are party-in-interest transactions. The Company pays directly any other fees related to the Plan's operations.

### 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions.

### 7. Tax Status

The Company has adopted a pre-approved 401(k) profit sharing plan document that has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the pre-approved plan document, the Plan administrator believes that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC, and therefore, believes the Plan is qualified.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 8. Risks, Uncertainties and Concentrations

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict.

### 8. Risks, Uncertainties and Concentrations, Cont'd

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
