(1) Eligibility for Participation

Non-highly compensated employees and principal employees of the employer enter the plan on the later January 1, 2022, the Plan's effective date, or the first day of the Plan Year and the first day of seventh month of the Plan Year after completing one year of service with at least 1000 hours of service from date of hire. The 1000 hours of service is not required for certain employees grandfathered in the company's profit-sharing plan.

(a) Eligibility: 3 years of service with 1,000 or more hours of service, excluding service prior to the effective date.

(b) Benefit: Cash Balance Account or life annuity equivalent payable following termination of employment at Normal Retirement (or age 62, if earlier). The participant may elect payment of his or her benefit on or after the last day of the plan year coincident or following his or her date of termination.

- (c) Actuarial Equivalence: 5.0% interest rate and applicable mortality table.
