## INDEPENDENT AUDITORS' REPORT

To the Plan Sponsor of Plus Company 401(k) Plan  
New York, New York

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

The Plan is a participant-directed defined contribution plan covering all eligible employees of Plus Company U.S. Inc., Citizen Relations, Eleven LLC, Mekanism, Inc., PathIQ Inc., Plus AIOS, Inc., Plus Company Digital US Inc., The Narrative Group, Inc., and We Are Very Social Inc. (collectively, the Company) with retirement benefits in accordance with section 401(k) of the Internal Revenue Code (the IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established on January 1, 1988.

Effective January 1, 2024, Mekanism 401(k) Plan was merged into the Plan. The Plan was also amended to:

- allow participants who were automatically enrolled in the Mekanism 401(k) Plan under the Eligible Automatic Contribution Arrangement (EACA) before January 1, 2024, to make permissible withdrawals within 90 days of their enrollment. This option remains available until each participant's 90-day period ends, as permitted under IRS Code Section 414(w).90-day period ends, as allowed under IRS Code Section 414(w).
- adopt Mekanism, Inc., Plus AIOS, Inc., Plus Company Digital US Inc., and We Are Very Social Inc. as participating employers.
- exclude Cossette Media U.S Inc., and Jungle U.S. Inc as participating employers.
- remove the 90 day eligibility service requirement for matching employer contributions allocation.
- permit in-service withdrawals from discretionary match and non-elective contributions made to the Mekanism 401(k) Plan prior to January 1, 2024.
- add a different vesting schedule for Company discretionary match and profit-sharing contributions: 33% vesting per year of service, beginning after one year of credited service, and become fully vested in Company discretionary match and profit-sharing contributions after three years of credited service. Additionally, all eligible employees merged from the Mekanism 401(k) Plan are fully vested in discretionary non-elective contributions. This applies to all eligible employees who were merged and terminated participants (with no hours of service on or after January 1, 2024) from the Mekanism 401(k) Plan, with a 60-month in-service withdrawal restriction.

General (Continued)

Effective January 26, 2024, a portion of the Oasis Retirement Savings Plan representing employees of We Are Social Inc. was merged into the Plan. The Plan was also amended to add a different vesting schedule for Company discretionary match contributions: 20% vesting for each year of service, beginning after one year of credited service, and become fully vested in Company discretionary match contributions after five years of credited service. This applies to all terminated participants with no hours of service on or after January 26, 2024, from We Are Social.

Effective November 9, 2024, the Plan was amended to increase the Cash-Out Threshold from \$1,000 to \$7,000 for mandatory distributions for participants.

Eligibility

All employees are eligible to participate in the Plan upon employment. Freelance, temporary, part-time, seasonal, and intern employees must have reached 21 years of age and have completed 1000 hours of service with the Company to participate in the Plan. Leased employees and nonresident aliens are excluded from participation in the Plan. Eligible employees shall enter the Plan on the first day of the calendar month coincident with or next following the date the eligibility requirements are met.

Contributions

*Participant Contributions:* Participants elect to have amounts withheld from their paychecks and contributed to the Plan by the Company. Participants may contribute up to 100% of their plan compensation in pre-tax deferrals or Roth deferrals as defined in the Plan and by the Internal Revenue Service. Participants may also contribute rollover amounts representing distributions from other qualified defined benefit or contribution plans. Participants who have attained age 50 before the end of the Plan year are eligible to make catch up contributions. The Plan excludes reimbursements or other expense allowances, fringe benefits, moving expenses, all deferred compensation and welfare benefits, differential wages and unused leave.

*Eligible Automatic Contribution Arrangement (EACA):* The Plan includes EACA provisions for participants. Participants without an existing affirmative election shall be subject to the automatic enrollment provisions of the Plan. The employer automatically withholds 3% of eligible compensation each pay period contributed as pre-tax elective deferrals to the Plan. Participants who were automatically enrolled in the Mekanism 401(k) Plan under the Eligible Automatic Contribution Arrangement (EACA) before January 1, 2024, allow to make permissible withdrawals within 90 days of their enrollment.

Contributions (continued)

*Employer Contributions:*

- *Non-Elective Contributions:* The Company may make discretionary non-elective contributions as determined by the Company. To receive an allocation of Company non-elective contributions, participants must be employed by the Company on the last day of the Plan year.
- *Discretionary Matching Contributions:* The Company makes discretionary matching contributions in an amount as determined by the Company. To receive an allocation of Company matching contributions, participants must be employed by the Company on the last day of the Plan year.
- *Qualified Matching Contributions (QMACs):* The Company may make designate all or a portion of any matching employer contributions as a QMAC for nondiscrimination testing purposes. To receive an allocation of Company QMACs, participants must be a non-highly compensated employee for the plan year.
- *Qualified Non-elective Contributions (QNECs):* The Company may also designate all or a portion of any matching employer contributions as a QNEC for nondiscrimination testing purposes. To receive an allocation of Company QMACs, participants must be a non-highly compensated employee for the plan year.

All foregoing contributions are subject to limits as set by federal law.

Investment Options

Participants may direct the investment of all contributions into various investment options offered by the Plan and Fidelity Management Trust Company (Fidelity).

Participant Loans

Loans to participants consist of promissory notes received from participants in exchange for the distribution of cash from the Plan. A participant is allowed to borrow a minimum of \$1,000, up to one half of the vested balance of their Plan account, up to a maximum of \$50,000. Participants may only have one outstanding loan at any given time. Loans must be repaid over no more than a five-year period with the exception of a loan for the participants' principal residence that may have a repayment period beyond five years. Principal and interest are paid not less frequently than quarterly or ratably through payroll deductions. Loans to participants are stated at the principal amount outstanding, which approximates fair value.

Participant Accounts

Each participant's account is credited with the participant's own contributions and an allocation of net earnings from investments and changes in investment values. Allocations are based on each participant's contributions, earnings, or account balances, as defined by the Plan agreement. The benefit to which a participant is entitled is limited to the benefit that can be provided from the participant's account. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan.

Vesting

Participants are always fully vested in their own contributions, non-elective employer contributions, and all earnings thereon. Participants vest in Company matching contributions at the rate of 25% for each year of service until fully vested, beginning on the first year of credited vesting service after the date of hire. Participants are fully vested in Company contributions after four years of credited service.

Employees hired prior to May 1, 2019, and former Fuse Project employees hired before January 1, 2023 are fully vested for employer discretionary matching contributions.

Participants that merged into this plan from the Eleven 401(k) Plan on January 1, 2020, are fully vested for safe harbor non-elective contributions. Participants that merged into this plan from the Eleven 401(k) who terminated prior to January 1, 2020, are vested at 25% for each year of service until fully vested, beginning on the first year of credited service after the date of hire for non-elective contributions. Participants that merged into this plan from the Eleven 401(k) Plan with a date of hire prior to November 1, 2010, are fully vested in their employer matching and non-elective contributions.

All eligible participants that merged into this plan from the Mekanism 401(k) Plan on January 1, 2024 are fully vested for discretionary non-elective contributions for in-service withdrawals with 60-month restriction. All eligible employees that merged and terminated without 1 hour of service from Mekanism 401(k) Plan vest in Company discretionary match and profit-sharing contributions at the rate of 33% for each year of service until fully vested, beginning after 1 year of credited service for in-service withdrawals with 60-month restriction. Participants are fully vested in Company discretionary match and profit-sharing contributions after three years of credited service.

All eligible participants that merged into this plan from the We Are Social on January 26, 2024 vest in Company discretionary match contributions at the rate of 20% for each year of service until fully vested, beginning after 1 year of credited service for all terminated participants without 1 hour of service. Participants are fully vested in Company discretionary match contributions after five years of credited service.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Terminated participants whose balances are less than \$7,000 will be automatically distributed. For such balances exceeding \$7,000, subject to certain requirements, participants may leave their account balance in the Plan or the Plan can distribute after the last day of the Plan Year quarter coincident with or next following severance of employment. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Participants may request withdrawal from their contribution accounts for financial hardship or after attaining the age of 59½. The distribution of the participant's account must commence no later than April 1 following the calendar year in which the participant attains age 73.

Forfeitures

Forfeitures of nonvested employer contributions if any shall be used to reduce employer contributions and can be applied to reduce administrative expenses charged to the Plan, for the plan year in which they occurred or thereafter. During the year ended December 31, 2024, forfeitures totaling \$13,887 were utilized to reduce employer contributions and \$23,645 to pay administrative fees. As of December 31, 2024 and 2023, there were \$115,380 and \$19,989, respectively, in forfeiture nonvested accounts available for future use.

**NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The accompanying financial statements are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions which affect the reported amounts of net assets available for benefits at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Investment Valuation and Income Recognition

Investment contracts held by a defined contribution plan are required to be reported at fair value except for fully benefit-responsive investment contracts, which are reported at contract value. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by its investment advisors, custodians, and insurance company. See Note 4 for a discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis.

Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**NOTE 3: INFORMATION CERTIFIED BY THE CUSTODIAN (UNAUDITED)**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, Fidelity, the custodian of the Plan, has certified as being complete and accurate the following information as of December 31, 2024 and 2023, and for the year then ended December 31, 2024.

- Investments and notes receivable from participants are reflected on the accompanying statements of net assets available for benefits.
- Net appreciation in fair value of investments, net gain on sale of assets, unrealized appreciation of assets, interest from investments, dividends, and interest on participant loans are reflected on the accompanying statement of changes in net assets available for benefits.

**NOTE 4: FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Interest-bearing cash:* Valued at the daily closing price as reported by the fund.

*Registered investment companies (mutual funds):* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/collective trusts:* Valued at the NAV units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

*Self-directed brokerage accounts:* The fair values of the mutual funds, stocks, and bonds within the self-directed brokerage accounts are based on quoted market prices when available.

The valuation methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Net appreciation in fair value of investments includes net unrealized and net realized gains and losses on investments during the year and is presented net of investment expenses. Investment income is allocated to individual participant accounts based upon the participant's share of the investment fund.

**NOTE 5: FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS**

Standard Stable Asset II Fund is a fixed annuity contract issued by an insurance company that provides a guarantee of principal and interest backed by a general account of the issuing company. The general account consists of all the assets of the insurance company, including fixed income, equities, real estate, cash, and others. The issuing insurance company is contractually obligated to repay principal and interest at a specified rate to the Plan. There are no reserves against contract value for credit risk of the contract issuer or otherwise. Participants invested in the Standard Stable Asset II Fund have a beneficial interest in the fixed annuity contract. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Except for premature termination of the contract by the Plan or plan termination, the insurance company may not cause the contract to be terminated at an amount other than the contract value. The Plan Sponsor has not expressed any intention to take either of these actions. The Standard Stable Asset II Fund is deemed to qualify as a fully benefit-responsive investment contract; therefore, the contract value is the relevant measurement attribute.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are probable of not occurring. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

**NOTE 6: PLAN TERMINATION**

Although the Company expects to continue the Plan indefinitely, it has the right under the Plan to suspend its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all accounts become fully vested and are non-forfeitable. Plan assets would first be used to pay any expenses properly charged to the Plan. The remaining Plan assets would then be distributed to participants.

**NOTE 7: TAX STATUS**

The Company has adopted the FMR LLC Non-Standardized Pre-Approved Profit Sharing Plan with CODA. The Internal Revenue Service ("IRS") has informed FMR LLC in a letter dated June 30, 2020, that its pre-approved defined contribution plan is designed in accordance with applicable sections of the IRC, and any Plan Sponsor adopting this form of the pre-approved defined contribution plan will be considered to have a plan qualified under applicable sections of the IRC. Therefore, the Plan and related trust are tax-exempt, and once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified as a tax-exempt trust.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examination for years prior to 2021.

**NOTE 8: PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Fidelity. Fidelity is the custodian, as defined by the Plan, and therefore, these transactions qualify as party-in-interest. Any purchase and sales of investments in the custodian are open market transactions at fair market value. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments. These fees are paid to the investment fund manager and may include certain revenue sharing fees that are paid to Fidelity, other investment custodians, and investment advisors.

Additionally, the Plan Sponsor, Plus Company U.S. Inc., is also a party-in-interest to the Plan; however, there were no transactions with the Plan Sponsor other than the funding of contributions to the Plan and payment of certain administrative expenses of the Plan. The Plan also allows for the issuance of notes receivable to participants in accordance with the related regulations. Such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA.

**NOTE 9: RESTATEMENT**

Beginning net assets available for benefits as of December 31, 2023 were restated for prior period adjustments. The adjustment relates to an understatement of employer contributions receivable and an understatement of employer contributions received. Net assets available for benefits of the Plan as of December 31, 2023 have been restated from \$40,208,261 to \$40,903,799.

**NOTE 11: RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 12: SUBSEQUENT EVENTS**

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits but arose after the statement of net assets available for benefits date and before the financial statements are available to be issued.

The plan has evaluated subsequent events through August 28, 2025, the date the financial statements were available to be issued.
