### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of The Academy 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### *Opinion*

- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by qualified institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).



### ***Basis for Opinion***

### 1. Description of the Plan

The following description of The Academy 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document and any amendments thereto for a more comprehensive description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan generally covering substantially all employees of Academy Parent, LLC (the Company) who are age 21 or older. The Plan was established on January 1, 2019, was most recently restated on September 9, 2024, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective May 10, 2024, the Company's Fiduciary Investment Committee was created and became responsible for the oversight of the Plan and the monitoring of investment performance. The Company retains an independent investment advisor to ascertain the appropriateness of the investment options offered by the Plan, and to recommend changes to the investment options as considered necessary.

#### *Trustee and Administration of the Plan*

The recordkeeper of the Plan is T. Rowe Price Trust Company (TRP). Prior to September 9, 2024, the trustee of the Plan was Reliance Trust Company (Reliance Trust). Effective September 9, 2024, the Plan was amended to reflect a change in the trustee from Reliance Trust to TRP. The administrator of the Plan is the Company. The trustee holds all assets of the Plan in accordance with the service provider contract with the Company.

As a result of this change, participants may no longer contribute to investment options offered by Reliance Trust. The Company and investment adviser completed a mapping of the previous investment options to the new investment options provided by TRP.

#### *Contributions*

The Plan allows each eligible participant to defer his or her compensation up to the maximum allowed by the Internal Revenue Code (IRC), as defined by the Plan.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

In addition, the Plan allows for catch up contributions by employees aged 50 years and older before the end of the Plan year. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions), as defined in the Plan's provisions. For the year ended December 31, 2024, rollover contributions totaled \$512,001.

The Company may make a discretionary matching contribution as determined annually by management. For the year ended December 31, 2024, the Company elected to match 50% of each

participant's deferral contributions up to 6% of his or her compensation. Both employee and employer contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participants direct the investment of their contributions and the Company's contributions made on their behalf into various investment options offered by the Plan. The Plan currently offers various mutual funds, a money market fund and a collective trust fund as investment options for participants.

### ***Participant accounts***

Each participant's account is credited with the participant's contributions, the Company's matching contribution and Plan earnings and losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

### ***Vesting***

Participants are immediately vested in their pre-tax elected salary deferrals, rollover contributions, plus actual earnings or losses thereon. Vesting in the employer contributions is based on years of continuous service. A participant is 100% vested in employer matching contributions ratably over a three-year grading schedule as follows:

One	33%
Two	66%
Three or more	100%

### ***Forfeited accounts***

The Company maintains a separate forfeiture account with the Plan trustee. When an employee terminates prior to full vesting, the Plan's cumulative, unvested matching contributions made on behalf of the participant, as well as earnings and losses thereon, are transferred to the Plan's forfeiture account. These forfeitures are first used to reduce employer contributions and then to reduce Plan expenses. As of December 31, 2024 and 2023, the Plan had a total of \$44,418 and \$0, respectively, in forfeitures available to reduce future employer contributions and plan expenses. For the year ended December 31, 2024, a total of \$2,389 of forfeitures were used to reduce pay plan expenses.

### ***Notes receivable from participants***

Participants may borrow from their accounts a minimum of \$1,000 or up to a maximum amount equal to the lesser of (i) 50% of the participant's vested account balance, or (ii) \$50,000 reduced by the excess of the participant's highest outstanding balance of loans during the one year period ending on the day before the date of the new loan, over the current outstanding balance of loans as of the date of the new loan. Notes receivable from participants are secured by the balance in the participant's account and bear interest at the prime rate at the time the note was approved

plus 1%. Repayment terms range from one to five years or up to ten years for the purchase of a primary residence. Principal and interest is paid ratably through payroll deductions.

### *Payment of benefits*

Upon termination of service due to death, disability, retirement or any other reason, a participant or beneficiary may elect to receive an amount equal to the value of the participant's vested interest. Upon termination of service, if the vested value of a participant's account is less than \$5,000, his or her account will be distributed in a single lump-sum payment. Participants may elect to withdraw from their accounts in the event of proven financial hardships.

## **2. Summary of Significant Accounting Policies**

### *Basis of accounting*

The Plan's financial statements are maintained on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

### *Use of estimates*

The preparation of financial statements in conformity with GAAP requires the Plan's management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from estimated amounts.

### *Investment valuation and income recognition*

Investments held by the Plan are reported at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment trustee. See Note 4 for additional information related to fair value measurements.

The Plan's shares of mutual funds and money market funds are valued at quoted market prices which represent the net asset value (NAV) of shares held by the Plan at each year end. The NAV is used as the practical expedient to estimate fair value. The Plan's investment in collective trusts are valued at the NAV of units of the collective trust fund. The NAV, as provided by the trustee of the collective trust, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily. The collective trusts are direct filing entities and there are no unfunded commitments.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Purchases and sales of securities are recorded principally on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Payment of benefits***

Benefits are recorded when paid.

### ***Administrative expenses***

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

### ***Contributions Receivable***

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation.

### ***Recent accounting pronouncements not yet adopted***

In June 2022, the Financial Accounting Standards Board (FASB) issued Accounting Standards Update (ASU) 2022-03, *Fair Value Measurement of Equity Securities Subject to Contractual Sale Restrictions*, to clarify that a contractual restriction on the sale of an equity security is not considered part of the unit of account of the equity security and is not considered in measuring the fair value of the equity security in accordance with ASC 820, *Fair Value Measurements*. ASU 2022-03 also adds certain disclosures for equity securities subject to contractual sales restrictions. The new ASU is effective and applied prospectively for public business entities for fiscal years beginning after December 15, 2023, and for all other entities is effective and applied prospectively for fiscal years beginning after December 15, 2024. Management is evaluating the effect that adoption of this new standard will have on the Plan's financial statements.

## **3. Certified Investment Information**

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedules, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust and TRP, qualified institutions.

## **4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest

priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

### 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to reduce or discontinue contributions, terminate the Plan subject to the provisions of ERISA, or both. In the event of Plan termination, participants would become 100% vested in their accounts.

### 6. Income Tax Status

Effective January 1, 2019, and as amended both January 1, 2024 and September 9, 2024, the Plan adopted the T. Rowe Price Defined Contribution Pre-Approved Plan (Pre-Approved Plan). The IRS ruled on June 30, 2020, that the Pre-Approved Plan, including related amendments, as designed, was in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 7. Prohibited Transactions

During the year ended December 31, 2023, the Company failed to segregate and remit in a timely manner certain participant contributions (salary reduction amounts) from its assets within the required time period as specified by the United States DOL Reg. 2510.3012. Failure to segregate and remit contributions within the specified time period is a prohibited transaction according to the provisions of ERISA and the IRC. The Company remitted these contributions to the Plan shortly after the required time frame and has remitted lost earnings associated with the late remittances in 2024.

### 8. Related Party Transactions and Party-in-Interest Transactions

Party-in-interest transactions include those transactions with fiduciaries or employees of the Plan, any person who provided services to the Plan, an employer whose employees were covered by the Plan, employee organizations whose members were covered by the Plan, a person who owned 50% or more of such an employer or employee organization, or relatives of such persons.

As of December 31, 2024 and 2023, and during the year ended December 31, 2024, the Plan held investments and traded in mutual funds, a money market fund, and collective trust funds held by Reliance Trust and TRP, who are the trustees effective from the period prior to and following September 9, 2024, respectively, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions and are exempt from the prohibited transaction rules of ERISA.

### 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### 10. Subsequent Events

The Plan Administrator has evaluated subsequent events through September 11, 2025, the date the financial statements were available to be issued. The Plan Administrator is not aware of any subsequent events which would require recognition or disclosure in the financial statements.
