

NOTE 1 - PLAN CREATION

Sumitomo Rubber USA, LLC (the “Company” or “Plan Sponsor”), formerly Goodyear Dunlop Tires North America, Ltd., and the United Steelworkers Local Union No. 135 Buffalo, New York (the “Union”) created the Sumitomo Rubber USA, LLC Supplemental Unemployment Benefits Plan (the “Plan”), formerly the Goodyear Dunlop Tires North America, Ltd. Supplemental Unemployment Benefits Plan, effective October 1, 2015. The Plan’s assets are held in the Sumitomo Rubber USA, LLC Superfund Trust (the “Trust”).

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Plan Year

Under the terms of the agreement, the Plan Year is the calendar year.

Basis of Accounting

The accounts of the Plan are maintained on a modified cash basis, which reflects actual cash receipts and disbursements, accruals for interest income, and increases or decreases in the fair value of investments which are recognized currently. The accounts do not include accruals for contributions or allowable expenses. The modified cash basis is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America.

Financial Data Certified by Trustee

All investment related information in the Statements of Net Assets Available for Benefits (modified cash basis), and the Statement of Changes in Net Assets Available for Benefits (modified cash basis) has been certified complete and accurate or derived from information certified complete and accurate by PNC Bank, National Association (the “Trustee”) in accordance with Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

Use of Estimates

The preparation of financial statements on the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from assets during the reporting period. Actual results could differ from those estimates.

Valuation of Investments, Security Transactions, and Interest Income

Investments are stated at fair market value. Interest income is accrued and gains and losses are recognized as earned.

Subsequent Events

The Plan has evaluated subsequent events through September 9, 2025, the date the financial statements were available to be issued.

NOTE 3 - GENERAL DESCRIPTION AND OPERATION OF THE PLAN

The following brief description of the Plan is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information. The Plan is subject to the provisions of ERISA.

The Plan is a supplemental unemployment benefit plan covering hourly employees who are members of the Union. The Company contributes to the Plan at rates specified in the Plan agreement.

The Plan provides benefits to participants for regular layoffs and short work weeks, provided they have accumulated in the current year, or in prior years, credit units in excess of the credit units required for payment at the time the request is filed. Accumulated credit units equal to one year's coverage may be carried forward. Credit units shall have no fixed value in terms of money, but shall be a means of determining eligibility for and duration of benefits.

Allowable expenses paid by the Plan (and Trust established under the Plan) include expenses of the Trustee incurred in the administration of the Plan. The Plan may also pay the fees of the independent auditors, however the Company has paid this expense for the year ended December 31, 2024. All other administrative costs are paid by the Company. If terminated, the Plan assets shall be used until exhausted to pay benefits to eligible employees and administrative expenses.

The Plan agreement specifies that investments shall be held only in general obligations of the United States Government or in other investments fully secured by such obligations.

NOTE 4 - BENEFIT OBLIGATION

As stipulated in Article VI, Section 4 of the Plan agreement, the maximum liability of the Plan shall be no more than the fair market value of the trust fund.

NOTE 5 - TAX STATUS

It is the Plan's intention that the Trust, adopted by the Plan, and Plan are to be organized and operated as tax-exempt under the appropriate sections of the Internal Revenue Code ("IRC"). Once determined to be tax-exempt, the Plan is required to operate in conformity with the IRC to maintain its tax-exempt status. The Plan Sponsor is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's tax status. Therefore, no provision for income taxes has been included in the Plan's financial statements.

NOTE 6 - TRANSACTIONS WITH PARTY-IN-INTEREST

During the year, the Plan paid fees to the Trustee for administration of the Plan.

NOTE 7 - FAIR VALUE MEASUREMENTS

Assets and liabilities measured at fair value are classified using the following hierarchy, which is based upon the transparency of inputs to the valuation as of the measurement date:

- Level 1 – Valuation is based upon quoted prices (unadjusted) for identical assets or liabilities in active markets.
- Level 2 – Valuation is based upon quoted prices for similar assets and liabilities in active markets, or other inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument.
- Level 3 – Valuation is based upon other unobservable inputs that are significant to the fair value measurement.

The classification of fair value within the hierarchy is based upon the lowest level of input that is significant to the measurement. The valuation methodologies used for assets measured at fair value is as follows:

Money market fund: Valued at the NAV of shares held by the Plan at year end, as determined by the closing price reported on the active market on which the individual securities are traded.
