Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of John Stuckey Ford, Inc. Profit-Sharing 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statement of net assets available for plan benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for plan benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Opinion

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control related matters that we identified during the audit.



NOTES TO FINANCIAL STATEMENTS

Note 1. Plan Description

The following description of John Stuckey Ford, Inc. Profit-Sharing 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all eligible nonunion employees of John Stuckey Ford, Inc., Stuckey Subaru, LLC; Stuckey Buick GMC, Inc., Stuckey Automotive Collision Center, Inc., Stuckey Automotive State College, Inc., Stuckey Ford Bellefonte, Inc., Stuckey Automotive Huntingdon Inc., Stuckey Automotive Inc. and Stuckey Automotive State College II, Inc. DBA Stuckey Nissan (collectively, hereinafter referred to as the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and is intended to comply with Section 401(a) of the Internal Revenue Code of 1986. Effective January 1, 2022, the Plan was restated as part of the required cycle three restatement for preapproved plans. No changes were made to the Plan as a result of the restatement.

Eligibility: Employees may participate in the Plan on the date on which they attain age 18 and complete three consecutive months of service (during which at least 250 hours of service are completed). Employees are eligible to receive discretionary employer matching contributions immediately upon plan entrance. Participants are eligible to receive a discretionary profit-sharing contribution if they complete 1,000 hours of service and are employed on the last day of the plan year.

Union employees whose employment is governed by a collective bargaining agreement under which retirement benefits are present and part-time, temporary and seasonal employees whose regularly scheduled service is less than 1,000 hours per year are not permitted to participate in the plan beginning on or after January 1, 2019.

Effective July 6, 2021, the Company acquired Joel Confer Ford of Bellefonte. Employee's past service was permitted in satisfying the Plan's eligibility requirements and eligible employees entered the Plan immediately upon beginning employment with the company.

Effective January 1, 2022, the company enabled long-term part-time (LTPT) employees to be eligible for the plan after meeting the following requirements: a.) three consecutive years of service beginning after December 31, 2020, with at least 500 hours of service each year b.) attainment of age 21. The entry date as an LTPT Participant for all Plan purposes will be the first day of the first month or the first day of the seventh month of the Plan Year coincident with or next following the date you meet the requirements to be an LTPT Employee.

Effective October 15, 2023, the Company acquired Jim Price Cassville Motors Sales, Inc. DBA Price Motor Sales, Inc. Employee's past service was permitted in satisfying the Plan's eligibility requirements and eligible employees entered the Plan immediately upon beginning employment with the company.

Effective May 8, 2024, the Company acquired Stuckey Automotive, Inc. and Stuckey Automotive State College II, Inc. DBA Stuckey Nissan. Employee's past service was permitted in satisfying the Plan's eligibility requirements and eligible employees entered the Plan immediately upon beginning employment with the company.

Note 1. Plan Description (Continued)

Contributions: Each year, participants in the Plan may contribute up to the maximum amount allowed by the Internal Revenue Service into either a regular 401(k) account (pre-tax) or a Roth 401(k) (after-tax) elective deferral account, as defined in the Plan agreement. Participants aged 50 or older may elect to defer additional “catch-up” amounts. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Company may make a discretionary matching contribution. For 2024, the Company matched 40% of the first 8% of gross compensation that a participant contributed to the Plan. For 2023, the Company matched 25% of the first 12% of gross compensation that a participant contributed to the Plan. The Company may also make a discretionary profit-sharing contribution. The Company did not make a profit-sharing contribution in 2024.

Participant Accounts: Each participant’s account is credited with the participant’s contributions, the Company’s matching contributions and allocations of (a) the Company’s profit-sharing contribution, if any, and (b) Plan earnings, net of administrative expenses. Plan earnings or losses are allocated according to the participant’s relative account balance in the various investment options. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.

Investment Options: Participants direct their salary deferral and matching contributions to selected investments made available and determined by the Plan Administrator. Participants may change their investment allocations at any time.

Vesting: Participants are immediately vested in their salary deferral and rollover contributions plus actual earnings thereon. Participants are fully vested in employer contributions after one year of service. Participant accounts become fully vested upon normal retirement at age 62, early retirement at age 55, death or if totally disabled.

Participant Loans: Participants may have one outstanding loan at any time and may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms may not exceed sixty months, unless the loan is for the purchase of a principal residence. All outstanding loan balances become due and payable in their entirety upon severance of employment unless directly rolled over (if otherwise permitted) to another employer’s plan. The applicable interest rate for new loans is 1% above the prime interest rate. While an employee, the loan must be repaid via payroll withholdings with a minimum amortization schedule of level installments.

Payment of Benefits: A participant shall be entitled to receive all or a portion of the balance held in his or her account upon termination of employment, retirement, reaching age 59 ½, death, or disability, or in the event of a severe financial hardship as defined by the plan. Hardship distributions may only be made from accounts which are fully vested. Participant benefits are paid in a lump sum payment. Vested balances of less than \$7,000 may be automatically distributed without participant consent in a single lump-sum payment.

Note 1. Plan Description (Continued)

Forfeitures: A participant's accrued vested benefit is determined on the date employment is terminated. The non-vested portion is forfeited upon total distribution of individual's account. Forfeitures of participants' non-vested accounts are used to offset employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$2,022 and \$2,401, respectively. Forfeitures of \$13,365 were used in 2024 to reduce employer matching contributions.

Administrative Expenses: Plan fees and expenses may be paid by the Plan if not paid by the Plan Sponsor.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting: The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits: Benefits are recorded when paid.

Notes Receivable from Participants: Note receivables from participants are measured at the unpaid principal balances plus any accrued interest. Delinquent loans are treated as distributions based upon the terms on the plan document surrounding defaulted loans.

Subsequent Events: In preparing these financial statements, the Plan Sponsor has evaluated subsequent events and transactions for potential recognition or disclosure through September 4, 2025, the date the financial statements were available to be issued. See Note 9.

Note 3. Information Certified by the Custodian

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to information certified as complete and accurate by Capital Bank and Trust Company (CB&T), the Custodian of the Plan.

Note 4. Investments and Fair Value Measurements

The Plan measures on a recurring basis its investments at fair value in accordance with the Financial Accounting Standards Board (FASB) codification *Fair Value Measurement*, which provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The three levels of the fair value hierarchy are as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that are accessible to the Plan. These generally provide the most reliable evidence and are used to measure fair value whenever available.
- Level 2 Inputs to the valuation methodology include significant inputs, other than Level 1 inputs, that are observable either directly or indirectly for substantially the full term of the asset through corroboration with observable market data. Level 2 inputs include quoted prices for similar assets in active markets, quoted market prices in markets that are not active for identical or similar assets, and other observable inputs.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

All investments in the Statements of Net Assets Available for Plan Benefits are reported at fair value. The Plan's investments consist of registered investment companies and a collective investment trust. The following are descriptions of valuation methodologies used for assets at fair value. There have been no changes in the methodologies used at December 31, 2024.

Registered Investment Companies: Shares of registered investments companies (mutual funds) are valued at the daily closing price as reported by the funds. The funds held by the Plan are open-end mutual funds registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded.

Note 4. Investments and Fair Value Measurements (Continued)

Collective Investment Trust: The collective investment trust is valued based upon the net asset value (NAV) of units of the collective trust as reported to the Plan by the trust. Net asset value is used as a practical expedient to estimate fair value because it is unlikely that the trust would sell the investment for an amount different than the reported net asset value. The units of each share class of the collective trust are valued daily based on closing market prices of the underlying investments. The NAV per unit is computed by dividing the total assets of the trust, less its liabilities, by the total number of units outstanding as of the valuation date. Investment income earned is reinvested in the trust and included in the determination of unit values.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain investments or financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Plan Termination

Although it has not expressed any intent to do so, the employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their accounts.

Note 6. Related Party and Party-in-Interest Transactions

Certain Plan investments are shares of registered investment companies managed by American Funds, which is a related party to Capital Bank and Trust Company, the Custodian of the Plan; therefore, these transactions qualify as party-in-interest transactions.

Note 7. Tax Status

Effective January 1, 2022, The Plan adopted a non-standardized pre-approved plan sponsored by FIS Business Systems, LLC. The non-standardized pre-approved plan has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, as to the plan's qualified status. The IRS has determined that the non-standardized pre-approved plan is designed in accordance with the applicable sections of the Internal Revenue Code (IRC). The non-standardized pre-approved plan opinion letter has been relied upon by this Plan. Although the Plan has since been amended, the Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

Note 7. Tax Status (Continued)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits.

Note 9. Subsequent Events

The plan changed its name to Stuckey Automotive Employees' Retirement Savings Plan as of February 1, 2025.
