***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Sietsema Farms 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Sietsema Farms 401(k) Plan Financial Statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note D to the financial statements, is complete and accurate.

## **Opinion**

### **Note A – Description of Plan**

The following description of the Sietsema Farms 401(k) Plan (Plan) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

#### **General**

The Plan was established on January 1, 1977, and was restated as of January 1, 2024. The Plan is a defined contribution plan covering all employees of Sietsema Farms 401(k) Plan and the related entities.

Sietsema Farms 401(k) Plan, (the Company) is the plan sponsor. Eligible employees can become participants in the Plan once they have obtained the age of 21 and have three months of service. Upon participation in the Plan, an employee becomes eligible to receive the employer safe harbor contribution. The Plan is qualified under Section 401(a) and the trust has been exempt from federal income tax under Section 501(a) of the Internal Revenue Code of 1986, as amended. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### **Contributions**

Participants may elect to contribute a percentage of their compensation to the Plan each year, subject to statutory limitations, as defined in the Plan. Participants who attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified plans (rollovers). The Company contributed a safe harbor match which is a direct match of the employee contribution up to four percent of eligible compensation.

#### **Plan Operations**

The Company has appointed Macatawa Bank to serve as Trustee, American Trust Company, to serve as custodian and recordkeeper, and the Company to act as plan administrator. The Trustee is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment strategy and monitors investment performance. The custodian is responsible for holding the investment assets of the Plan, executing investment transactions, and making distributions to the participants. The plan administrator interprets and communicates the provisions of the Plan, ensures that all government and participant reporting requirements are fulfilled and approves all distributions from the Plan to participants.

#### **Participant Accounts**

Individual accounts are maintained for each participant, with benefits limited to the participant's contributions, the participant's share of the Company safe harbor contributions plus or minus any allocation of income, expenses, gains, or losses. Allocations are based on participants' compensation or account balances as defined in the Plan Agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

### **Note A – Description of Plan (Continued)**

#### **Vesting**

Participants are immediately vested in their voluntary contributions, employer safe harbor contributions, rollover contributions and actual earnings thereon. Vesting in the employer discretionary contribution accounts is based on years of continuous service, as follows:

<u>Years of Service</u>	<u>Vesting Percentage</u>
Less than 2 years	0%
2 years	20%
3 years	40%
4 years	60%
5 years	80%
6 or more years	100%

An employee must complete 1,000 hours of service to receive credit for one year of service.

A participant also becomes fully vested at the time of the participant's death, if the participant becomes disabled while employed, or upon attainment of normal retirement age.

#### **Loans to Participants**

Under certain conditions, a participant may obtain a loan from the Plan. A participant may not request a loan less than \$1,000 with a maximum amount not to exceed the lesser of \$50,000 or one half of the participant's nonforfeitable interest in the Plan. The loan will bear a reasonable interest rate (1% above prime), be adequately secured, and not exceed a period of five years (unless used for the purchase of a primary residence). Principal and interest is paid ratably through payroll deductions. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

#### **Payment of Benefits**

Each participant's benefits are payable as of the earlier of the participant's termination of employment or having attained age 59½. Participants with balances of \$5,000 or less will receive a lump-sum distribution in an amount equal to his or her vested account balance. Participants with balances in excess of \$5,000 may either receive a lump-sum distribution in an amount equal to his or her vested account balance, or they may elect to receive installment payments. Active participants may also take in-service distributions from the Plan upon attainment of age 59½.

### ***Note A – Description of Plan (Continued)***

#### **Hardship Withdrawals**

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document. The plan administrator must approve any such hardship withdrawals.

#### **Costs and Expenses**

The Plan's record keeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses of the Plan. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan. All other expenses of the Plan are paid by the Company.

#### **Forfeited Accounts**

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures of non-vested Company contributions remain in the Plan to reduce future company contributions or pay administrative expenses of the Plan. The balance in the forfeiture account at December 31, 2024 and 2023, was \$293 and \$479, respectively. There were no forfeitures used during the year ended December 31, 2024. Forfeitures of \$27 were used to reduce plan expenses during the year ended December 31, 2023.

### ***Note B – Summary of Accounting Policies***

#### **Basis of Accounting**

The financial statements of the Plan are prepared using the accrual basis of accounting.

#### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

#### **Benefits**

Benefits are recorded when paid.

### ***Note B – Summary of Accounting Policies (Continued)***

#### **Investments and Income Recognition**

Investments are reported in the Plan's financial statements at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Income from interest is recorded as it is earned. Dividends are recorded on the ex-dividend date. Purchases and sales of securities are recorded on a trade date basis. Net appreciation or depreciation of investments is determined using the value at the beginning of the year or purchase price if acquired since that date. Management fees and operating expenses charged to the Plan for investments in the mutual funds and common/collective trust funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

#### **Subsequent Events**

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through September 12, 2025, which is the date the financial statements were available to be issued.

### ***Note C – Fair Value Measurements***

The Plan's investments are reported at fair value in the accompanying Statements of Assets Available for Benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **Note C – Fair Value Measurements (Continued)**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – inputs are unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.

Level 2 – inputs to the valuation methodology include:

- quoted prices for similar assets and liabilities in active markets
- quoted prices for identical or similar assets and liabilities in markets that are not active
- other inputs that are observable or can be corroborated by observable market data
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – inputs are generally unobservable and significant to the fair value measurement. Such inputs typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability, including certain pricing models, discounted cash flow methodologies, and similar techniques that use significant unobservable inputs.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued based on quoted net asset values of the shares held by the Plan on the last business day of the plan year.

*Common/collective trust funds:* Valued based on quoted net asset values (NAV) of the shares held by the Plan on the last business day of the plan year.

### ***Note D – Information Certified by Certifying Entities***

All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest income on notes receivable from participants and interest and dividends for the years then ended, were obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Macatawa Bank for the period January 1, 2023 through October 27, 2023 and American Trust Company effective October 27, 2023 through December 31, 2024, the certifying entities.

### ***Note E – Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Assets Available for Benefits.

### ***Note F – Party-In-Interest Transactions***

Fees paid by the Plan to parties-in-interest for services rendered to the Plan were \$45,968 and \$31,045 for the years ended December 31, 2024 and 2023, respectively. Such fees were based on reasonable and customary rates.

In addition, the Plan maintains notes receivable from participants. These party-in-interest transactions are exempt from the prohibited transaction rules under ERISA.

### ***Note G – Plan Termination***

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan document and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account.

### ***Note H – Plan Transfers***

Effective April 2024, Allendale Hardware, Inc. was no longer a participating employer. Participants' balances were transferred to another plan during the year ended December 31, 2024.

### ***Note I – Tax Status***

The Plan, as adopted, is a volume submitter plan, which does not require an application for a determination letter from the Internal Revenue Service (IRS). The volume submitter plan has received a favorable opinion letter from the IRS dated June 30, 2020. Although the Plan has been amended from the original prototype document, Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### ***Note J – Subsequent Amendment***

Effective January 1, 2025, the plan was amended to include White Acres, LLC as a participating employer.
