Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Chet Morrison Contractors 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

Note 1. Description of Plan

The following description of the Chet Morrison Contractors 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Chet Morrison Contractors, LLC (the Company) who have three months of service. An eligible employee may enter the Plan on the first day of the month coinciding with or following the date the employee satisfies the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Each year, participants may elect to contribute portions of their eligible compensation, up to the maximum allowable under the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Company may make discretionary matching contributions not to exceed 6% of the participant's compensation. Employer matching contributions do not apply to catch-up contributions. Additional profit-sharing contributions may be made at the discretion of the Company. The Company made a discretionary matching contribution of \$741,980 to the Plan for the year ended December 31, 2024. There were no profit-sharing contributions for the year ended December 31, 2024.

Participant Accounts

Participants direct the investment of their contributions into various investment options offered by the Plan. Each participant's account is credited with the participant's contribution, the Company's match contribution, plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000, up to a maximum of \$50,000, or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's vested account and bear an interest rate which is determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions as determined by the pay frequency of the participants.

Notes to Financial Statements

Note 1. Description of Plan (Continued)

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Participants become vested in the Company's discretionary contributions and earnings thereon based on the following vesting schedule:

Payment of Benefits

Distributions from the Plan's assets are made upon the participant's death, disability, retirement, termination of service, or other circumstances as described in the Plan Document. Upon termination a participant whose vested account balance did not exceed \$5,000 valued at the time of the distribution would receive an immediate lump-sum payment. If no election is made, the Plan Administrator will pay the distribution in a direct rollover to an individual retirement account. A participant whose vested account balance exceeds \$5,000 valued at the time of distribution may defer the payment of benefits until April 1 of the calendar year following the calendar year during which the participant attains 72. Fully vested participants who have attained age 59½ and who have not separated from service may obtain distributions of their account balance. Additionally, under certain circumstances of financial hardship, the participant is allowed to withdraw funds from the Plan.

Forfeitures

When certain terminations of participation in the Plan occur, the non-vested portion of the participant's account, as defined by the Plan, represents a forfeiture. Forfeitures are held in a money market account within a pooled separate account of Voya Retirement Insurance and Annuity Company (Voya), the Plan's trustee, and may be used to reduce any Company contribution or pay allowable plan operational expenses, or allocated to all participants based on the participant's proportionate compensation for the plan year, as outlined in the Plan Document. During the year ended December 31, 2024, forfeitures used to pay plan operational expenses totaled \$4,135. During the year ended December 31, 2024, \$145,475 of forfeitures was also used to provide a discretionary employer contribution. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$4,933 and \$3,126, respectively.

Note 1. Description of Plan (Continued)

Excess Contributions Payable

Participant contributions received during the years ended December 31, 2024 and 2023 are net of payments of \$-0- and \$55,236 made subsequent to December 31, 2024 and 2023, respectively, to active participants to return to them excess deferred contributions as required to satisfy the relevant non-discrimination provisions of the Plan. The amounts are included in the Plan's statements of net assets available for benefits as excess contributions payable at December 31, 2024 and 2023.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination or partial plan termination, participants will become fully vested in their accounts.

Plan Expenses

Plan expenses not paid by the Plan are paid by the Company.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based on the terms of the Plan Document. Related fees are recorded as administrative expenses and expensed when they are incurred directly to the participant's account. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Note 2. Summary of Significant Accounting Policies (Continued)

Tax Status

The Plan has adopted a preapproved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the IRC. The Plan has been amended since adopting the preapproved plan document; however, the Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Contributions

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits

Benefits are recorded when paid.

Note 4. Fair Value Measurements

The *Fair Value Measurement* Topic of the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full-term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts: Valued at the market value of the underlying mutual funds as adjusted for the Plan's participation units in the pooled accounts.

The method described above may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

- a) This category primarily consists of a diversified portfolio of stocks that has capital appreciation as its primary goal, with little or no payouts. Portfolio companies would mainly consist of companies with above-average growth in earnings that reinvest their earnings into expansion, acquisition, and/or research and development.
- b) This category includes funds seeking various returns of capital appreciation and current income. The funds invest primarily in equity and fixed income funds, with the allocations varying by each investment's individual strategy.
- c) This category primarily holds funds that are deemed to be undervalued in price and that are likely to pay dividends.
- d) This category includes funds constructed to match or track the components of a market index, such as the Standard & Poor's 500 Index. An index fund is said to provide broad market exposure, low operating expenses, and low portfolio turnover.
- e) This investment seeks total return comprised of income and capital appreciation, while maintaining a secondary emphasis on capital preservation. To achieve its investment objective, the fund invests primarily in an allocation of fixed income investments of varying maturities and credit qualities.
- f) These securities are issued by governments and corporations. These investments typically generate regular interest payments, and investor's principal is returned along with any accrued interest. Its goal is to preserve capital and manage volatility.

- g) This category automatically resets the asset mix of stocks, bonds, and cash equivalents in its portfolio according to a selected time frame that is appropriate for a particular investor.
- h) This category tends to divide their assets among 20 or more nations, although they tend to focus on the emerging markets of Asia and Latin America rather than on those of the Middle East, Africa, or Europe. These portfolios invest predominantly in emerging market equities, but some funds also invest in both equities and fixed income investments from emerging markets.

Note 5. Investment Contract with Voya Retirement Insurance and Annuity Company

The Plan allows participants to invest in a traditional annuity contract in which the invested funds are held in an insurance company general account which supports insurance and annuity obligations. This option is the Voya Fixed Account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

Because the investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the investment contract. Contract value, as reported in the Plan by Voya, represents contributions made under the contract, plus earnings less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The investment contract has a guarantee that the interest rate will not go below a floor rate, which is 1%. Such interest rate is reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan Documents (including complete or partial plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options; (3) bankruptcy of the Plan Sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that significantly affect the Plan's normal operations; (4) the failure of the Plan to qualify under 401(a) of the IRC or the failure of the trust to be tax exempt under Section 501(a) of the IRC; or (5) premature termination of the contract.

The Plan Administrator believes that no events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer, and that also would limit the ability of the Plan to transact at contract value with the participants.

Note 7. Risks and Uncertainties

The Plan invests in various investments as directed by participants. The underlying investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 8. Related-Party and Party-in-Interest Transactions

The Plan Administrator has evaluated subsequent events through the date that the financial statements were available to be issued, August 27, 2025, and determined that the following event requires disclosure.

In July 2025, the Plan was amended to retroactively change the required minimum distribution (RMD) age to 72 for participants born after June 30, 1949 for RMDs made after December 31, 2019. It was also amended to retroactively allow Long-Term Part Time employees to become eligible following certain conditions are met beginning after December 31, 2020.

No subsequent events occurring after August 27, 2025 have been evaluated for inclusion in these financial statements.
