## INDEPENDENT AUDITOR'S REPORT

To the Participants and Administrator of the  
All Truck Transportation Co., Inc. 401(k) Profit Sharing Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of the All Truck Transportation Co., Inc. 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ["ERISA Section 103(a)(3)(C) audit"]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

## NOTES TO THE FINANCIAL STATEMENTS

## NOTE 1 – DESCRIPTION OF PLAN

The following description of All Truck Transportation Co., Inc. 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more comprehensive description of its provisions.

**General.** The Plan is sponsored by All Truck Transportation Co., Inc. and Emjay Sales and Leasing, Inc. (the “Company”), as defined in the Plan. The Plan is a defined contribution plan, that covers all full-time employees of the Company. The Company controls and manages the operation and administration of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

**Eligibility.** Employees, except those covered by a collective bargaining agreement or that are classified as overflow work drivers, are eligible to participate upon completion of three consecutive months of service.

**Participant Contributions.** An eligible employee may elect to contribute a flat amount or a percentage of their earnings to the Plan, which are limited and subject to amounts established by the Internal Revenue Code (the “Code”). Participant contribution elections may be changed by participant at any time. A participant’s earnings consist of total cash compensation of an employee including vacation pay, bonuses, tips, and overtime pay in a plan year. Participants may also contribute “catch-up” contributions and amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

**Employer Contributions.** The Company makes discretionary matching contributions equal to 50% of the participant's contributions, up to 4% of eligible compensation. The Plan also allows for the Company to make a discretionary nonelective contribution to those participants still actively employed on the last day of the Plan year and who have earned at least 1,000 hours of service during the Plan year. No such contribution was made for the year ended December 31, 2024.

**Participant Accounts.** Each participant’s account is credited with the participant’s contributions, Company matching contributions, and allocation of (a) the Company’s discretionary non-elective contribution, if any, and (b) Plan earnings or losses, and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting.** Participants are immediately vested in their employee contributions plus actual earnings or losses thereon. Vesting in Company matching contributions and profit sharing, if any, and earnings thereon, is based on years of service and is determined as follows:

**Investment Options.** Participants can direct employee and Company contributions into any of the several investment alternatives provided by the Fidelity Management Trust Company, the trustee of the Plan (“Trustee”) and qualified institution under ERISA. Participants may change their investment options at any time.

**Notes Receivable from Participants.** Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant’s account and bear interest at rates assigned at loan inception. Principal and interest are paid ratably through payroll deductions.

## NOTE 1 – DESCRIPTION OF PLAN (Concluded)

**Payment of Benefits.** On termination of service due to death, disability, or retirement or for any other reason, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or installment or partial withdrawal payments. In addition, hardship distributions out of the participant's voluntary contribution and vested Company contribution accounts are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2 from the participant's vested account balance.

**Forfeitures.** Forfeited balances of terminated participants' non-vested accounts are used to reduce Plan administrative expenses or future Employer contributions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. There were no forfeited non-vested accounts as of December 31, 2024 and 2023. There were \$6,560 of forfeitures used to offset Employer contributions and to reduce Plan administrative expenses for the year ended December 31, 2024.

**Concentrations of Credit Risk.** As of December 31, 2024 and 2023, substantially all of the Plan's investments were held by the Trustee, whom held the Plan's investments and executed all investment transactions.

**Recent Legislation.** In December 2022, SECURE Act 2.0 ("SECURE 2.0") was enacted. SECURE 2.0 contains numerous significant changes for retirement plans, plan sponsors, and retirement plan providers. For example, SECURE 2.0 contains provisions related to, among many other things, increasing the required minimum distribution age, reducing required minimum distribution penalties, and removing required minimum distribution barriers for annuities. Many of the provisions in SECURE 2.0 went effective in 2023, but SECURE 2.0 will not be completely implemented until 2027. The Internal Revenue Service ("IRS") has issued additional guidance addressing specific issues arising from the implementation of the provisions of SECURE 2.0.

## NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting.** The accompanying financial statements have been prepared on the accrual method of accounting.

**Use of Estimates.** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition.** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's valuation policies are determined utilizing information provided by the Trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants.** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

**Benefit Payments.** Benefits are recorded when paid.

**Administrative Expenses.** Expenses incurred in the administration of the Plan are paid by the Company. Loans and distribution processing fees are paid by the participants.

**NOTE 3 – INFORMATION CERTIFIED BY THE TRUSTEE OF THE PLAN**

The following is a summary of the unaudited information regarding the Plan, included in the Plan's financial statements and supplemental schedule that was prepared by the Trustee, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the Trustee that such information is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income (loss) and interest on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Note 4: All investment balances.
- The schedule of assets held at the end of year as of December 31, 2024, as shown on Form 5500, Schedule H, Part IV, Line 4i.

**NOTE 4 – FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1.** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2.** Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3.** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual Funds and Money Market Accounts.** Valued at quoted market price.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 – RELATED-PARTY TRANSACTIONS**

Certain Plan investments are managed by the Trustee, and, therefore, these transactions qualify as party-in-interest transactions. These transactions are not, however, considered prohibited transactions under ERISA regulations. Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

**NOTE 6 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE 7 – TAX STATUS**

The Plan uses a prototype plan document sponsored by the Trustee. The Trustee received a favorable determination letter from the IRS dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the Code. The Plan itself has not received a determination letter from the IRS. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code.

**NOTE 8 – RISKS AND UNCERTAINTIES**

The Plan provides for various investment options in any combination of mutual funds, registered investment companies and other investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

## INDEPENDENT AUDITOR'S REPORT

To the Participants and Administrator of the  
All Truck Transportation Co., Inc. 401(k) Profit Sharing Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of the All Truck Transportation Co., Inc. 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ["ERISA Section 103(a)(3)(C) audit"]. Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

## NOTES TO THE FINANCIAL STATEMENTS

## NOTE 1 – DESCRIPTION OF PLAN

The following description of All Truck Transportation Co., Inc. 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more comprehensive description of its provisions.

**General.** The Plan is sponsored by All Truck Transportation Co., Inc. and Emjay Sales and Leasing, Inc. (the “Company”), as defined in the Plan. The Plan is a defined contribution plan, that covers all full-time employees of the Company. The Company controls and manages the operation and administration of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

**Eligibility.** Employees, except those covered by a collective bargaining agreement or that are classified as overflow work drivers, are eligible to participate upon completion of three consecutive months of service.

**Participant Contributions.** An eligible employee may elect to contribute a flat amount or a percentage of their earnings to the Plan, which are limited and subject to amounts established by the Internal Revenue Code (the “Code”). Participant contribution elections may be changed by participant at any time. A participant’s earnings consist of total cash compensation of an employee including vacation pay, bonuses, tips, and overtime pay in a plan year. Participants may also contribute “catch-up” contributions and amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

**Employer Contributions.** The Company makes discretionary matching contributions equal to 50% of the participant's contributions, up to 4% of eligible compensation. The Plan also allows for the Company to make a discretionary nonelective contribution to those participants still actively employed on the last day of the Plan year and who have earned at least 1,000 hours of service during the Plan year. No such contribution was made for the year ended December 31, 2024.

**Participant Accounts.** Each participant’s account is credited with the participant’s contributions, Company matching contributions, and allocation of (a) the Company’s discretionary non-elective contribution, if any, and (b) Plan earnings or losses, and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting.** Participants are immediately vested in their employee contributions plus actual earnings or losses thereon. Vesting in Company matching contributions and profit sharing, if any, and earnings thereon, is based on years of service and is determined as follows:

**Investment Options.** Participants can direct employee and Company contributions into any of the several investment alternatives provided by the Fidelity Management Trust Company, the trustee of the Plan (“Trustee”) and qualified institution under ERISA. Participants may change their investment options at any time.

**Notes Receivable from Participants.** Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant’s account and bear interest at rates assigned at loan inception. Principal and interest are paid ratably through payroll deductions.

**Payment of Benefits.** On termination of service due to death, disability, or retirement or for any other reason, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or installment or partial withdrawal payments. In addition, hardship distributions out of the participant's voluntary contribution and vested Company contribution accounts are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2 from the participant's vested account balance.

**Forfeitures.** Forfeited balances of terminated participants' non-vested accounts are used to reduce Plan administrative expenses or future Employer contributions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. There were no forfeited non-vested accounts as of December 31, 2024 and 2023. There were \$6,560 of forfeitures used to offset Employer contributions and to reduce Plan administrative expenses for the year ended December 31, 2024.

**Concentrations of Credit Risk.** As of December 31, 2024 and 2023, substantially all of the Plan's investments were held by the Trustee, whom held the Plan's investments and executed all investment transactions.

**Recent Legislation.** In December 2022, SECURE Act 2.0 ("SECURE 2.0") was enacted. SECURE 2.0 contains numerous significant changes for retirement plans, plan sponsors, and retirement plan providers. For example, SECURE 2.0 contains provisions related to, among many other things, increasing the required minimum distribution age, reducing required minimum distribution penalties, and removing required minimum distribution barriers for annuities. Many of the provisions in SECURE 2.0 went effective in 2023, but SECURE 2.0 will not be completely implemented until 2027. The Internal Revenue Service ("IRS") has issued additional guidance addressing specific issues arising from the implementation of the provisions of SECURE 2.0.

Actual results could differ from those estimates.

**Investment Valuation and Income Recognition.** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's valuation policies are determined utilizing information provided by the Trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants.** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

**Benefit Payments.** Benefits are recorded when paid.

**Administrative Expenses.** Expenses incurred in the administration of the Plan are paid by the Company. Loans and distribution processing fees are paid by the participants.

**NOTE 3 – INFORMATION CERTIFIED BY THE TRUSTEE OF THE PLAN**

The following is a summary of the unaudited information regarding the Plan, included in the Plan's financial statements and supplemental schedule that was prepared by the Trustee, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the Trustee that such information is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income (loss) and interest on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Note 4: All investment balances.
- The schedule of assets held at the end of year as of December 31, 2024, as shown on Form 5500, Schedule H, Part IV, Line 4i.

**NOTE 4 – FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1.** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2.** Inputs to the valuation methodology include the following:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3.** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual Funds and Money Market Accounts.** Valued at quoted market price.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 – RELATED-PARTY TRANSACTIONS**

Certain Plan investments are managed by the Trustee, and, therefore, these transactions qualify as party-in-interest transactions. These transactions are not, however, considered prohibited transactions under ERISA regulations. Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

**NOTE 6 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE 7 – TAX STATUS**

The Plan uses a prototype plan document sponsored by the Trustee. The Trustee received a favorable determination letter from the IRS dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the Code. The Plan itself has not received a determination letter from the IRS. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code.

**NOTE 8 – RISKS AND UNCERTAINTIES**

The Plan provides for various investment options in any combination of mutual funds, registered investment companies and other investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.
