NOTE A -- Description of plan and significant accounting policies

The following brief description of The Bruce Company of Wisconsin, Inc. Profit Sharing and Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. The employers, as described below, have adopted the FMR, LLC's Non-Standardized Pre-Approved Profit Sharing Plan, effective September 16, 2021. The original effective date of the Plan was March 1, 1967.

General

The Plan is a defined contribution plan with elective deferral 401(k) features covering eligible employees of The Bruce Company of Wisconsin, Inc. and Bruce Fence Company, LLC (the employers) who have completed one year of service, defined as at least 1,000 hours of service, and have attained age 21. Eligible employees may enter the Plan immediately upon meeting the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's Investment Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

The Plan's federal identification number is 39-0904663, and the Plan's number is 001.

Contributions

Each year, participants may contribute up to 60 percent of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 2 percent of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

The employers may make a discretionary matching contribution equal to a uniform percentage or dollar amount of participant elective deferrals. For 2024, the employers made discretionary matching contributions of 50 percent of the participant's deferral up to a maximum of the first 2 percent of the participant's eligible compensation. The employers also have the right to make additional discretionary contributions to be allocated to participants pro rata based on compensation. No additional discretionary contributions were made for 2024. Annual contributions from all sources are subject to certain limitations defined by the Internal Revenue Service (IRS).

Contributions receivable

Contributions receivable are written off when they are determined to be uncollectible. The allowance for credit losses is estimated based on expected credit losses considering the Plan's historical losses, existing economic conditions, and the financial stability of the employers.

Participant accounts and “rollovers”

Each participant’s account is credited with the participant’s contribution and allocations of (a) the employers’ matching and discretionary contribution, (b) Plan earnings and (c) charged with an allocation of administrative expenses. Allocations of Plan earnings are based on participant account balances, as defined, and allocation of employer contributions are based on participant compensation, as provided in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. The Plan permits the transfer of funds from other qualified plans to a separate participant’s rollover account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the employers’ discretionary contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested in discretionary matching contributions ratably after five years of credited service starting with year two of service. A participant is 100 percent vested ratably in additional discretionary contributions after seven years of credited service starting with year two of service. Participants who leave the Plan because of death or disability, as defined in the Plan, are considered 100 percent vested in all types of contributions including allocable additional discretionary employer contributions.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant’s account and bear interest at a fixed rate that is determined as 1 percent over the Prime Rate (7.50 percent at December 31, 2024) set by the Wall Street Journal on the first business day of the month the loan is originated. Principal and interest is paid by employees via check over a period not to exceed five years.

Benefits

On termination of service due to death, disability, retirement (age 65) or termination of employment, a participant may elect either a lump-sum distribution of the entire vested account balance or in a single sum distribution of a portion of the participant’s vested interest in his or her account. A participant with an account valued at less than \$1,000 shall receive a lump-sum distribution. A participant with an account valued between \$1,000 and \$5,000, on termination of service due to death, disability, retirement or termination of employment, shall have the amount rolled over to an IRA designated by the plan administrator. In-service distributions are available upon reaching age 59 ½. In addition, hardship distributions are permitted if certain criteria are met. The Plan allows in-kind distributions of shares of marketable securities, pursuant to the qualifying rollover of such distribution to a Fidelity Investments individual retirement account or taxable distribution directly to another Fidelity Investments account.

Forfeited accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$8,161 and \$5,254, respectively. These accounts are first used to pay administrative expenses. Any remaining amount is used to reduce future employer contributions payable under the Plan. In 2024, administrative expenses of \$112 were paid from forfeited nonvested accounts.

A summary of significant accounting policies follows:

Basis of accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) under the accrual method of accounting.

Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

The Plan's investments are stated at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits

Benefits are recorded when paid.

Administrative expenses

The employers pays some of the administrative expenses of the Plan which are excluded from these financial statements. The major administrative expenses are recordkeeping and professional fees.

Notes receivable from participants

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded.

Subsequent events

These financial statements have not been updated for subsequent events occurring after September 11, 2025, which is the date these financial statements were available to be issued. The Plan has no responsibility to update these financial statements for events and circumstances occurring after this date.

NOTE B -- Information certified by the trustee and asset custodian

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and interest, dividends, net appreciation, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company (Fidelity), the asset custodian and trustee of the Plan.

NOTE C -- Party-in-interest transactions

Fidelity is the trustee and asset custodian of the Plan as of and for the year ended December 31, 2024, and is therefore designated as a fiduciary and party-in-interest. The Plan regularly invests in mutual funds and a collective investment fund for which Fidelity is the issuing party. These party-in-interest transactions occur in the course of ordinary business and are exempt transactions.

Fees were also paid by the Plan during the year for advisory services rendered by Gallagher Fiduciary Advisors, LLC and audit fees to SVA Certified Public Accountants, S.C. These transactions also qualify as party-in-interest transactions.

NOTE D -- Fair value measurements

The Plan's investments are reported at fair value in the accompanying Statement of Net Assets Available for Benefits.

U.S. GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs were only used when Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- Registered investment companies. Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

- Stable value collective investment trust fund. A stable value fund that is composed primarily of fully benefit-responsive investment contracts that is valued at the net asset value of units of the collective investment trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value.

Gains and losses (realized and unrealized) included in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, are reported in net appreciation in fair value of investments.

Investments Measured Using the Net Asset Value per Share Practical Expedient

The following table summarizes investments for which fair value is measured using the net asset value per share practical expedient as of December 31, 2024 and 2023, respectively. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

Although it has not expressed any intent to do so, the employers have the right under the Plan, to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their allocated employer contributions.

NOTE F -- Tax status

The FMR LLC's Non-Standardized Pre-Approved Profit Sharing Plan that the Plan has adopted effective September 16, 2021, obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the prototype plan, as then designed, was acceptable under Section 401 of the Internal Revenue Code for use by employers for the benefit of their employees. The Plan has been amended since the date of the opinion letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
