INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Participants of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Intertape Polymer Corp. In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the

financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Notes to Financial Statements
December 31, 2024 and 2023

1 – Description of the Plan

The following description of the Intertape Polymer Corp. Menasha Union 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering substantially all union employees of the former Central Products Company (“Central”). On December 31, 2006, Central was merged into Intertape Polymer Corp. (“Company”, “Plan Administrator”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and subsequent legislation as well as the collective bargaining agreement in effect with the United Steelworkers International Union Local 2-727 (“CBA”).

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the years ended December 31, 2024 and 2023. Plan management continues to evaluate the impact of the optional provisions of SECURE 2.0 and is awaiting additional regulatory guidance from the Internal Revenue Service (IRS) and Department of Labor. The application of the SECURE 2.0 Act did not have a material effect on the Plan’s financial statements for the plan years ended December 31, 2024 and 2023.

Contributions

Union employees that have completed 55 calendar days of continuous service and are age 18 or older are eligible for participation in the Plan. The following individuals are excluded: (i) employees not covered under the CBA and (ii) “Student Employees” as defined in the CBA. For purposes of the match contribution and additional contribution (as defined below), employees covered under the CBA that were hired prior to August 9, 2012 are excluded.

Participants may elect to make compensation reduction (deferral) contributions to the Plan, pre-tax or Roth after tax, subject to Plan and Internal Revenue Service (“IRS”) limitations. The Plan also permits rollover and catch-up contributions. The Plan has an automatic enrollment feature whereby newly eligible employees are entered into the Plan at a deferral percentage of 2%. Employees may opt out of this 2% deferral or change the deferral percentage at any time.

Pursuant to the CBA in effect as of August 1, 2015 the Plan was amended. For employees hired on or before August 9, 2012, the Company is required to make a contribution in an amount equal to \$55 per year of service (year of service calculated as of July 31st each year) per employee whether or not such employees chose to participate in the Plan’s elective deferrals (“Service contribution”). The Service contribution is required to be remitted at the beginning of each Plan year on or before January 31 of the Plan year. As of August 2018, the CBA was amended to provide three additional years of Service contribution to eligible employees that retire during the term of the CBA, and increase the Service contribution to \$60 per year of service.

The Company funded the Service contributions of \$59,975 for the 2024 plan year and \$148,393 for the 2023 plan year in accordance with the CBA.

For eligible employees hired after August 9, 2012, the Company is required to contribute an amount equal to 65% of each participant’s deferral contribution up to a maximum of 6% of the participant’s annual base compensation for the plan year (“Participant match contribution”) and an additional contribution equal to \$1,350 per employee whether or not such employee chooses to participate in the Plan’s elective deferrals (“Additional contribution”). In March 2023, the CBA was amended such that the Participant match contribution was increased to 70% up to a maximum of 6%. Participant match contributions are required to be remitted by the end of the month following the end of each quarter. The Additional contributions are required to be remitted by the end of the month following the end of the Plan year. Employer contributions receivable included in the statements of net assets available for benefits as of December 31, 2024 and 2023, consist of Participant match and Additional contributions which were funded in accordance with the CBA.

For the Plan years ended December 31, 2024 and 2023, Participant match contributions totaled \$287,641 and \$254,637, respectively, and Additional contributions totaled \$195,750 and \$164,866, respectively.

Investment Options

Upon enrollment in the Plan, a participant may direct the investment of their account balance in 1% increments in any of the investment options offered by the Plan. Participants may change their investment options daily.

Participant Accounts

Each participant's account is credited with the participant's deferral contributions, Participant match contributions, Service contributions, Additional contributions, as applicable, and an allocation of the Plan earnings and losses, and expenses with respect to the investments of the participant's account. Allocations are based on participant earnings or account balances as defined in the Plan document. Each participant is entitled to the vested portion of their account.

Vesting

Participants are at all times fully vested in the value of their accounts attributable to the deferral contributions and the Service and Additional contributions. Vesting in the value of their accounts attributable to the Participant match contribution is based on years of continuous service. A participant is 20 percent vested after each year and 100 percent vested after five years of service.

Payment of Benefits

Payment of benefits can be made in a lump-sum distribution or installments as elected. A participant's account balance may not be withdrawn prior to death, retirement, disability, termination of employment, or termination of the Plan, unless the distribution qualifies as a financial hardship or in-service distribution at age 59 1/2, as defined in the Plan document. If employment terminates for any reason and the participant's vested account balance is less than \$1,000, the participant's vested account balance will be distributed in a lump-sum distribution. If the balance is less than \$5,000 but more than \$1,000, absent a request for a lump sum or direct rollover, it shall be paid to an individual retirement account.

Forfeiture Allocation

Forfeitures of Participant match contributions may be used to pay reasonable Plan expenses, or to reduce future Participant match contributions made by the Company. At December 31, 2024, forfeited non-vested accounts totaled \$5,043, and \$17,772 and \$1,526 of forfeitures, respectively, were used during 2024 to offset Participant match contributions and Additional contributions made by the Company. At December 31, 2023, forfeited non-vested accounts totalled \$1,603, and \$19,220 and \$4,788 of forfeitures, respectively, were used during 2023 to offset Participant match contributions and Additional contributions made by the Company.

Notes Receivable from Participants

Participants may borrow from their vested accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance and may have only one outstanding note at a time. Note terms are for a period not exceeding five years unless for the purchase of a principal residence, in which case the repayment period may not exceed ten years. The notes are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by Associated Trust Company, N.A. ("Associated" or "Trustee"), the Plan trustee.

2 – Summary of Significant Accounting Policies

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements follows.

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits

Benefits paid to participants are recorded when paid.

Administrative Expenses

Certain administrative expenses are paid by the Plan. All other expenses are paid by the Company and are excluded from these financial statements. Participant related fees and expenses are paid by the Plan through charges to participant accounts.

Investment Valuation, Notes Receivable from Participants and Income Recognition

The Plan’s investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for disclosures regarding fair value measurements.

Notes receivable from participants are valued at their unpaid principal balance plus any accrued interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed as they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes are treated as distributions pursuant to the terms of the Plan document.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes Plan realized and unrealized gains and losses on investments bought and sold as well as held during the year.

Subsequent Events

Plan management evaluated the December 31, 2024 financial statements for subsequent events through September 15, 2025, the date the financial statements were available to be issued. Plan management is not aware of any subsequent events which would require recognition or disclosure in the financial statements with the exception of those disclosed in these financial statements.

3 – Information Certified by Trustee

Management has determined that the Trustee is a qualified institution and the information prepared and certified by the Trustee meets the requirements of ERISA Section 103(a)(3)(C).

Accordingly, the Trustee has certified that the following data included in the financial statements and supplementary schedule is complete and accurate:

- Investments at fair value and notes receivable from participants, as shown in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants, as shown in the Statements of Changes in Net Assets Available for Benefits for the years ended December 31, 2024 and 2023.

- Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024.

The Plan's independent certified public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

4 – Collective Trust Funds

The Plan invests in collective trust funds composed primarily of fully benefit-responsive investment contracts that are valued at the net asset value ("NAV") of units of the bank collective trust. These contracts are not considered fully benefit-responsive to the Plan as the underlying contracts are not direct investments between the Plan and the issuer. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

5 – Fair Value Measurements

The FASB Accounting Standards Codification (the "Codification") establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under this guidance are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; or
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the NAV of shares held by the Plan at year end, based on quoted market prices.

Collective trust funds: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying

investments held by the fund less its liabilities. Redemptions are permitted daily subject to a one day redemption notice period unless the NAV of the fund falls below \$1. The funds have no unfunded commitments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6 – Related Party and Party-In-Interest Transactions

Certain Plan investments are managed by Associated. Associated is the trustee as defined by the Plan and, therefore, any transactions qualify as party-in-interest transactions.

The Plan allows participants to take out notes, which are also considered party-in-interest.

7 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. Upon termination, all participant accounts will become immediately vested.

8 – Tax Status

In July 2022, the Plan was restated to a non-standardized pre-approved plan with an opinion letter from the IRS dated June 30, 2020 stating that the form of the Plan was qualified under Section 401(a) of the Internal Revenue Code ("IRC"), and therefore, the related trust was tax-exempt. The Plan Administrator has determined that it is eligible to and has chosen to rely on the IRS pre-approved plan opinion letter. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of

December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9 – Risks and Uncertainties

In general, the investments provided by the Plan are exposed to various risks, such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participant account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
