## **INDEPENDENT AUDITORS' REPORT**

### (1) DESCRIPTION OF THE PLAN

The following description of the HazTek, Inc. 401(k) P/S Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

#### **GENERAL**

The Plan is a defined contribution plan covering substantially all salaried employees of HazTek, Inc. (the “Company”) who are age eighteen or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). An Administrative Committee/Board of Trustees is responsible for oversight of the Plan, including any Plan changes/amendments, match determination, the appropriateness of the Plan’s investment offerings, and monitoring investment performance. Effective April 7, 2025, the Plan was merged into the Code Red Safety Rental Plan and all assets of the Plan were transferred to the new plan.

#### **CONTRIBUTIONS**

Each year, participants may contribute up to 100% of pre-tax eligible compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are also eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan offers mutual funds, common/collective trusts, pooled separate accounts, and an insurance company annuity contract as investment options for participants. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in accordance with the default investment alternatives established under the Plan until changed by the participant.

After one year of service, the Company contributes 50% of the first 3% of eligible compensation and 75% of the next 3% of eligible compensation, capped at 3.75% of an employee’s eligible compensation. The Company may also make discretionary profit-sharing contributions in an amount to be determined by the employer for each plan year. No such contributions were made during the period ended April 7, 2025.

Contributions are subject to certain Internal Revenue Service (“IRS”) limitations.

#### **PARTICIPANT ACCOUNTS**

Each participant’s account is credited with the participant’s elective contributions and the Company contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

### ***VESTING***

Participants are vested immediately in their contributions (including rollover contributions) and earnings thereon. Vesting in the Company's matching and profit-sharing contribution portion of their account is based on continuous years of service and are 100% vested after five years of credited service. Regardless of the vesting schedule, a participant will become fully vested upon death or total and permanent disability.

### ***NOTES RECEIVABLE FROM PARTICIPANTS***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Principal and interest are paid ratably through biweekly payroll deductions over a reasonable period of time. The loan is secured by the balance in the participant's account and bears interest at a rate of 1% over the prime interest rate, as defined. The interest rate shall remain fixed throughout the duration of the loan. Interest rates ranged from 4.25% to 9.5%.

### ***PAYMENT OF BENEFITS***

On termination of service due to death, disability, retirement, or other reasons, a participant's vested interest in his or her account will be distributed in a lump-sum payment if such vested interest is less than \$5,000. Participant consent is required for distributions of vested account balances in excess of \$5,000.

### ***FORFEITED ACCOUNTS***

At December 31, 2024, forfeited non-vested accounts totaled \$77. The Employer may use forfeitures to pay Plan expenses or to reduce future employer matching contributions. Forfeited amounts applied during 2025 totaled \$18,619.

## **(2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### ***BASIS OF ACCOUNTING***

The financial statements are prepared under the accrual method of accounting.

### ***USE OF ESTIMATES***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### **INVESTMENT VALUATION AND INCOME RECOGNITION**

The Plan's investments are reported at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the custodian and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the period.

### **NOTES RECEIVABLE FROM PARTICIPANTS**

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when charged. No allowance for credit losses has been recorded as of December 31, 2024. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

### **PAYMENT OF BENEFITS**

Benefits are recorded when paid.

### **EXPENSES**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Certain fees (i.e., loan fees and certain withdrawal and distribution fees) are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation/depreciation of fair value of investments.

### (4) FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 inputs) and the lowest priority to unobservable inputs (Level 3 inputs).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at April 7, 2025 and December 31, 2024.

*Mutual funds:* Valued at the daily closing price as reported by the fund. These funds publish their daily net asset value ("NAV") and transact at that price.

*Common/collective trusts:* Valued at the NAV of units of the collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

*Pooled separate accounts:* Valued daily at the NAV of units of pooled separate account. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Pooled separate accounts and common/collective trusts generally can be redeemed on a daily basis and are not subject to withdrawal limitations.

### (5) RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Principal Trust Company is the custodian for the Plan. Certain Plan investments are insurance company contracts or units of either pooled separate accounts or common/collective trusts that are established/maintained by either the custodian or Principal Life Insurance Company. Principal Life Insurance Company is an affiliate of Principal Trust Company. Therefore, these transactions qualify as party-in-interest transactions. Principal Trust Company and Principal Life Insurance Company are both members of the Principal Financial Group.

Fees incurred by the Plan for the investment management services are included in net appreciation/depreciation in fair value of the investment as they are paid through revenue sharing, rather than a direct payment.

Fees paid by the Plan for administrative services amounted to \$9,530 for the period ended April 7, 2025.

### (6) ABILITY TO TERMINATE THE PLAN

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

On April 7, 2025, the Company terminated the Plan by merging it into the Code Red Safety Rental Plan.

### (7) TAX STATUS

The IRS issued a favorable opinion letter dated June 30, 2020 for plans using the third-party administrator’s prototype adoption agreement. The IRS stated that the prototype plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (“IRC”). There have been no amendments to the Plan since the date of this opinion letter. Therefore, no provision for income taxes has been made in the financial statements.

Accounting standards require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### (8) RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

### (9) SUBSEQUENT EVENTS

Subsequent events were evaluated through September 12, 2025, which is the date the financial statements were available to be issued.
