Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Profit Sharing 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTE 1 - DESCRIPTION OF PLAN

The following description of Damuth Services, Inc. Profit Sharing 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan documents or Summary Plan Description, which is available from the plan administrator, for a more complete description of the Plan's provisions.

Plan Termination - On November 11, 2024, the Plan Sponsor approved and executed a resolution to formally terminate the Plan effective December 31, 2024. In connection with the termination, the Plan ceased all contributions. The Plan Sponsor completed the process of liquidating all Plan assets and fully distributed all account balances to participants or their designated rollover accounts by December 31, 2024. As of that date, the Plan had no remaining assets or obligations.

General - The Plan was formed on November 30, 1970, and subsequently amended and restated effective January 1, 2021. The Plan is a defined contribution plan, commonly known as a 401(k) plan with discretionary employer contributions, covering all full-time and certain part-time employees of Damuth Services, Inc. (the "Company" or the "Plan Sponsor"). Each employee of the Company becomes a participant in the Plan after two months of employment and attaining age 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions - Participants were permitted to contribute up to the maximum compensation amount as allowable by law. Employer matching contributions were at a rate that was determined annually by the employer. For 2024, the rate was 100 percent of participant contributions up to 4.00 percent of the participant's compensation. The Plan does not require the participant to make salary deferrals. Participants were permitted to contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. In addition, the employer was permitted to make discretionary contributions as determined by the Board of Directors. Contributions in the aggregate were subject to certain limitations imposed by applicable laws. All contributions were participant-directed. The Plan included an auto-enrollment provision whereby all newly eligible employees were automatically enrolled in the Plan unless they affirmatively elected not to participate in the Plan. Automatically enrolled participants had their deferred rate set at 4 percent of eligible compensation, increased by 2 percent annually up to 15 percent, and their contributions invested in a designated investment until changed by the participant.

Rollovers from Other Plans - For eligible employees or participants, the Plan allowed rollover contributions from all qualified plans. A separate account was maintained by the Plan for a participant's rollover contributions, which was non-forfeitable at all times. The account shared in the income and gains and losses of the funding vehicles in which it was invested.

Participant Investment Account Options - Participants directed the investment of their contributions into various investment options offered by the Plan. The Plan offered several mutual funds and common trusts as investment options for participants.

Participant Accounts - Each participant's account was credited with the participant's contribution and allocations of (a) the Company's matching contribution and (b) plan earnings and charged with an allocation of administrative expenses. Allocations were based upon participant earnings or account balances, as defined.

Notes Receivable from Participants - Participants were permitted to borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans were secured by the balance in the participant's account and bore interest based on the Wall Street Journal's prime rate plus one percent as determined by T. Rowe Price Trust Company ("TRP" or the "Trustee"). Repayment terms, which were determined by the plan documents, were not permitted to exceed five years unless loan proceeds were used to acquire a participant's principal residence.

Vesting - Participants' and employer's contributions and actual earnings were 100 percent vested immediately.

Payment of Benefits - On termination of service due to retirement or disability, a participant was be entitled to receive the participant's vested account balance. Terminated participants with account balances less than \$5,000 automatically received a lump-sum distribution of their account balances, unless otherwise directed. In the event of a participant's death, the participant's beneficiary was entitled to receive the decedent's vested account balance.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Basis of Accounting - The accompanying financial statements of the Plan are prepared using the accrual basis in accordance with U.S. GAAP.

Investments Valuation and Income Recognition - The Plan's investments are stated at fair value. Fair value is defined as the price that would be received from the sale of an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of investments are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Payment of Benefits - Benefits are recorded when paid.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. Interest income earned on participant loans for the year ended December 31, 2024 was \$54,269.

Administrative Expense Reimbursements - The Plan had a revenue-sharing agreement with TRP. Under the terms of the agreement, TRP would provide the Plan with an administrative budget which it would apply administrative credits to with an amount equal to certain administrative fee payments with respect to Plan assets received or accrued for receipt that exceeded the established revenue threshold. The administrative credits would be used to pay certain administrative expenses of the Plan, as directed by the Company.

Administrative Expenses - Administrative expenses paid by the Plan include various recordkeeping/administration fees. Investment-related expenses are included in net appreciation in fair value of investments.

Subsequent Events - In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through September 8, 2025, the date the accompanying financial statements were available to be issued.

NOTE 3 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under U.S. GAAP are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- a. Quoted prices for similar assets or liabilities in active markets.
- b. Quoted prices for identical or similar assets or liabilities in inactive markets.
- c. Inputs other than quoted prices that are observable for the asset or liability.
- d. Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

NOTE 3 - FAIR VALUE MEASUREMENTS - CONTINUED

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable and significant inputs for the asset or liability.

The Plan's valuation methodology used to measure the fair values of mutual funds were derived from quoted market prices as substantially all of these instruments have active markets and are classified within Level 1 of the valuation hierarchy. Classification within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The fair market value of the common collective trusts have been measured using the Net Asset Value ("NAV") provided by the administrators of the funds. The NAV is based on the value of the underlying assets owned by the funds, minus its liabilities, divided by the number of units outstanding. There are no restrictions as to the redemption of these investments, nor does the Plan have any contractual obligations to further invest in any of the common collective trusts. Under the terms of the T. Rowe Price Stable Value Common Trust Fund ("Stable Value Fund") agreement, the Plan was required to provide advance written notice to T. Rowe Price Trust Company prior to full redemption of the Stable Value Fund.

There have been no changes in the methodologies used at December 31, 2024 and 2023. For the years ended December 31, 2024 and 2023, there were no transfers between levels.

NOTE 7 - TAX STATUS

The Internal Revenue Service has determined that the prototype profit sharing plan adopted by the Plan is designed in accordance with the applicable sections of the IRC and has informed the plan administrator of such in a letter dated August 19, 2020. Although the Plan has been amended since the date of this opinion letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore that the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invested in various investment funds. Investments in general are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments could have occurred during the year and could have materially affected participants' account balances.
