NOTE 1 – DESCRIPTION OF PLAN

The following description of the ABO Leasing Corporation 401(k) Profit Sharing Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all active employees except for all union employees and non-resident aliens of ABO Corporation and its participating subsidiaries, affiliates, and locations (collectively, the “Company” or “Employer”) who have attained the age of 18 and have completed two months of service. Employees are not eligible to receive a discretionary profit-sharing contribution until they have completed one year of credited service and are employed at the end of the Plan year. The Plan was established as of January 1, 2015 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions: Participants may contribute up to 100% of their eligible wages not to exceed maximum limits allowed by the Internal Revenue Service Code Section 402(g). In addition, participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions in excess of legal limits under IRS Code Section 414(v). Participants may also contribute amounts representing distributions from other qualified plans. The Company makes a matching contribution equal to 100% of the first 3% and 50% of the next 2% of compensation that participants contribute to the Plan. Additionally, the Board of Directors of ABO Leasing Corporation may also make an annual discretionary profit-sharing contribution. For the year ended December 31, 2024, the Company contributed \$652,347 in matching contributions and \$497,551 in profit sharing contributions.

Participant Accounts: Each participant’s account is credited with the participant’s contribution, the Company’s matching contributions and an allocation of the Company’s profit-sharing contributions and Plan earnings and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Participants direct the investment of their contributions and the Company contributions into various investment options available under the Plan.

Death and Disability: A participant is entitled to 100% of his or her account balance upon death or disability.

Vesting: Participants are immediately vested in their contributions and Employer match contributions plus actual earnings thereon upon entry into the Plan. Vesting in Employer profit sharing contributions, plus earnings thereon, is based on years of continuous service. A participant is 100% vested after five years of credited service.

Payment of Benefits: Upon termination of service, a participant (or their beneficiaries upon death of the participant) is eligible to receive an amount equal to the value of his or her vested account as a lump sum, partial payments, or in installment payments. Benefit amounts under \$5,000 are automatically distributed to participants. In-service withdrawals are also permitted for active participants who have attained age 59½. In addition, participants may make “hardship withdrawals,” as defined by the Plan.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the plan agreement to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event the Employer terminates the Plan, the accounts of all participants affected will become 100% vested in their Employer contributions and earnings thereon.

Notes Receivable from Participants: Participants may borrow funds against their account balance at a minimum amount of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account, bear interest at prevailing interest rates, and cannot exceed five years unless the loan is for the purchase of a principal residence. Principal and interest are paid through payroll deductions.

Forfeitures: Forfeitures of account balances of terminated participants attributable to Company contributions are used first to pay administrative expenses of the Plan. Remaining forfeitures are then used to reduce future employer contributions.

Administrative Expense and Investment Management Fees: Loan origination fees associated with notes receivable from participants and the Plan's recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income reported by the Plan. All other expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Risks and Uncertainties: The Plan provides for various investment options. The underlying investments are exposed to various risks, such as interest rate, market, liquidity, and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits and the statement of changes in net assets available for benefits.

Investment Valuation and Income Recognition: The Plan's investments, other than the fully benefit-responsive investment contract, are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exist price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contract, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and Plan provisions. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by participants' account balances.

Payment of Benefits: Benefits are recorded when paid.

Subsequent Events: Management has performed an analysis of the activities and transactions subsequent to December 31, 2024 to determine the need for any adjustments to or disclosure within the financial statements for the year ended December 31, 2024. Management has performed their analysis through September 10, 2025, which was the date that the financial statements were available to be issued.

NOTE 3 – FAIR VALUE MEASUREMENTS

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. The effect of a change in valuation technique or its application on a fair value estimate is accounted for prospectively as a change in accounting estimate. When evaluating indications of fair value resulting from the use of multiple valuation techniques, the Plan is to select the point within the resulting range of reasonable estimates of fair value that is most representative of fair value under current market conditions. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

Mutual funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Collective trust: The fair value of participation units held in the collective trust is based upon the net asset value per unit as reported by the fund manager. Withdrawals needed for benefit payments and loan advances of participating employee benefit plans are generally permitted daily, but the fund does reserve the right to withhold payment for up to 30 calendar days to preserve the liquidity of the fund. Withdrawals for other purposes may require a twelve-month advance notice to the fund. At its discretion, the fund may process these withdrawals prior to the end of the twelve-month period.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan holds a fully benefit-responsive investment contract that is reported at contract value, which is generally the amount a participant would receive if he or she would initiate a withdrawal or transfer from the contracts under the provisions of the Plan. Contract value represents contributions made to the contract, plus earnings, less participant withdrawals and administrative expenses. The contract value of the Plan's fully benefit-responsive investment contract, by general type, is presented below:

Traditional Guaranteed Investment Contract: The Plan holds a traditional guaranteed investment contract with Transamerica Life Insurance Company ("Issuer"). The Issuer maintains the contributions in its general account. The Issuer guarantees the Plan a return of principal and interest under the terms of the contracts. The interest crediting rate is updated semi-annually based on contract provisions. The Issuer's general account is credited with earnings on the underlying investments and is charged for participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

The Plan's investment contract specifies certain conditions under which distributions from the contract would be payable at amounts below contract value. Such circumstances include Plan termination, Plan merger, premature contract termination initiated by the Company, and certain other Company-initiated events that result in distributions exceeding a set amount. The contract limits the circumstances under which the Issuer may terminate the contracts. Examples of circumstances which would allow the Issuer to terminate the contracts include the Plan's loss of its qualified status, uncured material breaches of responsibilities, or material and adverse changes to the provisions of the Plan. If one of these events were to occur, the Issuer could terminate the contracts at an amount less than contract value. Currently, management believes that the occurrence of an event that would cause the Plan to transact contract distributions at less than contract value is not probable.

NOTE 5 – CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Vanguard Fiduciary Trust Company (the trustee of the Plan from January 1, 2024 to January 31, 2024), Reliance Trust Company (the custodian of the Plan from February 1, 2024 to June 28, 2024), Transamerica Trust Company (the custodian of the Plan from June 29, 2024 to December 31, 2024), and Transamerica Life Insurance Company.

NOTE 6 – TAX STATUS

The Internal Revenue Service issued an opinion letter, most recently dated June 30, 2020 that stated the prototype plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code.

NOTE 6 – TAX STATUS (Continued)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 – PARTIES-IN-INTEREST

Parties-in-interest are defined under the Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Employer, and certain others. The Plan holds funds managed by The Vanguard Group, Inc., an affiliate of the Plan's former trustee and Transamerica Asset Management., an affiliate of the Plan's trustee; therefore, these transactions and the payment of investment management fees paid by the Plan to investment managers qualify as party-in-interest transactions. Recordkeeping and trustee fees also qualify as parties-in-interest transactions. The Company provides certain accounting, recordkeeping and administrative services to the Plan for which it receives no compensation. Certain fees are paid by the Company for administration of the Plan. Notes receivable from participants are also considered parties-in-interest.
