We have conducted an ERISA Section 103(a)(3)(C) audit of the financial statements of Rosewood 401(k) Plan (the “Plan”) as of and for the year ended December 31, 2024, and have issued our report thereon dated September 16, 2025. Professional standards require that we advise you of the following information related to our audit.

Our Responsibility in Relation to the Financial Statement Audit

As communicated in our engagement letter dated June 6, 2025, our responsibility, as described by professional standards, is to conduct our audit in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (“ERISA”). Therefore, as permitted by ERISA Section 103(a)(3)(C), the audit need not extend to any statements of information related to assets held for investment of the Plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”). For an ERISA Section 103(a)(3)(C) audit, the audit will not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirement of accounting principles generally accepted in the United States of America (“GAAP”). Accordingly, the objective of the ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are also responsible for communicating significant matters related to the audit that are, in our professional judgment, relevant to your responsibilities in overseeing the financial reporting process. However, we are not required to design procedures for the purpose of identifying other matters to communicate to you.

Planned Scope and Timing of the Audit

We conducted our audit consistent with the planned scope and timing we previously communicated to you.

Compliance with All Ethics Requirements Regarding Independence

The engagement team and our firm, including its employees, have complied with all relevant ethical requirements regarding independence.

Significant Risks Identified

No significant risks were identified that required special audit consideration.

Qualitative Aspects of the Plan's Significant Accounting Practices

Significant Accounting Policies

Management has the responsibility to select and use appropriate accounting policies. A summary of the significant accounting policies adopted by the Plan is included in Note 2 to the financial statements. There have been no initial selection of accounting policies and no changes in significant accounting policies or their application during 2024. No matters have come to our attention that would require us, under professional standards, to inform you about (1) the methods used to account for significant unusual transactions and (2) the effect of significant accounting policies in controversial or emerging areas for which there is a lack of authoritative guidance or consensus.

Significant Accounting Estimates and Related Disclosures

Accounting estimates and related disclosures are an integral part of the financial statements prepared by management and are based on management's current judgments. Those judgments are normally based on knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ markedly from management's current judgments. There were no significant accounting estimates affecting the Plan's financial statements.

Financial Statement Disclosures

Certain financial statement disclosures involve significant judgment and are particularly sensitive because of their significance to financial statement users. There were no sensitive disclosures affecting the Plan's financial statements.

Significant Unusual Transactions

For purposes of this communication, professional standards require us to communicate to you significant unusual transactions identified during our audit. We have not identified any significant unusual transactions.

Form 5500 Procedures

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor's report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

Identified or Suspected Fraud

We have not identified any fraud or suspected fraud.

Significant Difficulties Encountered During the Audit

We encountered no significant difficulties in dealing with management relating to the performance of the audit.

Uncorrected and Corrected Misstatements

For purposes of this communication, professional standards require us to accumulate all known and likely misstatements identified during the audit, other than those that we believe are trivial, and communicate them to the appropriate level of management.

Further, professional standards require us to also communicate the effect of uncorrected misstatements related to prior periods on the relevant classes of transactions, account balances, or disclosures, and the financial statements as a whole. Uncorrected misstatements or matters underlying those uncorrected misstatements could potentially cause future-period financial statements to be materially misstated, even though the uncorrected misstatements are immaterial to the financial statements currently under audit. There were no uncorrected misstatements identified in the current or prior year.

In addition, professional standards require us to communicate to you all material, corrected misstatements that were brought to the attention of management as a result of our audit procedures. There were no corrected misstatements identified during the audit.

Disagreements with Management

For purposes of this letter, professional standards define a disagreement with management as a matter, whether or not resolved to our satisfaction, concerning a financial accounting, reporting, or auditing matter, which could be significant to the Plan's financial statements or the auditor's report. No such disagreements arose during the course of the audit.

Representations Requested from Management

We have requested certain written representations from management, which are included in the attached letter dated September 16, 2025.

Management's Consultations with Other Accountants

In some cases, management may decide to consult with other accountants about auditing and accounting matters. Management informed us that, and to our knowledge, there were no consultations with other accountants regarding auditing and accounting matters.

Other Significant Matters, Findings, or Issues

In the normal course of our professional association with the Plan, we generally discuss a variety of matters, including the application of accounting principles and auditing standards, business conditions affecting the Plan, and business plans and strategies that may affect the risks of material misstatement. None of the matters discussed resulted in a condition to our retention as the Plan's auditors.

Other Matters

The ERISA-required supplemental schedule was subjected to the audit procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with auditing standards generally accepted in the United States of America.

Our responsibility also includes communicating to you any information which we believe is a material misstatement of fact. Nothing came to our attention that caused us to believe that such information, or its manner of presentation, is materially inconsistent with the information, or manner of its presentation, appearing in the financial statements.

1. Description of the Plan

The following description of the Rosewood 401(k) Plan (the "Plan") provides only general information. Participants should refer to the *Basic Plan Document and Adoption Agreement* ("Plan Document") for a more complete description of the Plan's provisions. The Plan is sponsored by The Rosewood Corporation, whose corporate offices are located in Dallas, Texas.

General

The Plan is a defined contribution 401(k) plan covering employees of Rosewood Corporate Administration, Inc. and certain of its affiliates (collectively referred to as the "Company"). The Plan is subject to the provisions of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 ("ERISA").

Eligibility

Employees of the Company become eligible to participate in the Plan on the first day of employment and are enrolled within 30 days of the first day of employment. Employees must be twenty-one years of age to participate in the Plan.

Contributions

A participant may contribute any whole percentage between 1% and 90% of his or her compensation to the Plan, subject to the annual deferral limit of Section 401(k) of the Internal Revenue Code (the "Code") (\$23,000 and \$22,500 for 2024 and 2023, respectively, plus certain catch-up provisions for participants that have attained age 50 before the end of the Plan year). Unless a participant elects otherwise, the participant is enrolled with a deferral contribution of 6%, and after six months of employment, deferral contributions for each active participant are automatically increased annually in April by a whole percentage point until 10% is reached. Participants are allowed to make pre-tax, Roth, and after-tax contributions into the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contributions plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds, self-directed brokerage investments, and a common/collective investment trust as investment options for participants.

The Company (with the exception of one affiliate) makes matching contributions equal to 100% of the basic contribution of each participating employee, limited to a maximum match of 6% of each participating employee's earnings. For the one affiliate mentioned above, the Company makes matching contributions equal to 50% of the basic contribution of each participating employee with up to five years of continuous service, limited to a maximum match of 3% of each participating employee's earnings; after five years of continuous service, the Company makes matching contributions of 100%, limited to a maximum match of 6% of each participating employee's earnings.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's match, and an allocation of (a) Plan earnings and (b) revenue credits, and charged with an allocation of investment expenses and fees, if applicable. Allocations are based on account balances, as defined in the Plan.

1. Description of the Plan – continued

Interest income and fees associated with participant loans are credited/charged directly to the participant's account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Participants vest in employer's matching contributions 20% after each year of continuous service and become fully vested after five years of continuous service. If death or disability occurs or Normal Retirement Age (age 65) is reached while employed by the Company, participants become fully vested.

Notes Receivable from Participants

Participants may request loans via the Plan's automated phone system or online. No loan to any participant shall be made to the extent that such loan, when added to the outstanding balance of all other loans to the participant, would exceed the lesser of: (a) \$50,000 reduced by the excess (if any) of the highest outstanding balance of such participant's Plan loans during the one-year period ending on the day before the loan is made over the outstanding balance of the participant's Plan loans on the date the loan is made; or (b) one-half of the value of the participant's vested balance. The minimum principal amount of any loan is \$1,000. Loans under the Plan must be repaid within five years. However, loans to purchase a principal residence of the borrower may be repaid within 10 years from the date of the loan. The maximum number of loans outstanding to any participant is two, subject to the rules noted above. As of December 31, 2024 and 2023, interest rates ranged from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

Benefits Paid to Participants

Upon termination of service due to death, disability, retirement, or separation, a participant may elect to receive the vested account balance as a partial distribution, a distribution in installments, a lump-sum distribution, or direct rollover into another qualified plan or individual retirement account. Prior to a plan amendment in April 2024, a participant may only have elected to receive the vested account balance as a lump-sum distribution or direct rollover into another qualified plan or individual retirement account. For terminated participants with account balances less than \$7,000 (\$5,000 in 2023), the Plan Administrator may distribute the entire amount without the participant's consent.

In the event of financial hardship, as defined in the Plan Document, a participant may elect, while still in the employment of the Company, to withdraw all or part of their vested balance.

A participant who has attained age 59½ may elect, while still in the employment of the Company, an In-Service Withdrawal of all or part of their vested balance for any purpose. Any active participant who is 100% vested may also elect an In-Service Withdrawal for any purpose in an amount not to exceed the balance of the employer match account.

Forfeitures

Any amounts not eligible for withdrawal at time of termination are forfeited and are applied to reduce future Company contributions or pay certain Plan administrative fees. In certain circumstances, amounts forfeited may be restored to terminated employees who are subsequently re-employed provided they repay the amount of Company contributions received at termination. At December 31, 2024 and 2023, forfeitures of \$1,869 and \$1,879, respectively, were available for reducing future employer contributions, to pay Plan fees, or to restore prior forfeitures under certain conditions. During the years ended December 31, 2024 and 2023, employer contributions were reduced by \$42,678 and \$18,303, respectively, from forfeited nonvested accounts.

1. Description of the Plan – continued

Plan Termination

Although the Company expects to continue the Plan indefinitely, the Plan may be terminated by the Company, and the Company may suspend or discontinue its contributions at any time, subject to the provisions of ERISA. Upon termination of the Plan, participants become 100% vested in employer contributions.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Use of Estimates

The preparation of the financial statements in conformity with U.S. GAAP requires the Plan Administrator to use estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosure of contingent net assets available for benefits at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from these estimates.

Contributions

Contributions from the Company and participants are accrued as they become obligations of the Company, as determined by the Plan’s administrator, and in the period in which they are deducted from the participants, in accordance with salary deferral agreements.

Investment Valuation and Income Recognition

The Plan’s investments are stated at fair value as of the end of the year and are subject to market credit risks customarily associated with equity investments. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. *Net appreciation in fair value of investments* includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are included in *other income, net* and are expensed when incurred. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan Document.

Payment of Benefits

Benefits are recorded when paid.

2. Summary of Significant Accounting Policies – continued

Administrative Expenses/Revenue Credits

Generally all administrative expenses relative to the Plan, including recordkeeping expenses, are paid by the Company and excluded from these financial statements. Plan participants pay the administrative fees associated with notes receivable from participants. Investment related expenses are included in *net appreciation in fair value of investments*.

Fidelity Management Trust Company (“FMTC”), the trustee, is compensated by the Plan’s investment fund service providers for its shareholder and other services that benefit both the investment funds and the Plan. FMTC, in turn, provides credits to the Plan, which are allocated to the Plan participants and are included in *other income, net*.

3. Fair Value Measurements

The Company determines fair value based on assumptions that market participants would use in pricing an asset or liability in the principal or most advantageous market. When considering market participant assumptions in fair value measurements, the following fair value hierarchy distinguishes between observable and unobservable inputs, which are categorized in the following levels:

Level 1 – Observable inputs that are based upon quoted market prices for identical assets or liabilities within active markets.

Level 2 – Observable inputs other than Level 1 that are based upon quoted market prices for similar assets or liabilities, based upon quoted prices within inactive markets, or inputs other than quoted market prices that are observable through market data for substantially the full term of the asset or liability.

Level 3 – Inputs that are unobservable for the particular asset or liability due to little or no market activity and are significant to the fair value of the asset or liability. These inputs reflect assumptions that market participants would use when valuing the particular asset or liability.

To the extent that valuation is based on models or inputs that are less observable or unobservable in the market, the determination of fair value requires more judgment. Accordingly, the degree of judgment exercised by the Company in determining fair value is greatest for instruments categorized in Level 3. A financial instrument’s level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The Company uses prices and inputs that are current as of the measurement date, including during periods of market dislocation. In periods of market dislocation, the observability of prices and inputs may be reduced for many instruments. This condition could cause an instrument to be reclassified from Level 1 to Level 2 or Level 2 to Level 3. For the years ended December 31, 2024 and 2023, there were no significant transfers between levels.

Valuation Techniques

Mutual funds. These investments are public investment vehicles, which are valued using the net asset value (“NAV”) provided by the investment manager of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities and then divided by the number of shares outstanding. The NAV is a quoted price in an active market and classified within Level 1 of the valuation hierarchy.

Common/collective trusts. These investments are primarily fully benefit-responsive investment contracts that are valued using the NAV provided by the trustee as a practical expedient for fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. The NAV is based on the value of the underlying assets owned by the trust, which primarily utilizes contract value, minus its liabilities and then divided by the number of shares outstanding. Accordingly, these investments are not presented within the valuation hierarchy.

Self-directed brokerage investments. These investments are comprised of investments in common stocks, mutual funds, and money market funds (all of which are Level 1 investments).

4. Certified Investments

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including *investments, at fair value and notes receivable from participants* held at December 31, 2024 and 2023, and *net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants* for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by FMTC, the Trustee of the Plan.

5. Tax Status

The Internal Revenue Service (“IRS”) requires restatement of the Plan every six years to maintain its tax-qualified status. Therefore, effective August 31, 2021, the Plan was amended and restated to adopt the Fidelity Pre-Approved Defined Contribution Plan, which has a favorable opinion letter from the IRS dated June 30, 2020. The opinion letter states that the form of the Plan is acceptable under Section 401 of the Code. The Company may rely on this letter with respect to the qualification of the Plan under IRC Section 401(a) with certain limitations.

Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The Company believes that the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Plan management evaluates tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. As of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require disclosure. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Risks and Uncertainties

The variety of investment options are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

7. Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee organization, or relatives of such persons.

FMTC acts as trustee of the Plan. The Plan invests in shares of mutual funds managed by FMTC. The Plan also paid certain expenses related to Plan operations and investment activity to various service providers. The transactions above, as well as loans made to participants, qualify as party-in-interest transactions under ERISA that are exempt from the prohibited transaction rules.

8. Subsequent Events

The Plan's management has evaluated all subsequent events and transactions for potential recognition and disclosure through September 16, 2025, the date at which the financial statements were available to be issued, and determined there are no other reportable subsequent events.
