INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of
Ole Media Services, Inc. Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Ole Media Services, Inc. Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Ole Media Services, Inc. Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Opinion

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Ole Media Services, Inc. Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Ole Media Services, Inc. Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Ole Media Services, Inc. Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Ole Media Services, Inc. Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

NOTE 1 – DESCRIPTION OF PLAN

The following description of the Ole Media Services, Inc. Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

(A) GENERAL

The Plan was established on November 1, 2002 and restated effective January 1, 2022 by Ole Media Services, Inc. (the "Company") under the provisions of Section 401(a) of the Internal Revenue Code (the "Code"), as amended, which includes qualified cash or deferred arrangements as described in Section 401(k) of the Code, for the benefit of eligible employees of the Company. The Plan is subject to and conforms with the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

During 2024, the Company exited the joint venture between the Company and a participating employer, TVV LLC ("TVV"), and the Plan Administrative Committee approved the transfer of assets for all TVV employees to a newly formed plan with identical provisions to the Ole Media Services, Inc. Retirement Plan. As a result, assets in the amount of \$116,507 were transferred out of the plan on October 24, 2024.

(B) CONTRIBUTIONS

Eligible employees can contribute up to the maximum percentage allowable, subject to certain limitations under the Code. The total maximum allowable contribution per participant to the Plan directly from the participant was \$23,000 for the year ended December 31, 2024, not including additional catch-up contributions allowed for participants over the age of 50, which were \$7,500.

The matching percentage contributed by the Company is discretionary and is determined annually by the Company. The Company elected to match the lesser of 66.67% of the employee's contributions or \$3,500 for the year ended December 31, 2024. The Company made employer matching contributions of approximately \$286,000 for the year ended December 31, 2024. This amount is net of approximately \$4,000 in forfeitures used to offset matching contributions (Note 1H).

(C) ELIGIBILITY

Effective January 1, 2022 employees are eligible to participate in the Plan upon reaching the age of 21 and completing 90 days of service, as defined, prior to entry date. Employees meeting the above requirements can enter the Plan immediately.

NOTE 1 – DESCRIPTION OF PLAN (CONTINUED)

(D) VESTING

Participants are immediately vested in their elective deferrals and rollover contributions, plus or minus any earnings or losses thereon, which cannot be forfeited for any reason.

The Company’s discretionary matching contributions are vested in accordance with the following schedule:

<u>Years of service</u>	<u>Vested percentage</u>
0 - 1	0%
2	34%
3	67%
4 or more	100%

Participants are 100% vested, regardless of service, when they reach early retirement age.

(E) PAYMENTS OF BENEFITS

On termination of service due to death, disability or retirement, a participant may receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

The Plan also allows participants that qualify for financial hardship, as defined, to withdraw funds while still employed.

(F) PARTICIPANT ACCOUNTS

Each participant’s account is credited with the participant’s compensation deferral contribution, the Company’s discretionary matching contributions, if any, and an allocation of the investment earnings, based upon each participant’s election, and charged with an allocation of administrative expenses not paid by the Company. The benefit to which a participant is entitled upon withdrawal from the Plan, as defined above, is the vested benefit in the participant’s account.

NOTE 1 – DESCRIPTION OF PLAN (CONTINUED)

(G) INVESTMENT OPTIONS

Upon enrollment in the Plan, a participant may direct employee contributions as well as employer matching contributions and any related earnings in the various investment options offered by the Plan. John Hancock Life Insurance Company ("John Hancock"), a qualified institution, was the appointed custodian of the Plan's assets at December 31, 2024 and 2023.

(H) FOREFEITED ACCOUNTS

Non-vested portions of the matching contributions are forfeited as of an employee's termination date. Pursuant to the Plan, forfeitures may be used to pay administrative expenses or reduce matching contributions. During the year ended December 31, 2024 approximately \$4,000 in forfeitures were used to offset matching contributions. At December 31, 2024 and 2023, there were no remaining forfeitures, respectively.

(I) NOTES RECEIVABLE FROM PARTICIPANTS

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of (a) \$50,000 minus the difference between the highest outstanding balance of loans during the previous one-year period or (b) 50% of their vested account balance. The notes are secured by the balance in the participant's vested account. The interest rate for a loan is determined by the plan administrator based on current market rates. The interest rates are equal to the prime rate plus two percentage points at origination. Participants may only have two outstanding loans at any time.

Principal and interest is repaid through payroll deductions over a period of no more than five years unless the loan is used to purchase a primary residence which then allows for the repayment over ten years. The loan becomes payable in full upon the employee's termination. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following are the significant accounting policies followed by the Plan:

(A) BASIS OF ACCOUNTING

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America for employee benefit plans.

(B) INVESTMENT VALUATION AND INCOME RECOGNITION

Assets of the Plan are reflected in the accompanying statements at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investments are valued at market value based on published quotations. Quotations for marketable securities that are not published are obtained from brokerage firms by the Plan custodian.

Purchases and sales of securities are recorded on a trade date basis. Dividend and interest income are recorded by the custodian in the period earned. Net realized and unrealized appreciation or depreciation in fair value of investments consists of the change in unrealized appreciation or depreciation and the realized gain or loss on the sales of investments during the year. Acquisition costs are included in the cost of investments purchased and sales are recorded net of selling expenses. Investments are self-directed by the individual Plan participants.

(C) NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

(D) USE OF ESTIMATES

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amount of assets and liabilities and disclosure of contingent assets and liabilities as of the date of the financial statements and the reported amounts during the period. Actual results could differ from those estimates.

(E) RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

(F) PAYMENT OF BENEFITS

Benefits are recorded when paid.

(G) PLAN ADMINISTRATION EXPENSES

The Plan agreement allows for the Company to absorb a significant amount of the Plan's administrative expenses. During the year ended December 31, 2024, administrative expenses incurred by the Plan totaled approximately \$58,000.

(H) MANAGEMENT'S REVIEW OF SUBSEQUENT EVENTS

Management has evaluated subsequent events through September 8, 2025, the date on which the financial statements were available to be issued.

NOTE 3 – FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 3 – FAIR VALUE MEASUREMENTS (CONTINUED)

Accounting guidance establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for similar assets, and Level 3 inputs consist of unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. During 2024 and 2023, Level 1 inputs were available and therefore used.

The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds - The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year-end.

Common Collective Trusts - The Stable Value Fund is valued at the net asset value ("NAV") of the units of a collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Gains and losses (realized and unrealized) included in changes in net assets available for benefits for the year ended December 31, 2024 are reported net in appreciation in fair value of investments.

NOTE 4 – COMMON COLLECTIVE TRUST

The Plan has investments in stable value collective investment trust fund at December 31, 2024 and 2023. The Plan's investment in the fund is not a direct investment and therefore, is not considered a fully-benefit-responsive contract. The fund itself is considered to be fully benefit-responsive for participant initiated transactions. The Plan has estimated the investments' fair value utilizing the NAV practical expedient. The estimated fair value at December 31, 2024 and 2023 was \$167,955 and \$198,785, respectively. The objective of the investment is to preserve capital and provide stability of principal while earning current income that exceeds money market rates over the long term. Units in the trust may be redeemed on a daily basis to meet benefit payments and other participant-initiated withdrawals permitted by the Plan. Plan level withdrawals may be delayed up to twelve-months. At December 31, 2024 and 2023, there were no unfunded commitments.

NOTE 5 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan. In the event the Plan terminates, participants in the Plan become fully vested in the Company's contributions. Participants' contributions are always 100% vested.

NOTE 6 – TAX STATUS

The Company has adopted a non-standardized pre-approved profit sharing plan document that has received an opinion letter from the Internal Revenue Service (“IRS”) dated June 30, 2020, stating that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE 7 – INFORMATION PREPARED AND CERTIFIED BY THE PLAN CUSTODIAN

NOTE 8 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds and collective investment trusts managed by John Hancock. John Hancock is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than direct payment. Notes receivable from participants are also considered party-in-interest transactions.

NOTE 9 – FIDELITY BONDING

The Company maintains a fidelity bond of \$500,000 for Plan fiduciaries and individuals who handle the funds of the Plan, pursuant to the requirements of ERISA.

NOTE 10 – EXCESS CONTRIBUTIONS PAYABLE

Contributions received from participants for 2023 are net of excess deferral contributions of approximately \$28,000, which were returned to the participants in the subsequent year. These amounts are also included in the Plan's statements of net assets available for benefits as excess contributions payable at December 31, 2023.
