INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Pedernales Electric Cooperative, Inc. Employees' 401(k) Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Basis for Opinion

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTE 1 – DESCRIPTION OF PLAN

The Pedernales Electric Cooperative, Inc. Employees' 401(k) Savings Plan (the Plan) is a qualified defined contribution plan which benefits substantially all employees of Pedernales Electric Cooperative, Inc. (the Cooperative). The purpose of the Plan is to provide employees with the opportunity to save for retirement on a tax-advantaged basis. The Plan was originally effective on January 1, 1968, and has been amended and restated multiple times. The most recent restatement was effective January 1, 2024, and incorporated changes required by recent legislation, including the SECURE Act and updates to required minimum distribution rules under the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The following description of the Plan provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

Administration: A committee appointed by the Cooperative administers the Plan. The committee has overall responsibility for the operation and administration of the Plan. The committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Cooperative. All Plan benefits are provided by a trust fund. The Cooperative acts as the administrator of the Plan. Charles Schwab Trust Bank has been appointed by the Cooperative to perform the duties of the trustee of the trust fund used to fund the Plan.

Eligibility: The Plan permits employees who are not interns, independent contractors, leased employees, nonresident aliens, or are subject to a collective bargaining agreement to participate in the Plan as of the first administratively feasible pay period coinciding with or following the participant's first day of employment. The Cooperative contributes a matching contribution to eligible employees starting on the first day of the next month following six months of employment.

Investment Options: Participants direct the investment of their entire interest in the Plan. The Plan currently offers mutual funds and collective trust funds as investment options. Participants may modify elections, transfer existing balances, and obtain information regarding investments on a daily basis.

Contributions: Each year, participants may elect to contribute between 2% and 75% of eligible compensation, as defined in the Plan. A participant may elect to have all or a portion of their elective deferrals designated as Roth elective deferrals. Roth deferrals are subject to current-year federal income taxation but are not taxable when distributed. Participants who have attained age 50 before the end of the Plan year may make catch-up contributions. Rollovers are also permitted from other qualified defined benefit or defined contribution plans.

The Plan includes an automatic enrollment feature. Once a participant meets the eligibility requirements, they are automatically enrolled at a 2% deferral rate unless they affirmatively elect otherwise. The election is implemented as soon as the participant satisfies eligibility.

For participants hired on or after July 1, 2005, and for others who meet certain defined eligibility criteria, the Cooperative contributes a matching amount equal to 500% of the participant's salary deferral, up to 2% of eligible compensation. For all other participants, the match is 300% of the first 2% of compensation deferred. Compensation includes base pay, bonuses, and paid time off (PTO), subject to IRS limits. Any participant contributions above 2% of compensation are excluded from the match calculation.

Participant Accounts: Each participant's account is credited with the participant's contributions, rollovers, employer contributions, and an allocation of Plan earnings or losses. Participant accounts are charged with his or her withdrawals and an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or losses, account balances, or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Vesting: A participant is immediately vested with respect to the portion of their account attributable to participant contributions, rollover contributions, and the related earnings or losses thereon. Vesting in the Cooperative's contribution to their account is based on continuous service using the elapsed time method. A participant is 100% vested after three years of service.

Payment of Benefits: Upon termination of service before normal retirement age, a participant may elect to receive a single lump-sum payment in cash equal to the value of the participant's vested account balance, installment payments, or to rollover the distribution directly to another qualified plan under section 401 of the Internal Revenue Code (IRC). If a participant's vested account balance does not exceed \$1,000 upon termination of employment, it will be automatically distributed regardless of whether a participant consents to receive it. Upon normal retirement, disability, or death, the participant or beneficiary is entitled to receive the amount credited to their account. Benefits may be paid to the participant in a single lump-sum payment in cash, installment payments, or a direct rollover to another qualified plan. If the participant or their beneficiary is required to take minimum distributions, benefits may be paid in a series of payments as required by the IRC. Participants may receive an in-service distribution upon attaining age 59½ or incurring a disability. Hardship withdrawals are not permitted under the Plan.

Retirement, Death, and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death, or disability.

Notes Receivable from Participants: Participants may borrow from their accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are generally repaid within five years. Principal and interest payments are paid ratably through payroll deductions. Participant loans are evidenced by promissory notes, which are adequately secured by the balance in a participant's account, and bear interest at a rate commensurate with local prevailing rates.

Forfeited Accounts: Forfeitures may first be used to reduce employer contributions and then used to pay any administrative expenses. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$207,534 and \$242,156, respectively. During 2024, the Cooperative used \$52,837 to reduce employer contributions.

Plan Termination: Although the Cooperative intends to maintain the Plan indefinitely, it reserves the right to terminate the Plan at any time. Upon termination, no further contributions will be made to the Plan and all amounts credited to participants' accounts will become 100% vested. The Cooperative will direct distributions as soon as administratively feasible.

Administrative and Investment Management Expenses: Certain expenses of maintaining the Plan are paid directly by the Cooperative and are excluded from these financial statements. Plan recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income reported by the Plan.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through September 4, 2025, which is the date the financial statements were available to be issued.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Cooperative to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits: Benefits are recorded when paid.

Risk and Uncertainties: The Plan invests in various investments. Investments are exposed to various risks, such as interest rate, market, credit and risks from the effects of global events. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs in the valuation methodology are unobservable and significant to the fair value measurement.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: The fair values of mutual fund investments are based upon the closing net asset value (NAV) per share of the mutual fund on the day of the valuation as reflected on a national securities exchange (Level 1 inputs).

Collective Trusts: The fair values of participation units held in collective trusts are based on the NAV per unit as reported by the fund managers. The investment strategy is to preserve capital and provide stability of principal while earning current income that exceeds money market rates over the long term. The collective trust provides for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirements

The methods described above may produce a fair value estimate that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used at December 31, 2024 and 2023.

NOTE 4 – CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank.

NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Cooperative, and certain others. Notes receivable from participants also reflect party-in-interest transactions. Certain professional fees for the administration and audit of the Plan were paid by the Cooperative. Various administrative functions are performed by officers or employees of the Cooperative and no such officer or employee receives compensation from the Plan. During 2024, the Plan paid administrative fees to various service providers including an investment advisor and the Plan's recordkeeper. These reflect party-in-interest transactions.

NOTE 6 – TAX STATUS

The Plan obtained its latest determination letter on February 26, 2013, in which the Internal Revenue Service states that the Plan, as then designed, was in compliance with the applicable requirement of the IRC. Although the Plan has been amended since receiving the determination letter, the Cooperative believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

NOTE 6 – TAX STATUS (Continued)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that it is more-likely-than-not that all tax positions would be sustained upon examination. Therefore, no liability (or asset) or disclosure is required in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
