Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of G Treasury SS, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). December 31, 2024 and 2023

1. Description of the Plan

The following description of the G Treasury SS, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan established by G Treasury SS, LLC (the "Company" or "Plan Sponsor") on January 1, 1996, and was most recently amended and restated effective January 1, 2023 to permit in-service withdrawals at any time from participants' rollover contribution account. The Plan is a safe harbor defined contribution plan covering all employees, excluding interns and leased employees, who have completed 90 days and are age 21 or older or completed 1,000 hours of service in an Eligibility Computation Period, as defined in the Plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

The Plan is administered by the Company. The Plan administrator has the overall responsibility and authority as the named fiduciary to manage and control the operations and administration of the Plan and may designate one or more individuals to perform those responsibilities. The Plan's assets are held in the custody of Capital Bank and Trust Company (the "Custodian").

Plan Merger – In December 2021, the Plan Sponsor acquired Hedge Trackers, LLC and effective January 1, 2023 (the "Merger Date"), all participants included within the Hedge Trackers, LLC 401(k) Plan merged into the Plan. All eligible Hedge Trackers, LLC employees were able to participate in the Plan.

All Hedge Trackers, LLC 401(k) active Plan participant account balances became 100% vested as of the Merger Date and were not subject to forfeitures. The investments held by the participants in the Hedge Trackers, LLC 401(k) Plan were automatically rolled over to their account in the Plan. All participant accounts in the Hedge Trackers, LLC 401(k) Plan were fully liquidated and transferred on January 11, 2023.

Participant Contributions – Each year, participants may contribute up to 90 percent of pre-tax annual compensation, as defined in the plan document, up to the maximum limit of \$23,000 of the Internal Revenue Code ("IRC"). Participants also may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who have attained age 50 before the end of the plan year 2024 are eligible to make catch-up contributions up to \$7,500. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

Employer Contributions – The Company may contribute a discretionary match not to exceed 4% of base compensation that a participant contributes to the Plan. The Company makes a safe harbor matching contribution each pay period equal to 100% of the first 3% and 50% of the next 2% of eligible compensation contributed by each participant. For the year ended December 31, 2024, there were no discretionary contributions to the Plan. Safe harbor matching contributions totaled \$834,969 for the year ended December 31, 2024.

Participant Accounts – Individual accounts are maintained for each participant and include participants' salary deferral contributions, rollover contributions, employer contributions, and an allocation of Plan earnings (losses), including realized and unrealized gains and losses on investments, and administrative expenses, if not paid by the Plan Sponsor. Allocations are based on participant earnings (losses) or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Investment Options – Participants may direct American Funds (the "recordkeeper") as to the investment of their account balance into various investment options offered by the Plan. Participants may change their investment directions at any time, subject to such restrictions and procedures as established by the recordkeeper, the Plan, and the Company.

Vesting – Participants are vested immediately in their contributions and the safe harbor matching contribution plus actual earnings thereon. Vesting in the Company's discretionary contribution is based on years of continuous service. A participant is 20% vested after two years of credited service and continues to vest in increments of 20% until 100% vested after six years of credited service.

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance or \$50,000 reduced by the highest outstanding loan balance in their account during the prior 12-month period. Note terms range from 1 to 5 years (or up to 15 years for the purchase of a primary residence). The loans are secured by the balance in the participant's account. The loan interest rate, determined monthly, is set at 1 percent above the prime rate, published by The Wall Street Journal on the first business day of each month. Principal and interest are paid ratably through payroll deductions. The interest shall remain fixed throughout the duration of the loan. On December 31, 2024, the outstanding notes receivable had an interest rate between 7.25% to 9.50%.

Benefits and Payments – Upon termination of service, a participant (or designated beneficiary) may elect to receive an amount equal to the value of the participant's vested interest in his or her account. The Plan allows for distributions upon termination of service, death, disability, attainment of age 59½, in certain hardship situations while actively employed, or from a participant's rollover contribution account at any time. A participant may elect to receive a lump sum payment or roll over the value of their account into another qualified plan. If the vested account balance payable to an individual is less than or equal to \$5,000, the Plan Sponsor may require a distribution of the entire account balance in a lump sum. Hardship withdrawals are subject to IRC restrictions and penalties.

Administrative Expenses – The Plan is administered by the Plan Sponsor. Certain administrative functions are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan. Administrative expenses are paid directly by the Plan Sponsor.

2. Summary of Significant Accounting Policies

Basis of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with generally accepted accounting principles in the United States of America ("U.S. GAAP").

Use of Estimates – The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company, as applicable. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Payment of Benefits – Benefits are recorded when paid.

Expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Employer Contributions Receivable – Any contributions due and payable by the Company are reflected as employer contributions receivable in the Plan's financial statements.

Subsequent Events – Subsequent events were evaluated through the date of this letter, the date the financial statements were available to be issued.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurement*, are described as follows:

Level 1 – Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation technique include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds – These investments are public investment vehicles valued using the net asset value (“NAV”) provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market and classified within Level 1 of the valuation hierarchy.

Money Market Fund – These investments are valued at closing price reported on the active market on which the individual securities are traded and are classified within Level 1 of the valuation hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Information Certified by the Qualified Institution

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Capital Bank and Trust Company, the qualified institution of the Plan, has certified to the completeness and accuracy of the following data included in the accompanying financial statements:

- Investments, at fair value, and notes receivable from participants as shown on the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i as of December 31, 2024.

5. Party-in-interest Transactions

Certain Plan assets on December 31, 2024 are invested in funds sponsored by the recordkeeper. Transactions involving these investments are considered party-in-interest transactions for which statutory exemption exists under DOL Regulations. Fees incurred by the Plan for investment management services are paid directly by the Plan and, therefore, also qualify as party-in-interest transactions for which a statutory exemption exists. Fees paid to the Plan's recordkeeper and investment management services provider totaled \$55,009 for the year ended December 31, 2024. Notes receivable from participants also qualify as party-in-interest transactions.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

7. Tax Status

The Plan adopted a prototype standardized plan which received a favorable opinion letter from the IRS on June 30, 2020, which stated the prototype Plan is designed in accordance with applicable sections of the IRC. The Plan has not received a determination letter specific to the Plan itself, and the Plan has been amended since receiving the opinion letter. However, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to business income tax and, therefore, the Plan continues to be tax-exempt.

7. Tax Status (continued)

U.S. GAAP requires the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

As permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of DOL Rules and Regulations for Reporting and Disclosure under ERISA, our audit did not extend to any statements or information related to assets held for investment of the Plan ("investment information") by Capital Bank and Trust Company (the "Custodian" or "Qualified Institution"), which is a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, that prepared and certified the statements or information regarding assets so held in accordance with 29 CFR 2520.103-5. Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America. Other than for the certified investment information, the financial statements and supplemental schedule were audited by us in accordance with GAAS and were subjected to tests of your accounting records and other procedures as we considered necessary to enable us to express an opinion as to whether they are presented in compliance with DOL's Rules and Regulations for Reporting and Disclosure under ERISA. SIGNIFICANT FINDINGS

Qualitative Aspect of Accounting Policies

Management is responsible for the selection and use of appropriate accounting policies. In accordance with the terms of our engagement letter, we will advise management about the appropriateness of accounting policies and their application. The significant accounting policies used by the Plan are described in Note 2 to the financial statements. No new accounting policies were adopted and the application of existing policies was not changed during the year ended December 31, 2024.

We noted no transactions entered into by the Plan during the year that were both significant and unusual, and of which, under professional standards, we are required to inform you, or transactions for which there is a lack of authoritative guidance or consensus. In addition, we did not identify any significant findings or issues during the audit in connection with the Plan's related parties.

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected. The most sensitive estimate affecting the financial statements was:

Management's assessment of the valuation inputs for each Plan investment under Financial Accounting Standards Board Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, requires the Plan to assess and disclose in the financial statements the valuation input for each Plan investment. We evaluated the key factors and assumptions used to make the assessments for each Plan investment in determining it is reasonable in relation to the financial statements taken as a whole.

Certain financial statement disclosures are particularly sensitive because of their significance to financial statement users. The most sensitive disclosures affecting the financial statements were:

The disclosure of fair value measurements in Note 3 to the financial statements, which describes the valuation techniques used to measure each classification of the investments.

The disclosure in Note 4 regarding information certified to by the Plan's Custodian, which the Plan's independent auditors did not perform auditing procedures, except for comparing such information to the related information included in the financial statements and supplemental schedule, Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i.

The disclosure of related party and party-in-interest transactions in Note 5 which describes the relationship between the Plan and its third-party service providers.

The disclosures in the financial statements are neutral, consistent, and clear.

Difficulties Encountered in Performing the Audit

We encountered no significant difficulties in dealing with management in performing and completing our audit.

Significant Unusual Transactions Identified During the Audit

We identified no significant unusual transactions during the audit.

Difficult, Contentious or Other Matters Encountered During the Audit

We encountered no difficult, contentious, or other matters for which we consulted outside the engagement team that were, in our professional judgment, significant and relevant to those charged with governance regarding the responsibility to oversee the financial reporting process.

Corrected and Uncorrected Misstatements

- Preparation of Plan financial statements
- Proposing journal entries affecting the financial statements

Form 5500

In performing our audit, in accordance with GAAS, we are responsible for obtaining and reading the draft Form 5500 in order to identify material inconsistencies, if any, with the audited ERISA Plan financial statements. During our audit we obtained and read the draft Form 5500 from management and did not identify any material inconsistencies.

Reportable Findings

For purposes of this letter, a reportable finding is a matter that includes one or more of the following: (1) noncompliance or suspected noncompliance with laws and regulations, (2) a finding that in our professional judgment is significant and relevant to you regarding your responsibility to oversee the financial reporting process, and (3) an indication of internal control deficiencies identified during the audit that have not been previously communicated to management by other parties and that we determined are sufficiently important to merit management's attention.

See descriptions within *Internal Control Communications* section below.

Internal Control Communications

In planning and performing our ERISA Section 103(a)(3)(C) audit we considered the Plan's system of internal control over financial reporting ("internal control") as a basis for designing audit procedures that are appropriate in the circumstances for the purpose of issuing our report on the financial statements, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, we do not express an opinion on the effectiveness of the Plan's internal control, nor did we include a consideration of internal control relating to the investment information.

Our consideration of internal control was for the limited purpose described in the preceding paragraph and was not designed to identify all deficiencies in internal control that might be material weaknesses or significant deficiencies and, therefore, material weaknesses or significant deficiencies may exist that were not identified. However, as discussed below, we identified certain reportable findings that we consider to be deficiencies or significant deficiencies.

A deficiency in internal control exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct, misstatements on a timely basis. A significant deficiency is a deficiency, or a combination of deficiencies, in internal control that is less severe than a material weakness, yet important enough to merit attention by those charged with governance. A material weakness is a deficiency, or a combination of deficiencies in internal control, such that there is a reasonable possibility that a material misstatement of the Plan's financial statements will not be prevented, or detected and corrected, on a timely basis. We did not identify any deficiencies in internal control that we consider to be material weaknesses.

We consider the following reportable findings to be deficiencies in the Plan's internal controls:

The provisions of the Plan provide for an employer matching contribution to be made. It is our understanding that the contribution is currently being calculated and remitted for each pay period with a year-end "true-up" adjustment. The true-up adjustment for 2023 was calculated and remitted after the 2023 audit was issued, resulting in an understatement of employer receivables and employer contributions in 2023 and an understatement of net assets and overstatement of employer contributions in 2024. We recommend Plan management calculate and remit a true-up contribution within a reasonable timeframe after year-end to reduce any timing issues in recording the receivable.

During our audit procedures over employee contributions, we noted inconsistency in the application of the terms in the Plan document relating to the definition of eligible compensation for the purposes of calculating the employee's contribution and the employer's contribution. One participant in our sample made and received contributions based on compensation excluding tuition reimbursements, although tuition reimbursements are included in the definition of compensation in the Plan document. The incorrect use of eligible compensation resulted in under withholding for deferrals and an incorrect employer match. Incorrect deferrals could require the Plan Sponsor to make necessary corrective actions for the Plan to remain in compliance with regulations and may include corrective contributions on behalf of the participant. We recommend that the Plan Sponsor uniformly train all personnel who work with the Plan and review the setup of the payroll system to ensure it is consistent with the Plan document. Further, we recommend the Plan Sponsor consult with its third party administrator or ERISA specialist to determine if corrective action is required.

We consider the following reportable findings to be significant deficiencies in the Plan's internal controls:

During our audit procedures over employee contributions, we noted one instance in which a participant's contribution and related employer match withheld from payroll were deposited into the wrong participant account. We recommend the Company set up a file feed between the payroll provider and recordkeeper to ensure that funds are deposited into the correct accounts. Further, we recommend on a monthly basis, the Company reconciles both employee and employer contributions recorded per the recordkeeper to the individual participant payroll records. Additionally, we recommend the Company discuss with the third-party administrator or ERISA specialist to determine if corrective action is required.

During our audit procedures over employee contributions, we noted several instances in which the eligibility date used by management for purposes of calculating the employer match was incorrect. New participants received an employer match based on compensation prior to the correct eligibility date, causing the participants to receive an excess match for the Plan year. We recommend the Plan Sponsor establish policies and procedures to ensure demographic information being entered into the systems relevant to the Plan is properly reviewed and in accordance with Plan provisions.

We did not identify any deficiencies in internal control that we consider to be material weaknesses.

Other Audit Findings or Issues

We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with management each year prior to retention as the Plan's auditors. However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention.

OTHER MATTERS

Supplemental Schedule

Our responsibility for the ERISA-required supplemental schedule accompanying the financial statements is to perform adequate procedures to evaluate whether the form and content of the ERISA-required supplemental schedule, other than that agreed to or derived from the certified investment information, is presented in compliance with DOL's Rules and Regulations for Reporting and Disclosure under ERISA, and whether the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

This information is intended solely for the use of Plan administrator and management of the Plan and is not intended to be, and should not be, used by anyone other than these specified parties.
