## INDEPENDENT AUDITOR'S REPORT

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain other internal control-related matters that we identified during the audit.

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### **NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023**

#### **(1) Summary of Significant Accounting Policies**

##### **Nature of Business of Plan Sponsor**

Floyd's Truck Center, Inc. (the Company and Plan Sponsor) is involved in the sale and repair of commercial trucks and parts with locations in Nebraska, Wyoming, Montana, and South Dakota.

##### **Basis of Accounting**

The financial statements of Floyd's Truck Center, Inc. 401(k) Plan (the Plan) are prepared under the accrual method of accounting.

##### **Valuation of Investments and Income Recognition**

The Plan's investments are stated at fair value on a recurring basis as determined by American Trust Company (the Trustee) (Notes 3 and 7). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded when received. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### **Participant Notes Receivable**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024, and 2023, no allowance has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

##### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the financial statements and accompanying notes. Actual results could differ from those estimates.

##### **Risks and Uncertainties**

The Plan provides for various investment options. Investments are exposed to various risks, such as interest, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

##### **Net Change in Fair Market Value of Investments**

The net change in fair market value of investments is composed of the realized gains and losses in securities that were sold or otherwise disposed of during the year and the unrealized gains and losses in securities held at the end of the year.

#### **(1) Summary of Significant Accounting Policies**

##### **Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants during 2025.

##### **Payment of Benefits**

Benefits are recorded when paid.

##### **Administrative Expenses**

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. The Company has, at its discretion, absorbed certain other administrative expenses pertaining to the Plan. If not paid by the Company, these administrative expenses become the responsibility of the Plan. Investment management fees are included in administrative expenses on the statement of changes in net assets. Fees for recordkeeping as well as the administration of notes receivable and distributions to participants are included in administrative expenses and charged directly to the participants' accounts.

#### **(2) Description of the Plan**

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

##### **General**

The Plan is a defined contribution plan established for the benefit of the employees of Floyd's Truck Center, Eddie's Truck Center, Four Open A Trucks, and Jack's Truck Center, collectively referred to as Floyd's Truck Center, Inc. (the Company). The Plan is intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code (IRC) and similar state tax laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

##### **Eligibility**

Employees of the Company who have reached 21 years of age and have completed six months of continuous service are eligible to participate in the Plan.

##### **Contributions**

Participants may contribute a percentage of their pretax annual compensation, as defined by the Plan and subject to certain IRS limitations. Participants may also contribute (rollover) amounts representing distributions from other qualified defined benefit or contribution plans. The Company will match 50 percent of the elective deferrals up to a maximum of six percent of compensation. The Plan can also provide a discretionary contribution which is determined annually. No discretionary contributions were made during the year ended December 31, 2024.

The Plan allows Roth elective deferrals. Contributions to Roth accounts are made on an after-tax basis and contributions to a Roth account are included in the participant's gross contributions. Future distributions of Roth elected contributions and earnings thereon will not be taxed, if certain criteria are met. Roth elective deferrals to the Plan are permanently designated as Roth elective deferrals in participant accounts. The participant's Roth deferrals and gains and losses attributable to such deferrals are accounted for separately.

**(2) Description of the Plan**

**Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's matching contribution, (b) Plan earnings (losses), and (c) charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. The portion of the participants' accounts attributable to the Company's contributions become 20 percent vested after two years of credited service as defined and continues to vest at the rate of 20 percent for each successive year of service until 100 percent vested after six years of service.

**Participant Notes Receivable**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Loan terms range from one to five years. The loans are secured by the balance in the participant's account and bear interest at a rate equal to the prime rate plus one percent as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions.

**Payment of Benefits**

Upon termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Vested benefits less than \$1,000 are distributed as soon as administratively feasible after the participant's termination of employment. Vested benefits greater than \$1,000, but less than \$5,000, are rolled over to an individual retirement account.

**Hardship Withdrawals**

Should a plan participant experience a hardship, he or she may elect to withdraw all or part of his or her vested account from the Plan. All cases of hardship must be presented in writing to, and approved by, the Trustee. The Trustee may request additional supporting documentation from plan participants to substantiate any case of hardship. The Trustee may, at their discretion, approve all or part of the withdrawal request. Hardship withdrawals are recorded as distributions in the period in which they are paid.

**Participants' Investment Options**

Participants direct their account balance to selected investments as made available and determined by the Plan Administrator. Participants may change their investment options at any time throughout the year. Participants may elect to discontinue contributions at any time.

**Forfeitures**

Nonvested account balances are forfeited unless participants return to employment and contribute the distribution received at termination within a specified time. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$20,288 and \$39,432, respectively. The Plan uses forfeitures to offset administrative expenses and reduce employer contributions. Forfeitures of \$50,062 were used to offset administrative expenses and reduce employer contributions during the year ended December 31, 2024.

**(2) Description of the Plan**

**Subsequent Events**

The Company has evaluated subsequent events through September 9, 2025, the date which financial statements were available for issue.

**(3) Information Certified by Trustee**

The Plan's investments are held by Mid Atlantic Trust Company (sub-custodian). The Plan's investments were certified by American Trust Company. The fair value of investments at December 31, 2024 and 2023 is determined by American Trust Company (Trustee) (Note 7).

In accordance with Section 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator has received certification from the Trustee as to the accuracy and completeness of certain financial information of the Plan as of and for the years ended December 31, 2024 and 2023. Information contained in the following has been certified by the Trustee:

Statements of Net Assets Available for Benefits (except for Excess Contribution Payable)  
Statement of Changes in Net Assets Available for Benefits (except for Contributions,  
Benefits Paid to Participants, and Administrative Expenses)  
Supplemental Schedule of Assets Held at End of Year

The Plan invests in mutual funds with underlying assets consisting of any combination of stocks, bonds, fixed income securities and other investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the fair values of investments securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits.

Market volatility of equity-based investments may substantially impact the value of such investments at any given time. It is possible that the value of the Plan's investments, both in total and in individual participant accounts, has changed significantly since December 31, 2024.

**(4) Income Tax Status**

The Plan has received an opinion letter dated June 2020, from the Internal Revenue Service (IRS) as to the Plan's qualified status. The Plan has been amended since receiving the opinion letter; however, the Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the Department of Labor (DOL) or IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**(5) Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their employer contributions.

**(6) Participant Withdrawals**

Vested, undistributed account balances of separated Plan participants totaled approximately \$1,579,000 and \$1,323,000 at December 31, 2024 and 2023, respectively.

**(7) Recurring Fair Value**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described as follows:

- Level One: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access
- Level Two: Inputs include
  1. Quoted prices for similar assets or liabilities in active markets;
  2. Quoted prices for identical or similar assets or liabilities in inactive markets;
  3. Inputs other than quoted prices that are observable for the asset or liability;
  4. Inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability
- Level Three: Inputs to the valuation methodology are unobservable and significant to the fair value measurement

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following tables present the assets carried at fair value as of December 31, 2024 and 2023, in the accompanying Statements of Net Assets Available for Benefits by fair value hierarchy. All assets are measured on a recurring basis. No liabilities are measured at fair value on a recurring or nonrecurring basis.

**(7) Recurring Fair Value**

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at quoted market prices in an active market.

*Money Market Fund:* Valued at carrying value, which approximates fair value, based on the amount of net contributions plus any investment earnings allocated to the account.

**(8) Related Party Transactions and Party in Interest Transactions**

Fees for legal and professional services rendered to the Plan may be paid by the Company at its discretion. The Plan allows participants to take out loans against their account balances. Certain investments of the Company are issued by Mid Atlantic Trust Company (sub-custodian).

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**(9) Delinquent Participant Contributions**

During the plan years ended December 31, 2024 and 2023, \$-0- and \$113,114, respectively, of participant contributions and loan repayments were not remitted to the Plan within the time frame required by DOL regulations. No corrective contributions have been made for the 2023 late remittances. These late remittances have been reported on Schedule H line 4a of the Plan's Form 5500 for the years ended December 31, 2024 and 2023.
