## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator  
**Municipal Employees Credit Union of Baltimore**  
**Defined Benefit Plan**

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Municipal Employees Credit Union of Baltimore Defined Benefit Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, the statement of accumulated plan benefits as of December 31, 2023, and the related statement of changes in accumulated plan benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).

- The information in the accompanying financial statements related to assets held by and certified by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our ethical responsibilities in accordance with the ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audits of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audit.

### Other Matters – Supplemental Schedules Required by ERISA

The supplemental schedule of assets (held at end of year) and schedule of reportable transactions are presented for the purpose of additional analysis and are not a required part of the financial statements, but are supplemental information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

### Note 1 – Description of the Plan

#### General

Municipal Employees Credit Union of Baltimore Defined Benefit Plan (the Plan) is a non-contributory defined benefit pension plan that was established on September 30, 2018 by Municipal Employees Credit Union of Baltimore, Inc. (the Credit Union). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The following description of the Plan is provided for general information purposes only. Participants should refer to the Summary Plan Description or the Adoption Agreement, including amendments thereto, for a complete description of the Plan's provisions.

#### Administration

The Plan Sponsor and named Plan Administrator is the Credit Union. The Plan Administrator is responsible for oversight of the Plan. The Plan Administrator has formed a Retirement Committee made up of members from the Credit Union's management team. The Retirement Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and fees.

Effective December 13, 2023, John Hancock Trust Company LLC is the Plan's Investment Custodian and John Hancock Retirement Plan Services LLC provides participant and administrative services (collectively "John Hancock"). Previously, Empower Trust Company, LLC was the Plan's Investment Custodian and Empower Annuity Insurance Company of America provided participant and administrative services (collectively "Empower"). Assets approximating \$11,705,000 and \$38,584,000 were transferred from Empower to John Hancock in April 2024 and December 2023, respectively. The Investment Custodians hold all of the Plan's assets and executes all of the Plan's transactions.

#### Eligibility

Effective as of the close of business December 31, 2019, the Plan was amended to freeze the Plan. Prior to December 31, 2019, employees who had completed 12 months of service with at least 1,000 hours of service became eligible to participate in the Plan on the first day of the month after meeting the eligibility requirements. The Plan is closed to new participants hired after December 31, 2019.

#### Payment of Benefits

**Normal Retirement Benefits:** Normal retirement date is the first day of the calendar month coincident with or next following age 65. An eligible participant's monthly normal retirement benefit shall be equal to 1/12 of the sum (1), (2) and (3) as follows:

1. 1.25% of the participant's average earnings (up to the Social Security Covered Compensation) multiplied by years of credited service earned after December 31, 2019, up to 30 years,
2. 1.60% of the participant's average earnings in excess of the Social Security Covered Compensation multiplied by years of credited service earned after December 31, 2019, up to 30 years, and
3. 1.60% of the participant's average earnings multiplied by years of credit service earned after December 31, 2019, above 30 years.

A terminated participant who has completed five years of service is entitled to receive a vested monthly benefit starting on their normal retirement date. The amount of the benefit is equal to the retirement income earned based on service to date multiplied by the appropriate vested percentage. If the participant terminates employment and their vested balance in the Plan is less than \$5,000, then a lump-sum distribution will be made without the participant's consent.

**Early Retirement Benefits:** The Plan permits early retirement for participants equal to a reduced percentage of the annual retirement allowance payable at normal retirement date. Specifically, the factors used to determine the reduced percentage is 1/15<sup>th</sup> per year from age 65 to 60 and 1/30<sup>th</sup> per year from age 60 to age 55. An unreduced benefit is available at 65 or 57 with 30 years of service.

**Optional Benefit Form:** Optional benefit forms are available and equal to the actuarial equivalent of the normal benefit form and may be in an amount more or less than that provided by the normal benefit form depending on the option selected. Such distributions may be in one of the following forms:

- Single life annuity.
- Modified cash refund.
- Qualified joint and survivor annuities.
- Lump sum.

Effective August 1, 2024, the Plan was amended to permit eligible participants to elect a lump sum payout during the period of October 14, 2024 through November 29, 2024, equal to the actuarial present value of the vested accrued benefit.

**Death and Disability Benefits:** If an active vested employee dies, a death benefit equal to 50% of the amount that would have been payable to the participant under the 50% joint and survivor option is payable to the beneficiary at the participant's earliest retirement age.

If a retired employee dies, the benefit payable to the beneficiary is the amount as determined under the qualified joint and survivor annuity option if the employee had retired on the day before their death.

Employees who become permanently and totally disabled while employed prior to reaching normal retirement age, will continue to accrue benefits equal to the greater of: (1) vested accrued benefit on the disability date or (2) 1/12<sup>th</sup> of 15% of the employee's average annual earnings on the disability date.

**Vesting:** Participants that terminate employment prior to their normal retirement age for reasons other than death, disability, or early retirement are entitled to a percentage of their accrued benefits. A participant vests in contributions ratably over a period of five years of credited service.

### Note 2 – Summary of Significant Accounting Policies

#### Basis of Accounting

The Plan's financial statements have been prepared on the accrual basis of accounting. Income from investments is recorded when it is earned. Expenses are recorded in the accounting period in which they are incurred.

### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the Plan's management to make use of estimates and assumptions that affect the reported amounts of assets, liabilities and the actuarial present value of accumulated Plan benefits at the date of the financial statements. Actual results could differ from those estimates.

### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and Investment Custodian. See Note 4 for discussion of fair value measurements.

The purchase and sale of investments is recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Payment of Benefits

Benefit payments to participants and beneficiaries are recorded at the time of distribution.

### Actuarial Present Value of Accumulated Plan Benefits

Accumulated Plan benefits are those future periodic payments, including lump-sum distributions that are attributable under the Plan's provisions to the service employees have rendered. Accumulated Plan benefits expected to be paid to: (i) retired or terminated vested participants or their beneficiaries, (ii) beneficiaries of participants eligible to retire who have died, and (iii) present participants or their beneficiaries. Benefits payable under all circumstances (retirement, death, and termination of employment) are included in the computation to the extent they are considered attributable to employee service rendered at the valuation date.

Benefits to be provided via annuity contracts excluded from Plan assets are excluded from accumulated Plan benefits. The actuarial present value of accumulated Plan benefits is determined by an actuary from John Hancock, and it is that amount that results from applying actuarial assumptions to adjust the accumulated Plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

The significant actuarial assumptions used in the valuation as of January 1, 2024 were: (i) discount rate of 6.5% per annum, (ii) Mortality; Pri-2012 mortality for continent annuitants and non-annuitants projected fully generationally using Scale MP-2021, (iii) salary increases ranging from 4.5% - 10.2% based on age, and (iv) withdrawal rates based on age and years of service. Actuarial assumptions are based on the presumption that the Plan will continue indefinitely. If the Plan were terminated, different actuarial assumptions might be applicable in determining the actuarial present value of accumulated Plan benefits.

Interest rates used for actuarial calculations to measure the funding target are based on a modified yield curve. Benefit obligations expected to be paid in the next 5 years are discounted with a short-term corporate bond rate. Obligations expected to be paid more than 5 years but less than 20 years from now are discounted using an intermediate corporate bond rate. Obligations expected to be paid more than 20 years from now are discounted with a long-term bond rate. For the years ended December 31, 2024 and 2023, the three interest rates for short-term, intermediate-term and long-term were 4.75%, 4.87%, and 5.59% and 4.37%, 4.96% and 4.95%, respectively. The computations of the actuarial present value of accumulated Plan benefits were made as of January 1, 2024. Had the valuation been performed as of December 31, 2023, there would be no material differences.

### Subsequent Events

The Plan has evaluated subsequent events through September 3, 2025, the date the financial statements were available to be issued. Effective January 1, 2025, the Plan was amended to provide for a two-month lookback and a one-year stability period when calculating a lump sum, and defines the interest rate to use when making corrective distributions or correcting underpayments.

### **Note 3 – Unaudited Investment Information Certified by the Investment Custodian**

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under such election, the following information has been certified by the Investment Custodians, as to its completeness and accuracy and was not subjected to any auditing procedures performed by the Plan's independent auditors:

1. All investment balances reflected in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023,
2. All investment activity reflected in the Statements of Changes in Net Assets Available for Benefits for the years ended December 31, 2024 and 2023, and
3. All investment-related information included in the Supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year) and the Supplemental Schedule H, Line 4j - Schedule of Reportable Transactions as of December 31, 2024.

### **Note 4 – Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified contractual term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methods used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

*Mutual funds:* Valued at daily closing prices as reported by the fund. Mutual funds, including the money market fund, held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded.

*Pooled separate accounts & insurance company general account:* The pooled separate accounts and the insurance company general account are not publicly traded and are measured at fair value based on the fair value of the underlying assets of the pooled separate accounts and insurance company general account, using NAV as a practical expedient. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

### **Note 5 – Party-in-Interest Transactions**

Certain Plan investments are managed by John Hancock. As John Hancock serves as the Investment Custodian, as defined by the Plan, payment of fees by the Plan to Empower qualify as a party-in-interest transaction as defined by ERISA. Fees paid by the Plan for administrative services to John Hancock approximated \$159,000 and \$143,000 for the years ended December 31, 2024 and 2023, respectively. These transactions are not, however, considered prohibited transactions under 29 CFR 408(b) of the ERISA regulations.

### **Note 6 – Funding Policy and Administrative Fees**

The Plan is funded by contributions made by the Credit Union. The Credit Union's funding policy is to, at a minimum, make contributions to the Plan as recommended by the Plan's actuary. The Credit Union did not make any contributions to the Plan for the years ended December 31, 2024 and 2023. There were no minimum funding requirements for the years ended December 31, 2024 or 2023. Certain administrative Plan expenses are paid by the Plan. Additionally, other Plan expenses are paid by the Credit Union, as provided by the Plan document. Expenses that are paid directly by the Credit Union are excluded from these financial statements. In addition, certain investment related expenses are included in net appreciation in fair value of investments in the Statements of Changes in Net Assets Available for Benefits.

Although it has not expressed any intention to do so, the Credit Union has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA.

### **Note 7 – Plan Termination**

In the event the Plan terminates, the rights of all participants to benefits accrued to the date of such termination or discontinuance, to the extent funded, shall be nonforfeitable. Accordingly, the net assets of the Plan will be allocated in accordance with the Plan document and as prescribed by ERISA and its related regulations, generally to provide the following benefits in the order indicated:

- a. Benefits attributable to employee contributions, taking into account those paid out before termination.
- b. Other vested benefits insured by the Pension Benefit Guaranty Corporation (PBGC) (a U.S. government agency) up to the applicable limitations.
- c. All other vested benefits (that is, vested benefits not insured by the PBGC).
- d. All non-vested benefits.

Certain benefits under the Plan are insured by the PBGC if the Plan terminates. Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits, and certain disability and survivor's pensions. However, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed at the level in effect on the date of the Plan's termination. Whether all participants receive their benefits should the Plan terminate at some future time will depend on the sufficiency, at that time, of the Plan's net assets to provide for the accumulated benefit obligation and may also depend on the financial condition of the Credit Union and the level of benefit guaranteed by the PBGC.

### **Note 8 – Tax Status**

The Plan has received its latest determination letter on March 6, 2020, in which the IRS stated that the Plan, as designed, is qualified under applicable sections of the Internal Revenue Code (IRC). The Plan Administrator believes that the Plan currently is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan permitted provisions of SECURE Act 2.0 during the year ended December 31, 2024 and 2023. Written amendments to the Plan document to reflect these operational changes will be adopted at a later date in accordance with the deadlines pursuant to applicable laws and IRS guidance.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 9 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Plan contributions are made, and the actuarial present value of accumulated Plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

## Actuarial cost method

### Funding target and target normal cost

An actuarial cost method allocates the expected cost of a pension plan on a year-by-year basis. The primary objective is to accumulate enough assets prior to each participant's retirement to provide the promised pension benefits.

The Pension Protection Act of 2006 (PPA) requires plan sponsors to use the Traditional Unit Credit actuarial cost method in which the estimated accrued benefit is based on service and, if applicable, earnings as of the valuation date. The funding target is equal to the actuarial present value of all accrued benefits as of the valuation date. The target normal cost is the actuarial present value, as of the valuation date, of the expected increases in projected accrued benefits attributable to service expected to be completed during the plan year (i.e., if applicable, one year's salary growth is reflected in the determination of target normal cost).

For tax deduction purposes, the funding target may reflect the value of future pay increases on accrued benefits, if applicable.

### PPA discounting method

The plan sponsor must choose between full yield curve spot rates or a segmented yield curve of 24-month average corporate bond rates. If the segmented yield curve is selected, the plan sponsor can use either the rates as of the month of the valuation or as of a lookback month, up to 4 months prior to the valuation date. If the full yield curve is selected, the rates as of the month of valuation must be used.

For purposes of this valuation, the following discounting method was used and is assumed to be approved by the plan sponsor:

**September 2023 segment rates, adjusted so each segment rate is no less than the applicable minimum percentage\* of the corresponding 25-year average segment rate for the calendar year that contains the first day of the plan year and no more than the applicable maximum percentage\*\* of that 25-year average segment rate. The 25-year average cannot be less than 5.0% prior to application of the corridor.**

### Asset valuation method

Plan assets for purposes of this actuarial valuation are valued at their fair market value, including, if applicable, discounted receivable contributions.

\* Minimum is 95% through 2030, decreasing 5% per year beginning in 2031 until 70% is reached in 2035

\*\* Maximum is 105% through 2030 and increasing 5% per year beginning in 2031 until 130% is reached in 2035

## Rationale for significant assumptions

### Economic assumptions

- **Expected return on plan assets:** The assumption was selected by the client with input from their investment advisor. We believe the assumption is reasonable as it falls within a reasonable range of expected returns for the plan's asset allocation based on capital market assumptions.
- **ASC 960 discount rate:** This assumption is based on the expected return on plan assets assumption.
- **Salary increase:** This assumption has been in place when this population was part of a multiple employer plan through 2018. We believe that this is representative of anticipated future experience.

### Demographic Assumptions

- **ASC 960 mortality:** The mortality base table and projection scale is based on the most recent mortality table and improvement scale published by the Society of Actuaries and in our judgement, adequately reflects expected mortality rates as of the measurement date. The plan's size would not support a credible mortality study. The SOA elected not to release a new mortality scale since 2021 which would have included mortality data affected by the COVID-19 pandemic, but instead will continue to study emerging mortality experience and assess what mortality improvement scale options might be considered to be implemented in the future. As such, we have decided not to reflect any adjustments to the most recent mortality improvement scale. The plan's relatively small size would not support a credible mortality study.
- **Termination:** We believe that this assumption is representative of anticipated future experience. Historically, this assumption has not produced significant gains or losses for the plan. In addition, based on discussions with the plan sponsor, significant changes in termination patterns are not expected.
- **Disability:** We believe that this assumption is representative of anticipated future experience. Historically, this assumption has not produced significant gains or losses for the plan. In addition, based on discussions with the plan sponsor, significant changes in disability patterns are not expected.

## Actuarial assumptions

- **Retirement:** We believe that this assumption is representative of anticipated future experience. Historically, this assumption has not produced significant gains or losses for the plan. In addition, based on discussions with the plan sponsor, significant changes in retirement patterns are not expected.

### Miscellaneous assumptions

- **Expenses:** The assumption is based on the expectation of expenses to be paid out during the plan year, based on actual PBGC expenses projected for the year, and assuming non-PBGC related expenses will be similar to the prior year.
- **Form of payment:** The assumption is based on the normal form of payment. Historically, this assumption has not produced significant actuarial gains or losses for the plan.
- **Spouse's age and percent married:** The employer does not have enough credible data to analyze spousal demographics. These assumptions are based on the actuary's experience with similar plans.

Effective Date:	September 30, 2018
Participation:	An employee will become a member on the first day of the month coincident with or next following the completion of 12 months of service. Collectively bargained employees, leased employees, flex staff employees or independent contractors are not eligible. Plan closed to new entrants after December 31, 2019.
Benefit Service:	Benefit service equals the years and months of a member's service from benefit service date to membership termination date.
Vesting Service:	Vesting service is a member's period of service from employment date to membership termination date.
Annual Salary:	Annual Salary means base pay salary as of January 1 of the calendar year, or a member's date of enrollment if later.
High-3 Salary:	High-3 salary is a member's annual salary averaged over the 3 consecutive years during benefit service (or all years of benefit service if less than 3) which produce the highest annual average.
Normal Retirement Date:	First of the month coincident with or next following the attainment of age 65.
Normal Retirement Benefit:	<p>Prior to December 31, 2019 - The Normal Retirement Benefit equals 1.50%/1.85% High-3 Salary integrated with floating Covered Compensation, times years of Benefit Service (up to 30 years). Benefit Service above 30 years is credited with 1.85% of High-3 Salary.</p> <p>Effective January 1, 2020 - The Normal Retirement Benefit will be the sum of (A) plus (B), where (A) is the Accrued Benefit earned as of December 31, 2019 and (B) is determined by multiplying 1/12 by the sum of:</p> <ol style="list-style-type: none"><li>(1) 1.25% of High-3 Salary, up to Covered Compensation, multiplied by years of Benefit Service earned after December 31, 2019, up to 30 years; PLUS</li><li>(2) 1.60% of High-3 Salary, greater than Covered Compensation, multiplied by years of Benefit Service earned after December 31, 2019, up to 30 years; PLUS</li></ol>

Early Retirement Date:	Early retirement date is the first day of the month coincident with or next following the attainment of age 55 and completed 5 years of service or completed 30 years of benefit service.
Early Retirement Benefit:	The early retirement allowance payable before a member's normal retirement date equals a percentage of the annual retirement allowance payable at normal retirement date. The following factors are used to determine the percentage reduction: 1/15th per year from age 65 to age 60 and 1/30th per year from age 60 to age 55. An unreduced benefit is available at age 65 or age 57 with 30 years of service.
Disability Retirement Benefit:	An eligible Participant's monthly ordinary disability benefit shall be equal to the greater of <ol style="list-style-type: none"><li>(1) his vested Accrued Benefit on the date his Disability commenced or</li><li>(2) 1112th of 15% of the Participant's High-3 Salary on the date his Disability commenced.</li></ol>
Normal Form of Benefit:	Life Annuity (single), 50% Joint & Survivor (married)
Optional Forms of Benefits:	Modified Cash Refund, Joint and Survivor Annuities (40%, 50%, 75%, 100%), Lump Sum (May only elect if the annual benefit payable is less than \$600.00)
Death Benefit:	Pre-retirement: 50% of the amount that would have been payable to the Participant under the 50% Joint and Survivor option. Benefit is payable at the Participant's earliest retirement age.
Post-Retirement:	None except as provided by the annuity form elected. Spousal consent required for beneficiary other than spouse.
COLA:	A one-time cost of living adjustment is applied to the portion of the benefit associated with the 12/31/99 Accrued Benefit.
