*Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the accompanying financial statements of M.A. Brightbill Body Works, Inc. 401(k) Profit Sharing Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. NOTE A - DESCRIPTION OF THE PLAN

The following description of M.A. Brightbill Body Works, Inc. 401(k) Profit Sharing Plan ("the Plan") provides only general information. Participants should refer to the plan document for a more complete description of the plan's provisions.

1. General

The Plan is a defined contribution plan, established on January 1, 1996, covering all eligible employees of M.A. Brightbill Body Works, Inc. ("the Company") and Brightbill Transportation, Inc. who are age 21 or older except leased employees and employees (part-time, temporary or seasonal) who have not completed one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

2. Contributions

Eligible employees may elect to contribute a percentage of total compensation (as defined by the Plan) or a specific dollar amount to the Plan. Salary deferrals are subject to Internal Revenue Service (IRS) regulations and limitations. The Plan allows two types of salary deferrals: Pre-Tax 401(K) deferrals and After-Tax Roth 401(K) deferrals. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. At the discretion of the Plan administrator, participants may also be permitted to rollover contributions from other retirement plans and make an in-plan Roth transfer.

There are also two types of employer contributions allowed under the Plan: Matching Contributions and Profit Sharing Contributions. To be eligible to receive employer contributions the employee must be age 21 or older. Entry date will be the first day of the month coinciding with or following the date eligibility requirements are met.

The employer will make a matching contribution equal to 50% of eligible employees salary deferrals. The matching contribution is limited so that salary deferrals that exceed 6% of participant compensation will not be considered for the match calculation. The employer is also able to make a discretionary profit sharing contribution to the plan. No discretionary contributions were made during the year ended December 31, 2024. Employees must have completed one year of service (as defined) on the last day of the plan year to receive discretionary contributions.

3. Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's discretionary profit sharing contributions and plan earnings net of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

4. Vesting

Participants are fully vested, at all times, in their employee deferral contributions, catch-up contributions and rollover contributions, plus actual earnings thereon. Employer contributions are subject to a vesting schedule whereby each year of service increases their vesting by 25%. Therefore after a participant completes 4 years of service they are 100% vested in all employer contributions. The Plan defines a year of service as 1,000 hours of service or 100 driver days within a plan year. Participants become fully vested in all contributions upon death or total and permanent disability.

5. Investment Options

Upon enrollment in the plan, a participant is able to direct the investment of their entire account balance. The Plan administrator provides participants with information on the available investment options maintained by Ascensus Trust Company, a party-in-interest. Because all investments are participant directed, the accounts are segregated for purposes of determining the earnings or losses on investments.

6. Payment of Benefits

Participant accounts may be withdrawn by, or distributed to, a participant only upon termination of service or attaining the age of 59  $\frac{1}{2}$ . Withdrawals prior to age 59  $\frac{1}{2}$  are not permitted, except in the event of death, disability, or financial hardship. The plan also allows qualified reservist distributions. Payments will be in a lump-sum. Partial withdrawals are allowed for required minimum distributions.

Upon proof, to the satisfaction of the plan administrator, of an immediate and heavy financial need, amounts contributed may be withdrawn for a hardship purpose. Certain income tax penalties may apply to withdrawals or distributions prior to age 59  $\frac{1}{2}$ .

7. Notes Receivable from Participants

The trustee may make loans from the plan to participants for hardship or financial necessity in accordance with the plan document. All loans to participants are considered a directed investment from the participant's account, and all payments of principal and interest on loans are credited to the participant's account. The interest rate on all loans will be the Prime Rate plus 2% per annum. Loans are limited to the lesser of 50% of the vested participants account balance or \$50,000. All loans are to be repaid within five years unless the loan is used to acquire a principal residence, in which case the term may be longer.

8. Forfeited accounts

At December 31, 2024 and 2023, forfeited non-vested accounts were \$5,687 and \$1,607, respectively. Forfeitures of employer matching contributions and forfeitures of amounts other than employer matching contributions in a plan year will be used to reduce employer contributions in the subsequent year. Forfeitures used to reduce Company contributions were \$0 in 2024.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1. Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with generally accepted accounting principles in the United States of America.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

2. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of certain assets, liabilities and disclosures. Accordingly, the actual amounts could differ from those estimates. Any adjustments applied to estimated amounts are recognized in the year in which such adjustments are determined.

3. Investment Valuation and Income Recognition

Investments are stated at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note D for a discussion of fair value measurements.

The net appreciation in the fair value of investments includes realized and unrealized gains and losses on the fair value of investments held by the plan.

Purchases and sales of investments are recorded on a settlement date basis. Interest income is accrued as it is earned and dividends are recorded as of the ex-dividend date.

4. Payment of Benefits

Benefits are recorded when paid. At December 31, 2024 and 2023 there were no benefits which were processed and approved for payment, but not yet paid.

5. Plan Expenses

Certain expenses of maintaining the plan such as administrative fees may be paid from the plan assets and deducted from participant accounts unless paid by the employer in accordance with the plan document.

Management fees and other operating expenses charged to the plan for investments in mutual funds are deducted from income earned on a daily basis and are not separately reflected. These fees are reflected as a reduction of net appreciation in fair value of investments.

6. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the plan would then have the authority to take all reasonable actions to collect the balance owed.

7. Subsequent Events

The plan has evaluated subsequent events through September 10, 2025, the date the financial statements were available to be issued.

NOTE D - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820-10 are described as follows:

- Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets the plan has the ability to access.
- Level 2 inputs to the valuation methodology include the following:
  - Quoted prices for similar assets or liabilities in active markets
  - Quoted prices for identical or similar assets or liabilities in inactive markets
  - Inputs other than quoted prices that are observable for the asset or liability

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

- Mutual Funds - Valued at the net asset value of shares held by the plan at year-end (Level 1).

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E - INVESTMENT CONTRACT

The plan has a fully benefit-responsive investment contract with Ascensus Trust Company. Ascensus Trust Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the plan.

Because the investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the investment contract. The investment contract is presented at contract value on the face of the statements of net assets available for benefits. Contract value, as reported to the plan by Ascensus Trust Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than zero percent. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan); (2) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan; or (4) the failure of the trust to qualify for exemption from federal income taxes or any prohibited transaction exemption under the Employee Retirement Income Security Act of 1974, as amended. The plan administrator does not believe that any events that would limit the plan's ability to transact at contract value with participants are probable of occurring.

In addition, certain events allow the issuer to terminate the contract with the plan and settle at an amount different from contract value. Examples of such events include the following:

1. An uncured violation of the plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreements without the consent of the issuer

NOTE E - INVESTMENT CONTRACT - Continued

The Galliard Stable Return Fund Class C invests in investment contracts and security-backed contracts. An investment contract is a contract issued by a financial institution to provide a stated rate of return to the buyer of the contract for a specified period of time. A security-backed contract has similar characteristics as a traditional investment contract. At December 31, 2024 and 2023, the contract value of the Galliard Stable Value Return Class C was \$284,434 and \$310,891, respectively.

NOTE F - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested on all amounts credited to their separate accounts.

NOTE G - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE H - PARTY-IN-INTEREST TRANSACTIONS

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee organization, or relatives of such persons.

Plan investments are managed by the Trustee, therefore, these transaction qualify as party-in-interest transactions. Transactions with parties-in-interest also include fees paid during the year for trustee, accounting, and other services, as well as contributions to the Plan by the Company and loans made to participants. All of these transactions are exempted from prohibited transaction rules under ERISA.

## NOTE I - TAX STATUS

The Plan has adopted a prototype non-standardized profit sharing plan ("adopted plan"). The adopted plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service states that the form of the Plan is acceptable under section 401 of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to examinations prior to 2021.

Excess employee contributions amounting to \$19,163 are recorded as a liability in the accompanying statements of net assets available for benefits for the year ended December 31, 2024 and as a reduction of employee contributions for the year then ended. The Plan reimbursed these excess contributions to its participants during 2025.

The Plan failed the ADP test for the 2023 plan year. Excess employee contributions amounting to \$9,186 are recorded as a liability in the accompanying statements of net assets available for benefits for the year ended December 31, 2023 and as a reduction of employee contributions for the year then ended. The Plan reimbursed these excess contributions to its participants during 2024.
