Notes to Financial Statements

Note 1: Description of Plan

The following description of the Eden Stone Co., LLC Employee Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Eden Stone Co., LLC and its wholly owned subsidiaries: Valders Stone & Marble LLC; Eden Trucking, Inc.; and Valders Dimensional Stone LLC (collectively referred to as the "Company"). Employees are eligible to enter the Plan upon hire and attainment of 21 years of age. Plan entry dates are the first day of each calendar month following meeting eligibility requirements. Participants are eligible to receive Company discretionary matching and discretionary profit sharing contributions after one year of service, as defined in the plan document. Participants are also required to be employed by the Company on the last day of the plan year and must complete at least 1,000 hours of service in the plan year in order to receive Company discretionary profit sharing contributions.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. Management of the Company is responsible for oversight of the Plan, including the appropriateness of the Plan's investment offerings and monitoring of investment performance.

Contributions

Each year, participants may contribute up to 100% of eligible compensation, as defined in the plan document, on a pre-tax or Roth basis, not to exceed the maximum allowable limits by the Internal Revenue Service ("IRS"). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may make discretionary matching contributions and discretionary profit sharing contributions. For the year ended December 31, 2024, the discretionary matching contributions were equal to 50% of participant contributions to the Plan, up to 3% of eligible compensation. Rollover contributions are not matched. The Company did not make any discretionary profit sharing contributions for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company discretionary matching contributions, and allocations of (a) the Company discretionary profit sharing contributions, (b) plan earnings (losses), and (c) forfeited nonvested accounts. Participant accounts are reduced by withdrawals and charged with an allocation of administrative and investment management expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1: Description of Plan (Continued)

Vesting

Participants are vested immediately in their voluntary deferral and rollover contributions plus actual earnings thereon. Vesting in the Company's discretionary matching and profit sharing contributions, plus actual earnings thereon is based on continuous years of service subject to a six-year graded vesting schedule. Participants vest at a rate of 20% per year beginning with the second year of service. Participants become fully vested after six years of service. In addition, there is full vesting upon death or disability.

Notes Receivable From Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note terms range from one to five years or may extend beyond five years if the note is for the purchase of a primary residence. A participant can only have one loan outstanding at one time. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 3.25% to 9.50% at December 31, 2024, which were equal to the prime rate plus 1.00% as of the date of note issuance. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, normal retirement (age 65), or termination of employment, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount or partial withdrawals. Installment payments are permitted if the participants or beneficiaries are required to receive minimum distributions. If the participant's vested account balance does not exceed \$5,000, but is greater than \$1,000, the plan administrator will pay an involuntary cashout distribution as a direct rollover to an individual retirement plan. Vested balances less than \$1,000 can be distributed only in a single lump-sum payment. In addition, hardship distributions are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 55 and if the participant is fully vested in the distributing account. Participants may withdraw their rollover contributions at any time.

Forfeitures

Plan forfeitures arise as a result of participants who terminate service with the Company before becoming 100% vested in the Company's discretionary matching and profit sharing contributions. Forfeited nonvested accounts totaled \$2 at December 31, 2024, and \$6 at December 31, 2023. The Company may decide at its discretion how to use forfeitures under the plan document. During the year ended December 31, 2024, forfeitures in the amount of \$2,344 were used to reduce Company discretionary matching contributions.

SECURE 2.0 Act

The SECURE 2.0 Act of 2022 ("SECURE 2.0") signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately, through 2028. Those provisions include both required and optional elements. The Plan has adopted the required minimum distribution at age 73 effective January 1, 2023. The Plan also adopted provisions to allow penalty-free distributions in cases of domestic abuse, as well as increased the dollar limit for mandatory distributions effective January 1, 2024. The Plan is required to be amended in regard to other requirements of SECURE 2.0 by December 31, 2026.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value, except for the fully benefit-responsive investment contract ("FBRIC"). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

FBRICs are reported at contract value, which is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

Excess Contributions Payable

At December 31, 2024, amounts payable to participants totaled \$5,778 for contributions in excess of amounts allowed by the IRS, and this amount is recorded as a liability with a corresponding reduction to participant contributions. The excess contributions will be distributed to the applicable participants during 2025 as required by regulations. At December 31, 2023, there are no amounts payable to participants for contributions in excess of amounts allowed by the IRS.

Payment of Benefits

Benefits are recorded when paid.

Administrative and Investment Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment management fees paid directly by the Plan are allocated proportionately to plan participants based on their respective account balances and are reflected as investment expenses and included in net investment income. Fees related to administrative expenses are allocated proportionately to plan participants based on their respective account balances and included in administrative expenses. Fees related to the administration of notes receivable from participants and certain types of distributions are charged directly to the participant's account and included in administrative expenses.

Subsequent Events

The Plan has evaluated subsequent events through August 27, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1); and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs would be used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used as of December 31, 2024 and 2023.

Mutual funds held in pooled separate accounts: Valued based on quoted net asset values ("NAVs") of the underlying investments held by the pooled separate accounts. The underlying mutual funds held in pooled separate accounts are open-ended mutual funds registered with the U.S. Securities and Exchange Commission. These funds must publish their daily NAV and transact at that price.

Note 4: Guaranteed Investment Contract

The Plan invests in a FBRIC with Lincoln National Life Insurance Company ("Lincoln") in the form of a guaranteed investment contract ("GIC") that invests in traditional investment contracts. Lincoln maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Lincoln is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The GIC is carried at contract value, which represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on the best interest rate that is consistent with the performance of Lincoln's general account assets and is reviewed quarterly.

Certain events limit the Plan's ability to transact at contract value with Lincoln, including plan termination and other events as specified in the GIC. The plan administrator does not believe any events that would limit the Plan's ability to transact at contract value with participants or the issuer are probable of occurring. The GIC does not permit Lincoln to terminate the agreement prior to the scheduled maturity date.

Note 5: Information Prepared and Certified by the Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments, and fully benefit responsive investment contract at contract value held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Lincoln National Life Insurance Company ("Lincoln"), the trustee of the Plan.

Note 6: Party-in-Interest Transactions

RBC Wealth Management ("RBC") is the investment advisor to the Plan and, therefore, fees paid to RBC qualify as party-in-interest transactions. Fees paid by the Plan for investment management fees amounted to \$42,293 for the year ended December 31, 2024.

A certain plan investment is managed by Lincoln, the trustee of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to Lincoln for administrative services amounted to \$30,897 for the year ended December 31, 2024.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 7: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the plan document to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company discretionary matching and profit sharing contributions.

Note 8: Tax Status

The Plan adopted a non-standardized pre-approved plan document with an IRS notification letter dated June 30, 2020, which states the non-standardized pre-approved plan document, as then designed, is in compliance with the applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the notification letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 9: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
