## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of  
Keystone Dental, Inc. 401(k) Profit Sharing Plan

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of the Keystone Dental, Inc. 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### *Opinion*

## NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

---

### 1. DESCRIPTION OF PLAN

The following description of Keystone Dental, Inc. 401(k) Profit Sharing Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**General** – The Plan is a defined contribution plan covering substantially all employees of Keystone Dental, Inc. (the “Company” or the “Plan Sponsor”) who are age 21 or older, as defined in the Plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan’s Investment Committee (the “Committee”) is responsible for oversight of the Plan, determining the appropriateness of the Plan’s investment offerings and monitoring investment performance. The Committee has retained an advisor as the Plan’s 3(38) Fiduciary Investment Manager.

**Contributions** – The Plan allows each participant to contribute a percentage of his or her compensation, on a pre-tax or after-tax basis, in an amount not to exceed the dollar limit which is set by law. Participants who attain age 50 before the end of the Plan year are eligible to make additional “catch-up” contributions to the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to contribute to the Plan. Automatically enrolled participants have their deferral rate set at 3 percent of eligible compensation and their contributions invested in a designated balance fund until changed by the participant. The Company may, at management’s discretion, contribute to the accounts of participants who have been credited with at least 1,000 hours of service in the Plan year and are employed on the last day of the Plan year. The Company made discretionary match contributions of \$257,072 and \$303,822 for the years ended December 31, 2024 and 2023, respectively.

**Participants’ accounts** – Each participant’s account is credited with the participant’s contribution, the Company’s contribution, if any, and allocations of Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting** – Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company’s contributions and actual earnings thereon is based on years of service, as follows:

## 1. DESCRIPTION OF PLAN (CONTINUED)

**Forfeitures** – Forfeiture accounts represent non-vested Company contributions forfeited by participants who terminate employment or withdraw from the Plan. Forfeitures are retained by the Plan and are used to reduce future Company contributions or pay administrative expenses. At December 31, 2024 and 2023, there were no forfeited nonvested accounts. No forfeitures were used to reduce Company contributions or pay administrative expenses in 2024 and 2023.

**Notes receivable from participants** – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Loan terms range from one to five years, except for the purchase of a primary residence, in which case the loan term may be extended up to 25 years. Loans are secured by the balance in the participant’s account and bear interest at rates equal to the prime rate plus 2 percent. Principal and interest are paid ratably through payroll deductions.

**Benefits** – Participants are entitled to a lump-sum amount or installment arrangement equal to their total vested account balance upon death, disability, retirement or termination of employment. Upon termination, if a participant’s vested account is less than \$5,000, the plan administrator will distribute the benefit to the participant as a rollover into an individual retirement account. Hardship withdrawals are permitted from participant’s elective deferral account. In-service withdrawals from the participant’s total vested account balance are permitted upon reaching age 59 ½.

**Administrative expenses** – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

**Termination** – Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to amend or terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of accounting** – The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (US GAAP).

**Use of estimates** – The preparation of financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

**Investment valuation and income recognition** – The Plan’s investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Committee determines the Plan’s valuation policies utilizing information provided by investment advisers and trustee. See Note 6 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

**Benefits paid to participants** – Benefits are recorded when paid.

**Notes receivable from participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as they are incurred. Delinquent participant loans are reclassified as distributions in accordance with the provisions of the Plan.

**Subsequent events** – The Plan has evaluated subsequent events through September 4, 2025, the date the financial statements were available to be issued.

## 3. TAX STATUS

On June 30, 2020, the Internal Revenue Service stated that the preapproved defined contribution plan document adopted by the Plan of January 1, 2023, as then designed, qualifies under Section 401(a) of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the Plan itself. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## 4. PARTY-IN-INTEREST

Alerus Financial N.A. acts as the custodian for a fee. Alerus Financial N.A. is the trustee for the Plan and, therefore, these transactions qualify as party-in-interest transactions. These transactions, however, are exempt from reporting as prohibited transactions under ERISA. Fees paid by the Plan for investment management services are included in net appreciation (depreciation) in fair value of investments.

## 5. INVESTMENT INFORMATION CERTIFIED BY THE PLAN’S TRUSTEE

Certain information related to investments and notes receivables from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivables from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, dividend income, and interest income on notes receivable from participants for the years then ended was obtained by management and agreed to or derived from information certified as complete and accurate by Alerus Financial N.A., (the trustee of the Plan).

## 6. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described below:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, quoted prices for identical or similar assets and liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2024.

*Mutual funds* – Valued at the daily closing price reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and the transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trusts (CCT)* – valued at the NAV of units of a bank collective trust. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

*Stable value fund* – valued at the NAV of units of the stable value fund. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions may occur daily.

## 7. COMPLIANCE MATTERS

During 2025, it was determined that several participants withdrawing from the Plan did not have the proper forfeiture amounts withheld from their accounts at the time of distribution. Thus, the distribution included both vested and unvested monies. The error results from the Plan's recordkeeper not updating the vesting schedule at the time that a discretionary match was added to the Plan, effective January 1, 2022. As a result, distributions of the Company's discretionary match were not adjusted for the years of service for each participant. The Plan is working with their recordkeeper to correct the matter. The error affected plan years 2022 through 2025 and the scope of the error is approximately \$85,000. While a final resolution is pending, the Plan is working with its recordkeeper to ensure improperly distributed unvested monies are returned to the Plan and that future participant withdrawal distributions are calculated correctly.

**8. RISK AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statement of net assets available for benefits.
