## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of the

### SCOPE AND NATURE OF THE ERISA SECTION 103(A)(3)(C) AUDIT

We performed audits of the accompanying financial statements of the St. John Properties, Inc.
